This page will assist us with identifying your fireplace as a RETROFIT CANDIDATE. This Retrofit Project only applies to some, but not all, MARCO CCT and MGC, sealed glass front, DIRECT VENT, GAS FIREPLACES, where the chimney vents through the wall.

You are NOT subject to this retrofit action if:

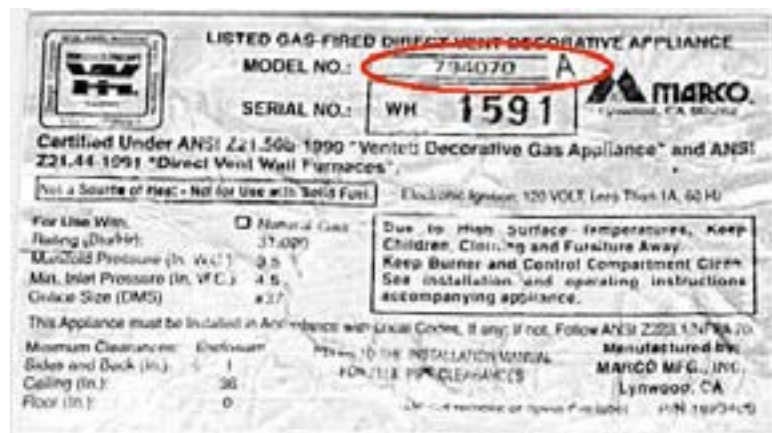
- 1. The chimney on your fireplace exits through the roof of your home.**
- 2. You have a wood burning fireplace with a GAS LOG SYSTEM or a GAS STARTER.**
- 3. Your Marco gas fireplace has no glass front, has operating glass doors or is part of the Galaxy product group.**

If you have any of the previously excluded fireplaces, you do not need to continue. Your fireplace is not part of the Marco Retrofit program.

If you feel your fireplace may be affected, please continue by clicking below.

If you have a direct-vent gas fireplace that you believe may require the retrofit, the following information will help confirm whether your gas fireplace is one of the installations requiring the retrofit.

The safety concern and retrofit only applies to specific models of Marco gas fireplaces. You will need to attain the specific model number on your fireplace. This information can be found on the silver 3" x 5" metal or foil identification plate that is located inside the lower grill or access panel at the right side bottom of the fireplace as you face the fireplace. The grill or panel is hinged at the bottom and can usually be opened with your fingertips. In some cases, it may be necessary to use a flat blade screwdriver or key to open and lower the panel.



The six-digit model number required starts with either a 794 or 797 as the first three numbers. It can be found near the top of the label and may require a flashlight to see the numbers. Please write down all six-digits of the model number including any letter following after the last number. This information is NECESSARY in order to properly identify your fireplace.

Based on your responses, your fireplace may be a candidate for our retrofit program. To further research your particular fireplace, you will need to identify the type of termination used.

Any Marco fireplaces which do NOT have a vent termination on an exterior wall are not included in this retrofit program.

Steps to follow to determine if your fireplace requires the retrofit:

1. The shape and characteristics of the vent termination will help determine if your fireplace installation is one of those to be retrofitted. The termination is painted black, but may have been painted the same color as the wall by your builder. Only the terminations shown in the following diagrams apply to this retrofit if there is a 4" diameter air intake. Compare your wall termination against the diagrams. If it looks like model B, look through the grill at either the left or right side to locate the 4" diameter air intake. All model A and some model Bs (without side grills) will require looking in through the lower grill to locate the 4" diameter air intake. The retrofit only applies to those with this air intake. If the termination does not have this 4" air intake as shown, your fireplace does not require the retrofit.
2. If your Marco fireplace installation has a termination on the exterior wall with horizontal slots along both side, your fireplace installation does not require this retrofit. Only terminations that look like the diagrams provided may require the retrofit.
