# **SAFETY**

Before beginning the installation of the fireplace, read these instructions through completely.

- This INNOVATIVE HEARTH PRODUCTS, LLC (IHP) fireplace and its components are safe when installed according to this installation manual. Unless you use IHP components, which have been designed and tested for the fireplace system, you may cause a fire hazard.
- The IHP warranty will be voided by and IHP disclaims any responsibility for the following actions.
  - a. Modification of the fireplace, components, doors, air inlet system and damper control.
  - b. Use of any component part not manufactured or approved by IHP in combination with an IHP fireplace system.

Proper installation is the most important step in ensuring safe and continuous operation of the fireplace. Consult the local building codes as to the particular requirements concerned with the installation of all factory built fireplaces.

MARNING: Do not install a fireplace insert in this box unless the manufacturer's instructions with the insert specifically state this fireplace has been tested for use with this insert.

#### **FOR YOUR SAFETY**

- Do not store or use gasoline or any other flammable vapors or liquids in the vicinity of this or any other appliance.
- Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.
- Do not place clothing or other flammable materials on or near the appliance.
- Never leave children unattended when a fire is burning in the fireplace.

MARNING: Use solid wood or processed solid fuel firelogs only. When processed wood fuel fire logs are used, do not poke or stir the logs while they are burning. Use only fire logs that have been evaluated for the application in fireplace and refer to fire log warnings and caution markings on packaging prior to use.

This fireplace is not intended to be used as a substitute for a furnace to heat an entire home. Use for supplemental heat only.

Overfiring of a fireplace is a condition where excessive temperatures are reached, beyond the design capabilities of the appliance. The damage that occurs from overfiring is not covered under the manufacturer's limited warranty.

MARNING: CONTINUED OVERFIRING CAN PER-MANENTLY DAMAGE YOUR FIREPLACE SYSTEM. SOME EXAMPLES OF CONDITIONS THAT COULD CAUSE OVERFIRING ARE:

- BURNING QUANTITIES OF SCRAP LUMBER, PINE BRANCHES, PAPER OR CARDBOARD BOXES WHICH EXCEED THE VOLUME OF THE NORMAL LOG FIRE.
- BURNING TRASH, CHEMICALS OR CHEMICALLY TREATED COMBUSTIBLES.

# **Disposal of Ashes**

Ashes should be placed in a metal container with a tight-fitting lid. The closed container of ashes should be placed on a noncombustible floor or on the ground, well away from all combustible materials, pending final disposal. If the ashes are disposed of by burial in soil or otherwise locally dispersed, they should be retained in the closed container until all cinders have thoroughly cooled.

WHEN USING THE DECORATIVE APPLIANCE, THE FIREPLACE DAMPER MUST BE SET IN THE FULLY OPEN POSITION.

Never use gasoline, gasoline-type lantern fuel, kerosene, charcoal lighter fluid, or similar liquids to start or 'freshen up' a fire in this fireplace. Keep all such liquids well away from the fireplace while it is in use.

Use SOLID WOOD only for fuel. It is best to use dry and well seasoned hardwood. Softwoods tend to burn very quickly. DO NOT use treated wood, charcoal, coal, trash, driftwood or woods that have been dipped in tar, pitch, pine tar, creosote, etc. Wood products made with synthetic binders, such as plywood, produce abnormally high temperatures and sputtering, smoking fires. When burning artificial logs, please read and follow the instructions provided by the manufacturer.

Never burn treated construction lumber or scraps. These woods burn excessively hot and may contain chemicals used to treat insects and fungus. When burned, these chemicals can pose a significant hazard.

WARNING: BURNING IMPROPER FUEL (I.E. CHARCOAL) CAN RESULT IN CARBON MONOXIDE POISONING. WHICH MAY LEAD TO DEATH!

Carbon Monoxide Poisoning – Early signs of carbon monoxide poisoning resemble the flu with headaches, dizziness, or nausea. If you have these signs, get fresh air at once! Have the appliance inspected by a qualified service technician. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

Ventilation Requirements - Provide adequate air for combustion. The fresh air requirements of this appliance must be met within the space where it will be installed.

Smoke Detectors - Since there are always several potential sources of fire in any home, we recommend installing smoke detectors. If possible, install the smoke detector in a hallway adjacent to the room (to reduce the possibility of occasional false activation from the heat produced by the appliance). If your local code requires a smoke detector be installed within the same room, you must follow the requirements of your local code. Check with your local building department for requirements in your area.

# Creosote – Formation and Need for Removal

When wood is burned slowly, it produces tar and other organic vapors, which combine with expelled moisture to form creosote. The creosote vapors condense in the relatively cool chimney flue of a slow-burning fire. As a result, creosote residue accumulates on the flue lining. When ignited this creosote makes an extremely hot fire.

The chimney shall be inspected at least twice a year during the heating season to determine when a creosote buildup has occurred. When creosote has accumulated (1/8" [3 mm] or more) it shall be removed to reduce the risk of a chimney fire.

▲ WARNING: Children and adults should be alerted to the hazards of high surface temperatures and to stay away to avoid burns or clothing ignition. Young children should be carefully supervised when in the same room as fireplace.




Figure 1 - 42" Model Oracle Cat 42




Figure 2 - 50" Model Oracle Cat 50

# FIREPLACE INSTALLATION

#### SELECTING LOCATION

To determine the safest and most efficient location for the fireplace, you must take into consideration the following guidelines:




Figure 3 - Framing Dimensions




Figure 4 - Corner Installation

- 1. The location must allow for proper clearances (see Figures 3 and 4).
- 2. Consider a location where fireplace will not be affected by drafts, air conditioning ducts, windows or doors.
- 3. A location that avoids cutting of joists or roof rafters will make installation easier.
- 4. An outside air kit is available with this fireplace (see Optional Outside Air Kit on page 8).

#### MINIMUM CLEARANCE TO COMBUSTIBLES

MARNING: Do not pack required air spaces with insulation or other materials.

#### Minimum/Maximum Chimney Height for Residential Installation

Minimum height of chimney, measured from base of fireplace to flue gas outlet of termination, is 16 feet for straight flue or a flue with one elbow set. Maximum distance between elbows is 6 feet. For systems with two elbow sets, minimum height is 22 feet. Maximum height of any system is 50 feet. This measurement includes fireplace, chimney sections and height of termination assembly at level of the flue gas outlet (see Figure 14, page 10).

# Minimum/Maximum Chimney Height for Outdoor Installation

Minimum height of chimney, measured from base of fireplace to flue gas outlet of termination, is 9.5 feet (minimum of 4 feet of chimney pipe sections required for outdoor installation).

#### **FRAMING**

- 1. Frame opening for fireplace using dimensions shown in Figures 3 and 4.
- 2. If fireplace is to be installed directly on carpeting, tile or any combustible material other than wood flooring, fireplace must be installed upon a metal or wood panel extending full width and depth of fireplace.
- 3. Set fireplace directly in front of this opening and slide unit back until nailing flanges touch side framing.
- 4. Check level of the fireplace and shim with sheet metal if necessary.
- 5. Before securing fireplace to prepared framing, ember protector (provided) must be placed between hearth extension (not supplied) and under bottom front edge of fireplace to protect against glowing embers falling through. If fireplace is to be installed on a

raised platform, a Z-type ember protector (not supplied) must be fabricated to fit your required platform height. Ember protector should extend under fireplace a minimum of 1  $^{1}/_{2}$ ". Ember protector should be made of galvanized sheet metal (28 gauge minimum to prevent corrosion.

6. Using screws or nails, secure fireplace to framing through flanges located on sides of fireplace.

**Note:** For outdoor installations, fireplace enclosure must allow for adequate drainage and fresh air ventilation. It is recommended that a sealed, corrosion resistant catch pan with provision for drainage be installed under fireplace within fireplace enclosure.

## **FIREPLACE INSTALLATION Continued**

#### **HEARTH EXTENSION**

A hearth extension projecting a minimum of 20" in front of and a minimum of 12" beyond each side of fireplace opening is required to protect combustible floor construction in front of fireplace. Fabricate a hearth extension using a material which meets the following specifications: a layer of noncombustible, inorganic material having a thermal conductivity of k=0.84 BTU IN/FT, HR. F (or less) at 1" thick. For example, if the material selected has a k factor of 0.25, such as glass fiber, the following formula would apply:

 $0.25 \times 1.0$ " = 0.30" thickness required 0.84




Figure 5 - Hearth Extension

Thermal conductivity "k" of materials can be obtained from manufacturer or supplier of noncombustible material. If hearth extension is to be covered, use noncombustible material such as tile, slate, brick, concrete, metal, glass, marble, stone, etc. Provide a means to prevent hearth extension from shifting and seal gap between fireplace frame and hearth extension with a noncombustible material (see Figure 5).

A WARNING: Hearth extension is to be installed only as shown in Figure 5.

#### **MANTELS**




Figure 6 - Mantel Clearances to Combustible Material

A mantel may be installed if desired (see Figure 6). Woodwork such as wood trims, mantels or any other combustible material projecting from front face must not be placed within 18" of fireplace opening. Combustible materials above 18" and projecting more than 1 ½" from fireplace must not be placed less than 21" from the top opening of the fireplace (NFPA 211, Section - Clearance from Combustible Material). Mantels or any other combustible material also may come up to side edge of black metal face of fireplace as long as projections from front face fall within limit shown in Figure 6.

#### **VENTING INSTALLATION**

#### OPTIONAL OUTSIDE AIR KIT (MODEL AK4/AK4F)

The installation of an outside air kit should be performed during the rough framing of the fireplace due to the nature of it's location. Outside combustion air is accessed through a vented crawl space (AK4F) or through a sidewall (AK4).

**A** CAUTION: Combustion air inlet ducts shall not terminate in attic space.

The maximum height for the air vent can not exceed 3 feet below the flue gas outlet of the termination.




Figure 7- Outside Air Kit

#### **CHIMNEY PIPE**

WARNING: Label part number 900599-01 must be applied by the installer to all chimney pipe sections but is not required on sections that will be visible after the installation is complete. Label must wrap around the circumference of the pipe. See accessories, page 24 for Kit F2659.




Figure 8- Lineal Gain

The IHP chimney system consists of 12", 18", 24", 36" and 48" snap-lock, double-wall pipe segments, planned for maximum adaptability to individual site requirements. Actual lengths gained after fitting overlaps must be taken into consideration (lineal gain) and are given in the lineal gain chart (see Figure 8). Lineal Gain is the actual measurable length of a part after two or more parts are connected. For Canada, use chimney parts designated "HT".

WARNING: The opening in the collar around the chimney at the top of the fireplace must not be obstructed. Never use blown insulation to fill the chimney enclosure.

# ASSEMBLY AND INSTALLATION OF DOUBLE WALL CHIMNEY SYSTEM

Each double wall chimney section consists of a galvanized outer pipe, a stainless steel inner flue pipe and a wire spacer. The pipe sections must be assembled independently as the chimney is installed. When connecting chimney directly to the fireplace, the inner flue pipe section must be installed first with the lanced side up. The outer pipe section can then be installed over 5 the flue pipe section with the hemmed end up. Press down on each pipe section until the lances securely engage the hem on the fireplace starter. The wire will assure the proper spacing between the inner and outer pipe sections.




Figure 9 - Elbow Offset

Continue to assemble chimney sections as outlined above, making sure that both the inner and outer pipe sections are locked together. When installing double wall snap-lock chimney together, it is important to assure the joint between the chimney sections is locked. Check by pulling chimney upward after locking. The chimney will not come apart if properly locked. It is not necessary to add screws to keep the chimney together (exception, see Figure 9, page 9).

The height of a vertical chimney pipe supported **ONLY** by the fireplace, must not exceed 20 feet. Chimney heights above 20 feet must be supported.

# **OFFSET CHART (22-50 FT. SYSTEM HEIGHT)**

# **USING ELBOW OFFSETS (30E-12DM)**

- 1. To achieve desired offset, you may install combinations of 12", 18", 24", 36" and 48" length of double wall pipe (see offset chart and Figure 9).




Figure 10 - Ceiling Support Pipe 12S-12DM

- 2. Chimney weight above offset rests on return elbow. Straps must be securely nailed to rafters or joists (see Figure 10, details A and B).




Figure 11 - Typical Offset Terminations

- 3. Maximum length of pipe between supports (return elbow or 12S-12DM) is 6' of angle run. Maximum of two 6' angle run sections per chimney system (see Figure 11, page 10).
- 4. All pipe connections between the offset and return must be secured with two screws on the outer pipe only (see Figure 10). Do not penetrate the inner stainless.

## **FIRESTOP SPACERS (FS-10)**




Figure 12 - Firestop Spacer with Living Space Above Ceiling




Figure 13 - Firestop Spacer with Attic Space Above Ceiling

Firestop spacers are required at each point where the chimney penetrates a floor space. Their purpose is to establish and maintain the required clearance between the chimney and the combustible materials. When the pipe passes through a framed opening into a living space above, the firestop must be placed onto the ceiling from below as shown in Figure 12. They also provide complete separation from one floor space to another or attic space as required by most codes. When the double wall pipe passes through a framed opening into an attic space, the firestop must be placed into an attic floor as shown in Figure 13.

# **IMPORTANT NOTICE**

When penetrating a ceiling into an attic, a firestop thimble (FST10) is required to avoid intrusion by insulation and recommended to negotiate a joist.





Figure 13a - Firestop Thimble

#### PENETRATING ROOF

To maintain a 2" clearance to the pipe on a roof with a pitch, a rectangular opening must be cut.

- 1. Determine center point through which pipe will penetrate roof.
- 2. Determine center point of roof. Pitch is distance the roof drops over a given span, usually 12". A 6/12 pitch means that roof drops 6" for each 12" measured horizontally down from roof rafters.
- 3. Use roof opening chart (Figure 14) to determine correct opening length and flashing required.
- 4. Remove shingles around opening measured. Cut out this section.
- 5. Add next sections of pipe until end penetrates roof line. Check to see that proper clearances are maintained. Extend chimney by adding sections of double wall pipe until pipe is minimum of 30" above highest point of roof cutout. Termination and chimney must extend a minimum of 36" above highest point where it passes through roof.

#### FLASHING INSTALLATION (V6F-10DM OR V12F-10DM)




Figure 15 - Flashing Installation

Determine the flashing to be used with the roof opening chart. Slide flashing over pipe until base is flat against roof. Replace as many shingles as needed to cover exposed area and flashing base. Secure in position by nailing through shingles (see Figure 15). DO NOT NAIL THROUGH FLASHING CONE.

#### **Installing Flashing on a Metal Roof**

When installing the flashing on a metal roof, it is required that putty tape be used between the flashing and the roof. The flashing must be secured to the roof using  $\#8 \times 3/4$ " screws and then sealed with roof coating to prevent leakage through the screw holes. A roof coating must also be applied around the perimeter of the flashing to provide a proper seal.

#### Storm Collar Installation (SC2-1)




Figure 16 - Storm Collar

Place storm collar over pipe and slide down until it is snug against the open edge of the flashing (see Figure 16). Apply waterproof caulk around the perimeter of the collar to provide a proper seal.

#### **Terminations/Spark Arrestor**

The fireplace system must be terminated with the listed round top or chase terminations. In any case, refer to the installation instructions supplied with the termination.

A CAUTION: Do not seal openings on the rooftop flashing. Follow the installation instructions provided with the termination being used.




Figure 17 - Termination

#### **CHASE INSTALLATIONS**




Figure 18 - Multiple Chase Installation

Instructions for chase installations are included with the chase style termination chosen. In a multiple chase installation, be sure to provide adequate distance between terminations to prevent smoke spillage from one termination to another. We suggest that terminations be separated at least 24", center to center and stacked at a vertical height difference of 18" (see Figure 18).

Note: If a decorative shroud is to be installed, contact the manufacturer for specifications.

#### 10 FOOT RULE




Figure 19 - 10 Foot Rule

All flue gas outlet chimney terminations must extend a minimum of 3 feet in height above the highest point where it passes through the roof and must be at least 2 feet above the highest point of the roof that is within a horizontal distance of 10 feet (see Figure 19).

#### FINISHING FIREPLACE

Combustible materials, such as wallboard, sheet rock, drywall, plywood, etc. may make direct contact with sides and top around the fireplace face. It is important that combustible materials do not overlap the face itself. Brick, glass, tile or other noncombustible materials may overlap the front face provided they do not obstruct essential openings like louvered slots or any other opening. When overlapping with a noncombustible facing material, use only noncombustible mortar or adhesive.

#### MOSAIC MASONRY BRICK PANELS AND ESTATE REFRACTORY PANELS INSTALLATION



**NOTE:** A Mosaic Masonry or Estate liner is required for use with your Oracle Cat 42, or Oracle Cat 50 Firebox. (Not supplied, see page 22 for models available).

#### MOSAIC MASONRY BRICK INSTALLATION

IMPORTANT: Installation of brick panels should be done after the fireplace is placed in a permanent location.

**Note:** Remove grate, screen assemblies and all hardware components out of the box prior to installation.

#### INSTALLATION




Figure 20 - Installing Hearth and Leading Brick panels

- Install bottom brick panel. Using at least two people, hold bottom brick panel by its side edges. Place the back edge of bottom panel into the firebox first and carefully lower the front edge of panel. Make sure bottom panel is centered in the firebox and flush with the front of the fireplace. Be careful not to pinch your fingers between the panel and firebox (Figure 20).
- 2. Install the left and right side leading bricks (Figure 20).




Figure 21 - Slots for Firebrick Walls

3. Install the left and right firebrick walls. There is a bracket with 2 tabs on the bottom of each firebrick wall. Angle the wall into the fireplace opening and into the slots on the side of the hearth (Figure 21), then tilt the top of the panel toward the firebox surround.




Figure 22 - Installing Side Walls

4. Secure the firebrick wall using 2 of the retainers provided. The bracket will slip underneath the metal lip on the top of the wall and screw into the inner dome of the fireplace (Figure 22).




Figure 23 - Installing Rear Wall

- 5. Install the rear firebrick wall last. Place the wall face side down on the hearth with the bottom of the wall toward the rear of the firebox and the top toward the front of the fireplace. Tilt the wall up toward the back of the firebox. Secure with 2 rear retaining brackets provided (Figure 23, page 14).
- 6. It is recommended that the joints between all firebrick walls be grouted for a more finished look, see grouting instructions. For more information and to watch a how to video go to **Astria.US.com** and select Technical Support.

#### **GROUTING INSTRUCTIONS**

## Note: Grouting material provided with mosaic brick kit

- Moisten brick surface with damp sponge or spray bottle just prior to application. When bricks are wet, any excess grout mixture on bricks will easily wipe off.
- 2. In a heavy duty mixing bucket, add equal parts cement and sand. Add enough water and mix together well using a power drill with mixing wand attachment to a yogurt like consistency. Not adding enough water can lead to grout falling out after burning.
- 3. The overall length of piping bag should be about 16". If the bag is longer than 16", cut it down to size by removing end with larger opening. This will make the bag easier to handle.
- 4. Put grout mixture into piping bag making sure the smaller opening is downward and over a moist towel to avoid spilling. Place a wet towel over the bucket making sure it is directly on the surface of grout mixture. This will keep the mixture moist and it will not dry out before use.
- 5. Grout all joints where two firebrick walls come together.
- 6. Using a trowel, remove excess grout mixture by moving trowel in the direction of the joint. Grout mixture in the joint should now be flush with brick surface. If not enough grout is applied into each space, grout may fall out after burning.
- 7. Using a joint striker, smooth out grout line. Allow 72 hours before operating fireplace.

#### **INSTALLING SCREEN**

- 1. Slide round end of screen rod into rings at top of screen. Attach one push-on nut to end of rod before attaching last ring of screen.




Figure 24 - Installing Fireplace Screen

- 2. Insert the round end screen rod into hole on the left and right side of smoke shelf (Figure 24).
- Mount flat end of screen rod with #10 x 5/8" to center of smoke shelf
- Install other screen rod in same manner.

#### **INSTALLING GRATE RETAINERS**




Figure 25 - Installing Grate Retainers

- Place the provided grate retainers on the hearth as shown in Figure 25. The back of the retainer will be flush with the rear firebrick wall. Mark the center of the hole on the hearth with a marker.
- 2. Drill two holes in the hearth in the marked locations using a masonry 3/16" drill bit.
- 3. Secure grate retainer with masonry screws provided.

MARNING: Risk of fire! Replace grate with IHP approved grate only. The grate has been designed to keep the operation of your fireplace safe and efficient.

#### **ESTATE REFRACTORY PANELS INSTALLATION**

**Note:** Remove grate, screen assemblies and all hardware components out of the box prior to installation.

- Install bottom brick panel. Using at least two people, hold bottom brick panel by its side edges. Place the back edge of bottom panel into the firebox first and carefully lower the front edge of panel. Make sure bottom panel is centered in the firebox and flush with the front of the fireplace. Be careful not to pinch your fingers between the panel and firebox.
- Position "Z" shape retaining brackets on top of the notched area toward the rear of the bottom brick panel. Grate retaining bracket should be positioned as shown in Figure 25, page 14.
- Install rear brick panel. This panel has a top and bottom side.
   To determine correct position, match up the pattern on the rear panel with the right and left brick panels before installing. Make sure rear panel is centered before continuing.
- 4. Install the right and left brick panels with the gas line knock outs placed down toward the bottom refractory. Align the right an left brick panels with the rear panel so the grout lines line up.




Figure 26- Installing Refractory Panels

- 5. Install upper corner brackets and tighten set screws (see Figure 26).
- 6. Install grate by placing rear legs into slots in the grate retainer (see Figure 26)

#### **OPTIONAL GAS LINE INSTALLATION**

Gas line hook up should be done by your supplier or a qualified service person.

**Note:** Before you proceed, make sure your gas supply is turned off. Use only a 1/2" black iron pipe and appropriate fittings.




Figure 27 - Gas Line Access

- Remove knockout indentation on refractory or firebrick wall located above refractory hearth floor. Knockout indentation must be firmly tapped with any solid object such as a 1/2" dowel until it is released. Remove fragmented portions of refractory (see Figure 27).
- 2. Remove gas line cover plate located on either side of fireplace and pull out insulation from gas line conduit sleeve. Save insulation for reuse. Replace screws.




Figure 28 - Gas Line Installation

- 3. Run a 1/2" black iron gas line into fireplace through the rear at gas line conduit sleeve (if using a raised platform, add height). Provide sufficient gas line into fireplace chamber for fitting connection (see Figure 28, page 16).

**Note:** Secure incoming gas line to wood framing to provide rigidity for threaded end.

4. Repack insulation around gas line and into sleeve opening. Seal any gaps between gas line and refractory knockout hole with refractory cement or commercial furnace cement, Install the gas appliance or cap-off gas line if desired.

CAUTION: All gas piping and connections must be tested for leaks after the installation is completed. After ensuring that the gas valve is on, apply soap and water solution to all connections and joints. Bubbles forming show a leak. Correct all leaks at once. DO NOT USE AN OPEN FLAME FOR LEAK TESTING AND DO NOT OPERATE ANY APPLIANCE IF A LEAK IS DETECTED. LEAK TESTING SHOULD BE DONE BY A QUALIFIED SERVICE PERSON.

**WARNING:** Do not operate an unvented gas log set in this fireplace with the chimney removed.

A gas line or gas log lighter may be installed for the purpose of installing a vented or vent-free decorative gas appliance incorporating an automatic shutoff device and complying with the Standard for Decorative Gas Appliances for Installation in Vented Fireplaces, ANSI Z21.60 or American Gas Association draft requirements for Gas Fired Log Lighters for Wood Burning Fireplaces, Draft NO. 4 dated August, 1993.

If you install a decorative gas appliance (vented gas log), the decorative gas appliance must comply with the Standard for Decorative Gas Appliance for Installation in Solid Fuel Burning Fireplaces, ANS Z21.60 or Z21.84 and shall also be installed in accordance with the National Fuel Gas Code, ANSI 7223NFPA 54 latest edition.

If you wish to install an unvented (vent-free) gas log set, only unvented gas log sets which have been found to comply with the standard for unvented room heaters, ANSI Z21.11.2 are to be installed in this fireplace.

WARNING: If the fireplace has been used for wood burning, the firebox and chimney must be cleaned of soot, creosote and ashes be a qualified chimney cleaner. Creosote will ignite if heavily heated.

▲ WARNING: When using a decorative vented gas log, the damper must be removed or permanently locked in the fully open position and the glass doors must be in the fully open position.

# **PUREFIRE HOOD INSTALLATION**

- The PureFire hood supplied with this fireplace is packaged in a separate box and placed in the firebox during shipping.
- 2. Remove hood from box. Locate brackets (quantity 2) and screws (quantity 4) for hood installation in the hardware bag.




Figure 29 - Installing PureFire Hood

- 3. Using screws provided, secure the bracket to the inner dome of the fireplace as shown in Figure 29. The left and right bracket are different. The edge that is straight will be closer to the fireplace opening
- 4. Lift hood up into the fireplace and place it on the retaining brackets (Figure 29). The rear of the hood will touching the rear of the fireplace.

### **INSTALLING AIR DEFLECTORS (42" MODELS ONLY)**

Slide air deflector in between the front side face and side brick panel (see Figure 31, page 17). The notched end of the deflector sits on bottom hearth. Air deflector does not require any fastening.

The front side faces and side brick panels will hold the deflector in place (see Figure 31, page 17).

#### **DOOR FRAME MODELS**

#### BDMO42E/G/C AND BDMO50E/G/C

#### Installation




Figure 30 - Installing Top Door Frame

- 1. Remove screws from smoke shelf (see Figure 30).
- 2. Mount top door frame and secure with screws provided (see Figure 30).




Figure 31 - Installing Bottom Door Frame and Air Deflector

- 3. Place bottom door frame on top of ash lip at front of fireplace (see Figure 31, page 17).
- 4. Secure bottom door frame to brick with two hex screws provided as shown in Figure 31, page 17 using a 7/16" open end or adjustable wrench.

WARNING: Discontinue use of the appliance immediately if doors are damaged and contact a qualified installer for repair. Only doors certified with the appliance shall be used.

<u>WARNING: Do not slam or strike doors. Damage</u> can result in a hazardous condition.

#### **INSTALLING GLASS DOORS**

Spring clips have been installed but some adjustments may be needed. Install the doors using the following steps:

- With bifold doors completely folded, insert bottom pivot pin into pivot hole located near bottom corner of front face opening and swing door to vertical position making sure top pins slide into door track. Door is installed when top door pin snaps into spring clip.
- 2. Repeat step 1 for remaining door.

If you find the doors do not close properly or do not appear level or straight, proceed with section on door adjustment,




Figure 32 - Installing Bi-Fold Doors

#### **DOOR ADJUSTMENT**




Figure 33 - Adjusting Bi-Fold Doors

Remove doors and slightly loosen lower pivot clips and upper spring clips. Replace doors and fully close them. Use 1/8" shims (any material) to level doors. Once proper setting is achieved, carefully open doors enough so that you can access spring clips with a phillips screwdriver. Tighten screws. See Figure 33.

#### **OPERATION AND MAINTENANCE GUIDELINES**

#### **GLASS DOORS**




Figure 34 - Bi-Fold Glass Doors

Glass doors are optional with the fireplace. When fireplace is in operation, doors must be fully opened or fully closed position only or a fire hazard may be created (see Figure 34).

A fireplace equipped with glass doors operates much differently than a fireplace with an open front. A fireplace with glass doors has a limited amount of air for combustion.

Excessive heat within the fireplace can result if too large a fire is built or if combustion air gate is not completely open. The following tips should be followed to assure that both the fireplace and glass door retain their beauty and function properly. Both the flue damper and glass doors must be fully opened before starting fire. This will provide sufficient combustion air and maintain safe temperatures in firebox.

**IMPORTANT:** The glass must be allowed to warm slowly and evenly. The tempered glass will withstand a gradual temperature rise to 550° F, which is more than a normal fire will generate. Such materials as pitch/wax laden logs, very dry mill end lumber and large amounts of paper or cardboard boxes can create an excessively hot fire and should not be burned in this fireplace. Always keep the fire well back from the doors and never allow flames to contact the glass.

WARNING: Fireplaces equipped with glass doors should be operated only with doors fully opened or doors fully closed. Doors, if left partly open, may draw gas and flame out of the fireplace opening creating risks of both fire and smoke.

# OPERATION AND MAINTENANCE GUIDELINES Continued

#### **Cleaning Glass**

Clean glass with any commercial glass cleaner or soap and water. Do not use any abrasive material to clean glass. Do not clean glass with any cool water if glass is still hot from the fire and smoke.

#### **OUTSIDE AIR AND DAMPER HANDLE OPERATION**




Figure 35 - Operating Damper Handle

The damper handle, which opens and closes the damper blade, is located in the upper front face of the fireplace. Pushing the handle forward and up through the keyway slot will free damper blade to automatically open. Pushing the handle forward and down will lock damper blade closed (see Figure 35). Damper must be locked in the full open position before operating fireplace (see Figure 35).

#### **PUREFIRE EMISSION CONTROL SYSTEM**

This fireplace is equipped with a PureFire Emission Control System. The Catalytic Hood system reduces particulates emissions in a wood burning fireplace to meet the EPA Wood-Burning Fireplace Program Phase 2 emission level.

The EPA qualifying label, shown on page 19, will be affixed to the catalyst. Before lighting the first fire, remove and maintain this label in a safe place if needed for permits or building inspection. Prior to beginning installation, contact your local building official to determine the need to obtain a permit. For proper operation, catalyst must be replace every 3 to 5 years.

#### **FUELING GUIDELINES**

The fireplace grate must always be secured to the retaining brackets provided. The position of the grate must be centered against the back wall of the firebox.

Burn only dry, seasoned (cured) wood with less than 20% moisture. Avoid the use of treated, painted and laminated wood. Never burn garbage or other foreign materials. Do not use artificial logs, colored newspaper or petroleum based fire starters. Avoid wood with high salt content. All of these materials may contain compounds which can shorten the life of the catalyst. Wet or unseasoned wood may lower catalytic temperatures and result in inefficient operation.

The catalyst is designed to function at optimum efficiency when the fireplace is burning clean, dry, cord wood as fireplace fuel. A simple visual inspection of the chimney during the wood burning process will determine catalyst performance.

The fuel load should always be placed on the back of the grate. Use clean dry wood, seasoned cord wood is the best choice. Never burn trash, plastics, gasoline, rubber, industrial solvents, flammable liquids, naptha, household garbage, material treated with petroleum products, leaves, paper products, cardboard or salt driftwood.

Refer to your INNOVATIVE HEARTH PRODUCTS (IHP) Homeowner's Guide included with your fireplace for proper fire building technique and ash removal procedures. These fueling guidelines must be followed in order to achieve maximum emissions performance from the PureFire System.

#### **OPERATION**

The proper use of a wood burning fireplace equipped with the catalyst will significantly reduce the emissions that it produces. Simple fuel considerations with regard to moisture content, size, and quality of fuel will help control the production of wood smoke and improve the performance of the catalyst and fireplace efficiency. With proper care, the catalyst will provide years of fuel savings and lowered emissions. By following some simple guidelines, you will ensure maximum performance and longevity.

The smoke that is usually seen coming out of a chimney is essentially a combination of unburned fuel (carbon and hydrogen) and moisture in the form of water vapor. The catalyst is a technology that provides secondary combustion for the wood burning process.

#### MAINTENANCE

The PureFire System is a maintenance free technology. Do not attempt to remove or clean the combustor. The direct flame from the fire will clean the combustor. Only a certified technician should remove the unit. To ensure proper fireplace operation, the PureFire System should be replaced every 3 to 5 years (see <a href="Parts">Parts</a> on page 20).

#### PUREFIRE EMISSION CONTROL SYSTEM Continued

**NOTE:** Chimney smoke may be visible during the first 8 to 10 minutes of fireplace operation when the fire is first getting started and the final 8 to 10 minutes of operation while the fire is dissipating. Under normal operating conditions, you should see little or no smoke coming out of the chimney. If continuous smoke is visible, make sure only dry seasoned wood is being burned. If visible smoke continues, the combustor has ceased to function or there is thermal crumbling. Call your IHP distributor or dealer for replacement parts.





#### WARRANTY

INNOVATIVE HEARTH PRODUCTS (IHP) warranty obligations for the PureFire Emissions Control System are limited to the terms set forth below.

IHP warrants to the consumer who purchases a new solid fuel burning fireplace containing a PureFire Emissions Control System as a new component, to replace the catalyst at no charge should it cease to function within three years from the date of purchase. The PureFire Catalytic Component is designed to perform efficiently for three years of fireplace operation. ONLY recommended fuels should be burned. Follow the fueling directions in manufacturers operation manual. For warranty purposes, proof of fireplace purchases is required. Labor for removal and/or installation of the catalytic component is not the responsibility of the manufacturer.

Neither IHP nor the dealer who sells the PureFire Emissions Control System is responsible for indirect, incidental, special, punitive or consequential damages arising out of the improper use of this product or the continued use of this product beyond the required replacement period.







#### THE WARRANTY

Innovative Hearth Products ("IHP") Limited Lifetime Warranty warrants your Astria® Brand EPA Wood Burning Fireplace ("Product") to be free from defects in materials and workmanship at the time of manufacture. The Product body, firebox and ceramic glass carry the Limited Lifetime Warranty. Ceramic glass carries the Limited Lifetime Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the Limited Lifetime Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this Limited Lifetime Warranty as described herein.

#### **COVERAGE COMMENCEMENT DATE**

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

#### **EXCLUSIONS AND LIMITATIONS**

This Limited Lifetime Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The Product body and firebox carry the Limited Lifetime Warranty from the date of installation. Vent components, trim components and paint are excluded from this Limited Lifetime Warranty. The following do not carry a Limited Lifetime Warranty but are warranted as follows:

Cast Iron Heat Exchanger – Replacement for five years from the date of installation

Cast iron parts - Replacement for one year from the date of installation

Catalyst - Carries a separate warranty. Refer to the warranty certificate provided for that part

Electrical components - Repair or replacement for one year from date of installation

Gaskets - Replacement for one year from the date of installation.

Gold & nickel plating - Replacement for two years from date of installation. Excludes tarnishing

Refractory & screens - Replacement for two years from date of installation. Excludes hairline cracks

Removable air tubes - Repair or replacement for seven years from date of installation. IHP prevailing labor rates for years one through five.

Labor coverage - Prevailing IHP labor rates apply for the warranty period of the component, unless otherwise noted

Parts not otherwise listed carry a 90 day warranty from the date of installation.

Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance. (The Product must be subject to normal use with approved fuels listed in the Operation Manual provided with the product. Fuel products with abnormal burning characteristics, including but not limited to fuel such as driftwood, coal or plywood and wood products using a binder may burn at excessive temperatures and may cause damage to the Product or may cause it to function improperly; IHP stoves, inserts and high efficiency EPA fireplaces are approved for burning dry seasoned wood only.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

Coverage of this Limited Lifetime Warranty is conditional upon the appliance being operated without the use of grates, irons or any other method to elevate the fire.

IHP is not responsible for inadequate system draft caused by air conditioning and heating systems, mechanical ventilation systems, or general construction conditions which may generate negative air pressure in the room in which the appliance is installed. Additionally IHP assumes no responsibility for smoking conditions caused by inadequate chimney height, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions. Certain IHP Products are listed for use with Security Chimneys International, Ltd. chimney systems only. Use of chimney components other than that specified in the Product manual will void the Product warranty.

This Limited Lifetime Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this Limited Lifetime Warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. The provisions of this Limited Lifetime Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

#### INVESTIGATION OF CLAIMS AGAINST WARRANTY

IHP reserves the right to investigate any and all claims against this Limited Lifetime Warranty and to decide, in its sole discretion, upon the method of settlement.

To receive the benefits and advantages described in this Limited Lifetime Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.

Contact IHP at the address provided herein to obtain a listing of approved dealers/distributors. IHP shall in no event be responsible for any warranty work done by a contractor that is not approved without first obtaining IHP's prior written consent.

#### HOW TO REGISTER A CLAIM AGAINST WARRANTY

In order for any claim under this warranty to be valid, you must contact the IHP dealer/distributor from which you purchased the product. If you cannot locate the dealer/distributor, then you must notify IHP in writing. IHP must be notified of the claimed defect in writing within 90 days of the date of failure.
