

INTRODUCTION

The **Montebello® Series** direct-vent, sealed-combustion gas fireplaces operate on natural or propane gas. These appliances feature a remotely controlled electronic intermittent pilot ignition system (manual adjustment of the gas valve settings is not possible).

The Montebello Series is a decorative fireplace and may not be installed and operated as the primary heat source in a dwelling.

Electrical power (120 VAC line voltage) is recommended to operate the fireplace; however, four (4) "AA" batteries can be used for full-time operation or as a backup in case of a power outage.

Approved Vent Components

These fireplaces are designed, tested, and listed for operation and installation with **8" DV Lock** direct vent system components (8" inner, 11" outer) by Innovative Hearth Products.

These approved vent system components are labeled for identification. *USE ONLY AP-PROVED VENT COMPONENTS. Do NOT use any other manufacturer's vent components with these appliances.*

Codes and Standards

These appliances comply with National Safety Standards and are tested and listed by PFS TECO (Report No. F14-106) to ANSI Z21.50:19 (in Canada, CSA-2.22:19) as vented gas fireplaces.

These appliances are listed by PFS TECO for installation in bedrooms and mobile homes.

Installation must conform to local codes. In the absence of local codes, installation must comply with the current National Fuel Gas Code, ANSI Z223.1 (in Canada, the current CAN/CGA-B149.1 installation code).

The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70 (latest edition) or the Canadian Electrical Code, CSA C22.1 (latest edition).

Test gauge connections are provided on the front of the gas control valve (identified IN for the inlet and OUT for the manifold side).

Propane tanks are at pressures that will cause damage to valve components. Verify that the tanks have step-down regulators to reduce the pressure to safe levels.

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures **in excess of** 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures equal to or less than 1/2 psi (3.5 kPa).

Orifice Sizes—Sea Level To High Altitude (All Models)

These appliances are tested and approved for installation at elevations of 0–4500 feet (0–1372 meters) above sea level, using the standard burner orifice sizes (marked with an asterisk (*) in *Table 4*). For elevations above 4500 feet, contact your gas supplier or qualified service technician.

Deration—At higher elevations, the amount of BTU fuel value delivered must be reduced by either:

- using gas that has been derated by the gas company; or
- changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1—latest edition or, in Canada, the CAN/CGA-B149.1 codes—latest edition.

Install the appliance according to the regulations of the local authorities having jurisdiction and, in the USA, the National Fuel Gas Code NFPA 54/ANSI Z223.1—latest edition or , in Canada, the CAN/CGA-B149.1- latest edition.

NOTE: Flame appearance will diminish 4% per thousand feet of altitude.



COMMONWEALTH OF MASSACHUSETTS REQUIREMENTS

These appliances are approved for installation in the US state of Massachusetts if the following additional requirements are met:

- Install this appliance in accordance with Massachusetts Rules and Regulations 248 C.M.R. Sections 4.00 through 8.00.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36 inches (92 centimeters) in length.
- The individual manual shut-off must be a T-handle type valve.

Massachusetts Horizontal Vent Requirements In the Commonwealth of Massachusetts, horizontal terminations installed less than seven (7) feet above the finished grade must comply with the following additional requirements:

- A hard wired carbon monoxide detector with an alarm and battery back-up must be installed on the floor level where the gas fireplace is installed. The carbon monoxide detector must comply with NFPA 720, be ANSI/UL 2034 listed and be ISA certified.
- A metal or plastic identification plate must be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade and be directly in line with the horizontal termination. The sign must read, in print size no less than one-half (1/2) inch in size, GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS.

COLD CLIMATE INSULATION


For cold climate installations, seal all cracks around your appliance with noncombustible material and wherever cold air could enter the room. It is especially important to insulate outside chase cavity between studs and under floor on which appliance rests, if floor is above ground level. Gas line holes and other openings should be caulked or stuffed with unfaced fiberglass insulation.

If the fireplace is being installed on a cement slab in cold climates, a sheet of plywood or other raised platform can be placed underneath to prevent cold transfer to the fireplace and into the room. It also helps to sheetrock inside surfaces and tape for maximum air tightness and caulk firestops.

MANUFACTURED HOME REQUIREMENTS

This appliance may be installed in an aftermarket permanently located, manufactured home and must be installed in accordance with the manufacturer's instructions.

CAUTION: This appliance must be grounded to the chassis of the manufactured home in accordance with local codes or in the absence of local codes, with the National Electrical Code ANSI/NFPA 70—latest edition or the Canadian Electrical Code CSA C22.1—latest edition.

LOCATION

In selecting the location, the aesthetic and functional use of the appliance are primary concerns. However, vent system routing to the exterior and access to the fuel supply are also important.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies (Figure 2).

The location should also be free of electrical, plumbing or other heating/air conditioning ducting.

These direct-vent appliances are uniquely suited for installations requiring a utility shelf positioned directly above the fireplace. Utility shelves like these are commonly used for locating television sets and decorative plants.

Be aware that this is a heat producing appliance. Objects placed above the unit are exposed to elevated temperatures.

Do not insulate the space between the appliance and the area above it (see *Figure 7 on Page 10*).

The minimum height from the base of the appliance to the underside of combustible materials used to construct a utility shelf in this fashion is shown in *Figure 7 on Page 10*.

The appliance must be mounted on a fully supported base extending the full width and depth of the unit. The appliance may be located on or near conventional construction materials. However, if installed on combustible materials, such as carpeting, vinyl tile, or other combustible material other than wood flooring, the appliance shall be installed on a metal or wood panel extending the full width and depth of the appliance.

VENT TERMINATION CLEARANCES

These instructions should be used as a guideline and do not supersede local codes in any way. Install vent according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 in Canada.

Vertical Vent Termination Clearances




Figure 3—Multiple Terminations

Terminate multiple vent terminations according to the installation codes listed above. Also see *Figure 3*.

Terminate single vent caps relative to building components according to *Figures 3* and *4*.





Horizontal Vent Termination Clearances

The horizontal vent termination must have a minimum of 3" (77 mm) clearance to any overhead combustible projection of 2-1/2" (64 mm) or less (see *Figure 5*). For projections exceeding 2-1/2" (64 mm), see *Figure 5*. For additional vent location restrictions refer to *Figure 6* on *Page 9*.

MINIMUM CLEARANCES TO COMBUSTIBLES

The appliance is approved with zero clearance to combustible materials on all sides (as detailed in *Table 5*), with the following exception: **When the unit is installed with one side flush with a wall, the wall on the other side of the unit must not extend beyond the front edge of the unit.** In addition, when the unit is recessed, the side walls surrounding the unit must not extend beyond the front edge of the unit (see *Figure 2*).

Shelf Height

To provide for the lowest possible shelf surface, the venting attached to the top vent should be routed in a way to minimize obstructions to the space above the appliance. **Do not insulate the space between the appliance and the area above it** (see *Figure 7*). The minimum height from the base of the appliance to the underside of combustible materials used to construct a utility shelf in this fashion is shown in *Figure 7*.

Wall Finishes / Surrounds / Mantels


NOTE: Combustible wall finish materials and/or surround materials must not be allowed to encroach the area defined by the appliance front face (black sheet metal). **Neverallow combustible materials to be positioned** in front of or overlapping the appliance face. See Figure 9 and Figure 51 on Page 29.


Non-combustible materials, such as surrounds and other appliance trim, may be installed on the appliance front face with these exceptions: they must not cover any portion of the removable glass panel.


Vertical installation clearances to combustible mantels vary according to the depth of the mantel. See *Figure 8*. Mantels constructed of noncombustible materials may be installed at any height above the appliance opening. Minimum clearance requirements include any projections such as shelves, window sills, mantels, etc. above the appliance.

NOTE: We recommend the use of high temperature paint (rated 175° F or higher) on the underside of the mantel.

DETAILED INSTALLATION STEPS

The appliance is shipped with all gas controls and components installed and prewired.

- 1. Remove the shipping carton, exposing the front glass door on the valve access side.
- Using a Phillips screwdriver, unfasten two

 (2) screws located at the top of the glass frame (see Figure 47 on page 28). Tilt the top of the glass frame away from the unit. Lift it carefully off the bottom door track and set the door aside, protecting it from inadvertent damage.

TYPICAL INSTALLATION SEQUENCE

The typical sequence of installation is outlined below. However, each installation is unique and may result in variations to the steps described.



Step 1. FRAMING


Frame these appliances as illustrated in *Figure* 11 on *Page* 12, unless the appliance is to be installed in a corner. See *Figure* 12 on *Page* 13 for corner framing installations. All framing details must allow for a minimum clearance to combustible framing members as shown in *Table* 5 on *Page* 10.

If the appliance is to be elevated above floor level, a solid continuous platform must be constructed below the appliance.

Headers may be in direct contact with the appliance top spacers but must not be supported by them or notched to fit around them. All construction above the appliance must be self-supporting, **DO NOT** use the appliance for structural support.

A header heat shiled is taped to the top of the fireplace. Slide the heat shield into the framing and attach the heat shield using the screws in the standoff (see *Figure 10*).

The fireplace should be secured to the side framing members using the unit's nailing flanges—one top and bottom on each side of the fireplace front (see *Figure 10*). Use 8d nails or their equivalent.








NOTE: The nailing flanges, combustible members and screw heads located in areas directly adjacent to the nailing flanges, are EXEMPT from the 1/2" clearance to combustible requirements for the firebox outer wrapper. Combustible framing may be in direct contact with the nailing flanges and may be located closer than 1/2" from screw heads and the firebox wrapper in areas adjacent to the nailing flanges. Frame the opening to the exact dimensions specified in the framing details of this manual.





Figure 12—Corner Framing with Horizontal Termination (8DVLHT)

Step 2. ROUTING GAS LINE

Route a 1/2" (13 mm) gas line along the inside of the right side framing as shown in *Figure* 13. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations.

All appliances are factory-equipped with a flexible gas line connector and 1/2" shutoff valve. (See Step 6 on *Page 25*).

The incoming gas line should be piped into the valve compartment and connected in one of the two methods as shown in *Figure 36* on *Page 25*.



Proper Sizing of Gas Line

Properly size and route the gas supply line from the supply regulator to the area where the appliance is to be installed per requirements outlined in the National Fuel Gas Code, NFPA 54—latest edition (USA) or CAN/CGA-B149.1—latest edition (Canada).

Never use galvanized or plastic pipe. Refer to *Table 6* for proper sizing of the gas supply line, if black iron pipe is being used. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations. We recommend that a qualified individual such as a plumber or gas fitter be hired to correctly size and route the gas supply line to the appliance. Installing a gas supply line from the fuel supply to the appliance involves numerous considerations of materials, protection, sizing, locations, controls, pressure, sediment, and more. Certainly no one unfamiliar and unqualified should attempt sizing or installing gas piping.

Step 3. INSTALL THE VENT SYSTEM

General Information

These instructions should be used as a guideline and do not supersede local codes in any way. Install vent according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 and -B149.2 in Canada.

Ensure clearances are in accordance with local installation codes and the requirements of the gas supplier.

Use only approved venting components. See *Approved Vent Components* on *Page 4*.

These fireplaces must be vented directly to the outside.

The vent system may not service multiple appliances, and must never be connected to a flue serving a separate solid fuel burning appliance. The vent pipe is tested to be run inside an enclosing wall (such as a chase). There is no requirement for inspection openings in the enclosing wall at any of the joints in the vent pipe.

Installation of Vent Restrictor




Figure 14—Vent Restrictor Installation

A vent restrictor may be needed with this appliance. The restrictor is installed in the appliance top flue outlet as shown in *Figure 14*,

For vertical venting from 6 feet to 12 feet or more, from the top of the fireplace to the top of the termination, the installation of a vent restrictor is required.

If necessary, install a vent restrictor in the appliance flue outlet as shown in *Figure 14*. The vent restrictor is held in place by friction, only.

NOTE: The restrictor is included within the firebox.

When vertically terminating the vent system above the roof, install a vent restrictor in the top vent of the fireplace outlet. Install the restrictor as shown from inside the unit, in the inner fireplace collar


VERTICAL TERMINATION SYSTEMS (ROOF)

See *Figure 15* and *Figures 23* through 25 on *Page 18* and their associated Vertical Vent Tables which illustrate the various vertical venting configurations that are possible for use with these appliances. **8" DV Lock** pipe applications are shown in these figures. A Vertical Vent Table summarizes each system's minimum and maximum vertical and horizontal length values that can be used to design and install the vent components in a variety of applications.

The vertical vent system terminates through the roof. The minimum vent height above the roof and/or adjacent walls is specified in ANSI Z223.1—latest edition (In Canada, the current CAN/CGA-B149.1 installation code) by major building codes. Always consult your local codes for specific requirements. A general guide to follow is the Gas Vent Rule (refer to *Figure 4 on Page 8*).

Vertical (Straight) Installation (Figure 15)

Determine the number of straight vent sections required. 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm) net section lengths are available (see *Tables on this page* and *Page 18—Vent Sections*). Plan the vent lengths so that a joint does not occur at the intersection of ceiling or roof joists. Refer to the Vent Section Length Chart.


Vertical (Offset) Installation

Analyze the vent routing and determine the quantities of vent sections and number of elbows required. Refer to **Vertical Vent Figures and Tables on** *Page 18* to select the type of vertical installation desired. Vent sections are available in net lengths of 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm). Refer to the **Vent Section Length Chart on** *Page 15* for an aid in selecting length combinations. Elbows are available in 90° and 45° configurations. Refer to *Figure 19 on Page 17* for the 8DVLE45 and 8DVLE90 elbow dimensional specifications.

Where required, an adjustable DV length section (8DVLAL) may be used to provide the installer with an option in installing in tight and confined spaces or where the vent run made up of fixed length pieces develops a joint in a undesirable location, or will not build up to the required length. The 8DVLAL adjustable DV length section has an effective length of from 1-1/2" (38 mm) to 6-3/4" (171 mm). The 8DVLAL is fitted with a dimpled end (identical to a normal vent section component) and a plain end with 3 pilot holes. Slip the dimpled end over the locking channel end of a standard 8DVL vent component the required distance and secure with three screws.


Maintain a minimum 1" (26 mm) clearance to combustible materials for all vertical elements. Clearances for all horizontal elements are 3" (77 mm) on top, 1" (26 mm) on sides and 1" (26 mm) on the bottom.

A. Frame ceiling opening—Use a plumb line from the ceiling above the appliance to locate center of the vertical run. Cut and/or frame an opening, 13" x 13" (330 mm x 330 mm) inside dimensions, about this center mark (*Figure 16*).



B. Attach vent components to appliance— 8" DV Lock (8DVL) direct-vent system components are unitized concentric pipe components featuring positive twist lock connections (see Figure 17).

All of the appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the appliance collar to create the positive twist lock connection.



Joint Connection - 8" DV LOCK Direct Vent components are engineered for easy twist lock assembly. Eight indentations are located on the female end of pipe and fittings to slide straight into the male end of the adjacent pipe or fitting, by orientating the eight indentations so they match and slide into the eight entry slots on the male ends.

Push the pipe sections completely together, then twist lock one section clockwise approximately one-quarter turn until the two sections are fully locked (see **Figure 17**). Indentations on the female end of black painted pipe and fittings will not be visible unless by examining the inside of the female ends.

The unitized design of the **8" DV Lock** components will engage and seal both the inner and outer pipe without the need for sealant or screws. If desired a #6 \times 1/2" screw may be used at the joint, but it is not required as the pipe will securely lock when twisted.

C. Attach vent components to each other—Other vent sections may be added to the previously installed section in accordance with the requirements of the vertical vent figures and tables. To add another vent component to a length of vent run, align the dimpled end over the inclined channel end of the previously installed section, adjusting the radial alignment until the eight female end indentations are aligned with the male end entry slots of the previous section.

Push the vent component against the previous section until it fully engages, then twist the component clockwise running the dimples down and along the incline channels until they seat at the end of the channels. This seating position is indicated by the alignment of the indents into the entry slots as shown in *Figure 17*.


D. Install vertical firestop at ceiling—When using 8" DV Lock, use 8DVLVF vertical firestop at ceiling joists. If there is living space above the ceiling level, the vertical firestop must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the vertical firestop must be installed on the top side of the joist.

Route the vent sections through the framed opening and secure the firestop with 8d nails or other appropriate fasteners at each corner. Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections. Insulation shield (F4358) is required and may be used to help maintain the clearances indicated here. See installation accessories on *Page 31*. The gap between the vent pipe and a vertical firestop can be sealed with non-combustible caulking.

E. Support the vertical vent run sections-


NOTE: Proper venting support is very important. The weight of the vent must not be supported by the fireplace in any degree.

Support the vertical portion of the venting system every 8 feet (2.4 m) above the fireplace vent outlet.



One method of support is by utilizing field provided wall support straps (conventional plumber's tape). Secure the plumber's tape to the framing members with nails or screws. Strap the tape around the vent, securing the ends of the tape to the framing. If desired, sheet metal screws #6 x 1/2" length may be used to secure the wall support straps to the vent pipe. See *Figure 18 on Page 16*.


F. Change vent direction to horizontal/inclined run—At transition from or to a horizontal/inclined run, install the 8DVLE45 and 8DVLE90 elbows in the same manner as the straight vent sections. Fully engage the inner and outer unitized pipes at the bottom of the elbow. Rotate the elbow in the desired direction. NOTE: Three (3) holes are provided at the bottom of the elbows. Secure the elbow in place with a minimum of two (2) self tapping screws. The top of the elbow will connect to straight lengths of 8" DV Lock pipe by twist-locking the pieces together. See Figure 17 on Page 16 and Figure 19.



G. Continue installation of horizontal/inclined sections—Continue with the installation of the straight vent sections in horizontal/inclined run as described in **Step C.** Install wall support straps every 3 ft (914 mm) along horizontal/ inclined vent runs using conventional plumber's tape. See Page 19, Figure 26. It is very important that the horizontal/inclined run be maintained in a straight (no dips), slightly elevated plane. The recommended incline is approximately 1/4" per foot (20 mm per meter) horizontal, in a direction away from the fireplace. The rise per foot run ratios that are smaller are acceptable all the way down to at or near level. Use a carpenter's level to measure from a constant surface and adjust the wall support straps as necessary.

It is important to maintain the required clearances to combustibles: 1"(26 mm) at all sides for all vertical runs; and 3" (77 mm) at the top, 1" (26 mm) at sides, and 1" (26 mm) at the bottom for all horizontal/inclined runs.


H. Frame roof opening—Identify location for vent at the roof. Cut and/or frame opening per Roof Framing Chart (*Figure 20*).





- I. Install the roof flashing—Extend the vent sections through the roof structure. Install the roof flashing over the vent section and position such that the vent column rises vertically (use carpenters level) (*Figure 21*). Nail along perimeter to secure flashing or adjust roofing to overlap the flashing edges at top and sides only and trim where necessary. Seal the top and both sides of the flashing with waterproof caulking.
- J. Install the storm collar—Install the storm collar, supplied with the vertical termination, over the vent/flashing joint (see *Figure 21*). Secure the storm collar in place on top of the flashing by sliding the tab through the mating slot and folding over. Apply non-combustible caulking or mastic around the circumference of the joint to provide a water tight seal.



K. Install the vertical termination—The final step involves installation of the Vertical Termination. Extend the vent sections to the height as shown in the "Vertical vent termination section" on *Page 8*. The 8DVLVT Vertical Termination (*Figure 22*) can be installed in the exact same fashion as any other 8" DV Lock section. Align the termination over the end of the previously installed section, adjusting the radial alignment until the entry slots on the last vent section engage into the indents on the termination. Push the termination down until it fully engages, then twist the termination clockwise running the dimples down and along the incline channels until they seat at the end of the channels.



If the vent system extends more than 5 feet (1.5 m) above the roof flashing, stabilizers may be necessary. Additional screws may be used at section joints for added stability. Guide wires may be attached to the joint for additional support on multiple joint configurations.

VERTICAL VENT FIGURES/TABLES

NOTES

- 8" DV Lock (rigid vent pipe) is shown in the figures
- It is very important that the horizontal/ inclined run be maintained in a straight (no dips), slightly elevated plane. The recommended incline is approximately 1/4"per foot (20 mm per meter) horizontal, in a direction away from the fireplace. The rise per foot run ratios that are smaller are acceptable all the way down to at or near level.
- 8DVLVF (8" DV Lock) vertical firestop must be used anytime vent pipe passes through a combustible floor or ceiling. 8DVLHF (8" DV Lock) horizontal firestop must be used anytime vent pipe passes through a combustible wall.
- Two 45° elbows may be used in place of one 90° elbow. The same rise to run ratios, as shown in the venting figures for 90° elbows, must be followed if 45° elbows are used.




Figure 23—Top Vent—Straight






HORIZONTAL (OUTSIDE WALL) TERMINATION SYSTEM

See *Figures 26–31* and their associated Horizontal Venttables that illustrate the various horizontal venting configurations that are possible for use with these appliances. **8" DV Lock** pipe applications are shown in these Figures. A Horizontal Venttable summarizes each system's minimum and maximum vertical and horizontal length values that can be used to design and install the vent components in a variety of applications.

The horizontal vent system terminates through an outside wall. Building Codes limit or prohibit terminating in specific areas. Refer to *Figure 6* on *Page 9* for location guidelines.

8" DV Lock direct-vent system components are unitized concentric pipe components featuring positive twist lock connection, (refer to Figure 17 on Page 16). All of the appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the appliance collar to create the positive twist lock connection.


A. Plan the vent run.

Analyze the vent routing and determine the types and quantities of sections required 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm) net section lengths are available. It is recommended that you plan the venting so that a joint does not occur in the ceiling or roof joists. Allow for elbows as indicated in *Figure 20 on Page 17*.

Maintain a minimum 1" (26 mm) clearance to combustibles on the vertical sections. Clearances for the horizontal runs are; 3" (77 mm) on top, 1" (26 mm) on sides, and 1" (26 mm) at the bottom.

- **B. Frame exterior wall opening**—Locate the center of the vent outlet on the exterior wall according to the dimensions shown in *Figure 11 on Page 10*. Cut and/or frame an opening, 15" x 13" (381 mm x 330 mm) inside dimensions, with 9" above center and 7" below center.
- **C. Frame ceiling opening**—If the vertical route is to penetrate a ceiling, use plumb line to locate the center above the appliance. Cut and/or frame an opening, 13" x 13" (330 mm x 330 mm) inside dimensions, about this center (refer to *Figure 17* on *Page 16*).
- **D.** Attach vent components to appliance—To attach a vent component to the appliance collar, align the dimpled end over the collar, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels on the collar (*refer to Figure* 16 on *Page 16*).

Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels. The unitized design of the **8" DV Lock** components will engage and seal both the inner and outer pipe elements with the same procedure. Sealant and securing screws are not required.



E. Attach vent components to each other—

8" DV LOCK Direct Vent components are engineered for easy twist lock assembly. Eight indentations are located on the female end of pipe and fittings to slide straight into the male end of the adjacent pipe or fitting, by orientating the eight indentations so they match and slide into the eight entry slots on the male ends.

Push the pipe sections completely together, then twist lock one section clockwise approximately one-quarter turn until the two sections are fully locked (see Figure 17 on Page 16). Indentations on the female end of black painted pipe and fittings will not be visible unless by examining the inside of the female ends.

F. Install vertical firestop at ceiling - When using 8" DV Lock, use 8DVLVF vertical firestop at ceiling joists. If there is living space above the ceiling level, the vertical firestop must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the vertical firestop must be installed on the top side of the joist.

Route the vent sections through the framed opening and secure the firestop with 8d nails or other appropriate fasteners at each corner. Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections. Insulation shield (F4358) is required and may be used to help maintain the clearances indicated here. See installation accessories on *Page 31*. The gap between the vent pipe and a vertical firestop can be sealed with non-combustible caulking.

Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections.

- **G. Support the vertical run sections**—See *Step E* on *Page 16.*
- H. Change vent direction—Attransition from or to a horizontal/inclined run, install the 8DVLE45 and 8DVLE90 elbows in the same manner as the straight vent sections. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element. Twist elbow sections in a clockwise direction only so as to avoid the possibility of unlocking any of the previously connected vent sections (see Figure 17 on Page 18).
- I. Continue installation of horizontal/inclined sections—Continue with the installation of the straight vent sections in horizontal/inclined run as described in **Step E on Page 16**. Install wall support straps every 3 feet (1914 mm) along horizontal/inclined vent runs using conventional plumber's tape.

See Figure 26, It is very important that the horizontal/inclined run be maintained in a straight (no dips), slightly elevated plane. The recommended incline is approximately 1/4" per foot (20 mm per meter) horizontal, in a direction away from the fireplace. The rise per foot run ratios that are smaller are acceptable all the way down to at or near level.

It is important to maintain the required clearances to combustibles: 1"(26 mm) at all sides for all vertical runs; and 3" (77 mm) at the top, 1" (26 mm) at sides, and 1" (26 mm) at the bottom for all horizontal/inclined runs.

Use a carpenter's level to measure from a constant surface and adjust the wall support straps as necessary.

J. Assemble vent run to exterior wall—If not previously measured, locate the center of the vent at the exterior wall. Prepare an opening as described in *Step B on Page 19*. Assemble the vent system to point where the terminus of the last section is within 5" (127 mm) to 8-1/2" (216 mm) inboard of the exterior surface to which the 8DVLHT horizontal termination is to be attached, see *Figure 29* and *Table 9 on Page 21*.




Figure 28—Wall Thickness and Horizontal Termination Requirements

If the terminus of the last section is not within this distance, use the adjustable DV length section, 8DVLAL, as the last vent section. For wall thicknesses greater than that shown in *Figure 28*, refer to *Table 9 on Page 21*. This table lists the additional venting components needed (in addition to the termination and adaptor) for a particular range of wall thicknesses.

K. Install horizontal firestop at exterior wall—When using the horizontal termination, install 8DVLHF horizontal firestop over the opening at the exterior side of the framing, long side up, with the 3" spacer clearance at the top as shown in *Figure 27*, and nail into place.

(The horizontal firestop may also be installed over the opening at the interior side of the framing).

L. Install the Horizontal Termination (8DV-LHT)— Before attaching the termination to the exterior wall, run a bead of non-hardening sealant around the termination's outside edges so as to make a seal between the termination and the wall.


With the **HOT arrow on the termination pointing up**, slide the termination through the wall and into the vent pipe and secure the termination to the exterior wall with four wood screws.

The termination must slide over the mating vent pipe a minimum of 1-1/4 inches. Use an 8DVLAL Adjustable DV Length section if necessary to complete the connection with the vent pipe. If using the 8DVLAL, secure it using three (3) #8 x 1/2 sheet metal screws.

Secure the joint between the termination and vent pipe by attaching the two metal strips extending from the termination to the outer vent pipe with two (2) #8 x 1/2 sheet metal screws.

The horizontal termination must not be recessed into the exterior wall or siding by more than the 1-1/4" (32 mm) as shown in Figure 28.

IMPORTANT: The vent termination is hot while in operation and for a period of time following the use of the fireplace. Young children should be carefully supervised when they are in the same area as a hot termination.

Horizontal terminations have been designed to perform in a wide range of weather conditions. Our terminations meet or exceed industry standards.

When selecting the locations of your horizontal terminations, do not place the termination where water from eaves and adjoining rooflines may create a heavy flow of cascading water onto the termination cap. If the cap must be placed where the possibility of cascading water exists, it is the responsibility of the builder to direct the water away from the termination cap by using gutters or other means.

Take care to carefully follow the installation instructions for the termination, including the use of silicone caulking where required.

See Table 9 as an aid in venting component selection for a particular range of exterior wall thicknesses.






Step 4. FIELD WIRING

A CAUTION

Ground supply lead must be connected to the wire attached to the green ground screw located on the outlet box. Failure to do so will result in a potential safety hazard. The appliance must be electrically grounded in accordance with local codes or, in the absence of local codes, the National Electrical Code, ANSI/NFPA 70-latest edition. (In Canada, the current CSA C22-1 Canadian Electrical Code).

CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation.


The gas valve is set in place and pre-wired at the factory.


Electronic Wiring

NOTE: The electronic appliance must be connected to the main power supply.

- **1**. Route a 3-wire 120Vac 60Hz 1ph power supply to the appliance junction box.
- Remove the electrical inlet cover plate from the side of the unit by removing the plate's securing screws (see Figure 11 on Page 12).
- Remove the cover plate's knockout and then feed the power supply wire through the knockout opening and into the unit junction box.
- Connect the black power supply wire to the power outlet's red pigtail lead and the white power supply wire to the common terminal of the outlet as shown in Figures 32 and 33.
- Connect the ground supply wire to the pigtail lead attached to outlet's green ground screw.

- Install the wall-mounted ON/OFF control, as described in "Installing and initializing the Remote Control System" on *Page 24*, in a convenient location near the fireplace.
- **7**. After the wiring is complete, replace the cover plate.





Installing and initializing the Remote Control System

REQUIRED ITEMS (not provided):

- Standard Junction Box
- Paper Clip or similar object (for remote control system initialization)

Installing and Wiring the Receiver (Wall Switch)

The receiver for the Total Comfort Control™ Remote Control System connects directly to the gas valve, stepper motor, and fan control module with an umbilical cord wiring harness.

- Install a junction box (not provided) on the wall adjacent to the appliance, within reach of the remote system umbilical cord wiring harness. Position the 6-pin terminal within the junction box in preparation for attachment to the remote receiver.
- When wall finish is complete, install the receiver in the previously installed junction box, and connect the 6-pin terminal to the 6-pin connector on the back of the receiver.
- Install the receiver cover plate, taking care to ensure the receiver switch is properly indexed with the switch cover when aligning the components for attachments.

Initializing the Remote Control System

After completing fireplace installation, initialize the remote control system before operating the fireplace.

- Insert the three (3) provided AAA batteries into the battery bay in the transmitter, taking care to correctly align polarity (+/ -).
- 5. Insert the four (4) provided AA batteries into the receiver battery bay (behind the wall switch plate), taking care to correctly align polarity (+/).
- On the receiver, place the three-position slider switch in the REMOTE position (Figure 34).
- On the receiver front cover, insert the end of a paper clip (or other similar object; not provided) into the hole marked "PRG."

The receiver will "beep" three times to indicate it is ready to synchronize with the transmitter.

On the transmitter, press the ON button.
 The receiver will "beep" four times to indicate acceptance of the transmitter's command (and set the receiver to the transmitter's specific code). The system is now initialized.

The remote control system provides remote operation of the following fireplace functions:


- · Primary burner ON/OFF
- Flame height and heat output adjustment (six levels)


The receiver accepts commands via radio frequency from the transmitter and does not require line-of-sight operation.

The slider switch on the receiver can be set to one of three positions:

- ON (manual override)
- OFF (manual override)
- REMOTE (remote control)

See the fireplace Care and Operation Instructions for detailed instructions on using the remote control system to operate the fireplace.





A WARNING

Fire hazard. Can cause severe injury or death. The receiver causes ignition of the appliance. The appliance can turn on suddenly. Keep away from the appliance burner when operating the remote system or activating manual bypass of the remote system.

ACAUTION

Property damage hazard. Excessive heat can cause property damage. The appliance can stay lit for many hours. Turn off the appliance if it is not going to be attended for any length of time. Always place the transmitter where children can not reach it.

Step 5. REMOVE GLASS DOOR FRAME

Remove the glass door assembly. See *Installation and Removal of Glass Door* on *Page 28*.

Step 6. CONNECTING GAS LINE

All codes require a shut-off valve mounted in the supply line. The orientation of the shut-off valve should face the front. *Figure 36* illustrates two methods for connecting the gas supply. A Sediment Trap is recommended to prevent moisture and debris in gas line from damaging the valve.

The flex-line method is acceptable in the U.S.A. where local codes permit, however, Canadian requirements vary depending on locality. Installation must be in compliance with local codes. These appliances are equipped with a gas flex-line for use in connecting the unit to the gas line. See *Figure 36* for flex-line description. The flex-line is rated for both natural and propane gas. A manual shut off valve is also provided with the flex-line.


The gas control valve is located on the right side of the unit.

When using solid gas line connector, access the valve by removing the front door assembly on the valve access side and the access plate (see Figure 37).

The electronic control valve has a 3/8" (10 mm) NPT thread gas supply inlet.

Bring the shutoff valve on the end of the flex-line over to the hard pipe and tighten with wrenches from above through the firebox opening.

Secure all joints tightly using appropriate tools and sealing compounds (ensure propane resistant compounds are used in propane applications). It is recommended to seal around the gas line to prevent cold air leakage.




TEST ALL CONNECTIONS FOR GAS LEAKS (FACTORY AND FIELD):

A WARNING

Never use an open flame to check for leaks.

Turn on gas supply and test for gas leaks using a gas leak test solution (also referred to as bubble leak solution).

NOTE: Using a soapy water solution is an effective leak test solution but it is not recommended, because the soap residue that is left on the pipes/fittings can result in corrosion over time.



- A. Light the appliance (refer to the lighting instructions label in the control compartment or in the Care and Operation Instructions manual).
- **B.** Brush all joints and connections with the gas leak test solution to check for leaks. If bubbles are formed, or gas odor is detected, turn the receiver or remote control to the "OFF" position. Either tighten or refasten the leaking connection, then retest as described above.
- **C.** When the gas lines are tested and leak-free be sure to rinse off the leak testing solution.
- **D.** Re-install the access plate, making certain the gasket has not been damaged.

Step 7. VERIFY PROPER FIREPLACE OPERATION

Turn on burner then observe the individual tongues of flame on the burner. Make sure all ports are open and producing flame evenly across the burner. If any ports are blocked, or partially blocked, clean out the ports.


With gas line installed run initial system checkout before closing up the front of the unit. Follow the lighting instructions provided in the Care and Operation Instructions manual.

NOTE: Lighting Instructions are also found on the literature tag tied to the bracket above the gas valve. To access the tag, reach into the right side opening.

When first lighting the appliance, it will take a few minutes for the line to purge itself of air. Once purging is complete, the pilot and burner will light and operate as indicated in the instruction manual. Subsequent lighting of the appliance will not require such purging. Inspect the pilot flame (remove logs, if necessary, handling carefully).

Electronic Appliance Checkout

To light the burner, turn "ON" the optional remote wall switch or turn the appliance mounted ON/OFF switch to the "ON" position. Ensure the igniter lights the pilot. The pilot flame should engulf the flame sensor as shown in *Figure 38*.



Step 8. INSTALL VOLCANIC STONE, GLOWING EMBERS, AND LOGS (Traditional Only), or **GLASS MEDIA (Contemporary Only)**

NOTE: If installing the Contemporary Burner/Floor Kit, skip this step and instead refer to the instructions provided with the kit.

WARNING

- DO NOT operate this appliance without the required accessories properly installed:
- floor (log set or contemporary kit), and
- firebox liner panels (ceramic or porcelain).

WARNING

- DO NOT attempt to install the logs until the appliance installation has been completed, the gas line connected and tested for leaks and the initial burner operation has been checked out.
- The size and position of the log set was engineered to give the appliance a safe, reliable and attractive flame pattern. Any attempt to use a different log set in the fireplace will void the warranty and will result in incomplete combustion, sooting, and poor flame quality.
- Logs get very hot and will remain hot up to one hour after gas supply is turned off. Handle only when logs are cool. Turn off all electricity to the appliance before you install grate, volcanic stone, embers and logs.
- This appliance is not designed to burn wood. Any attempt to do so could cause irreparable damage to the appliance and prove hazardous to your safety.
- If logs are not installed according to the log installation instructions, flame impingement and improper combustion could occur and result in soot and/or excessive production of carbon monoxide (CO), a colorless, odorless, toxic gas.
- Step 1. Install the ceramic or porcelain firebox liner panels per the instructions provided in kit.
- Step 2. Place volcanic stone around the burner (the entire bag of volcanic stone will NOT be used). DO NOT PLACE VOLCANIC STONE ON THE BURNER. See Figure 41.
- **Step 3.** Separate the glowing embers (rockwool) into pieces about the size of a quarter (see Figure 39). Keep the pieces fluffed, not matted. Distribute these pieces over the burner as shown in Figure 40. Do not use more than necessary. When properly positioned, the Glowing Embers will cover approximately 75% of the burner on natural gas. For propane gas, do not place embers on main ports.


NOTE: Excessive use of embers may result in sooting or poor flame. This appliance is provided with enough Glowing Embers for several applications, do not feel compelled to use all that is in a new bag. For best glowing effect, replace the ember material annually. Replacement Glowing Embers are available (Catalog Number 88L53).




Figure 42 - Placing Log 1

Step 4. Position the individual logs as shown in *Figures 42 through 46*. Logs should be placed in the order shown. Place logs 2 and 3 against the pins on the grate, NOT over them.

Proper log and twig placement is critical to encourage outstanding flame appearance and prevent sooting. When positioned properly as shown, twigs will be positioned between flame peaks and will not impinge any flames.






Figure 43 - Placing Log 2





Contemporary Only: Glass Media Placement

 Spread a thin layer of the media evenly on the burner and media screen.



On the corner of the right media screen, arrange the media to allow the pilot flame to reach the burner during lighting.

NOTE: It is important to ensure proper log and/or media placement per the manual when installing these units. Verify pilot flame is not obstructed. Ensure media does not fall through the pilot hole in the floor. See Verify Appliance Operation on Page 25.

Step 9. INSTALLATION AND REMOVAL OF GLASS DOOR

WARNING

- When reinstalling the glass door, the door latch screws must be securely tightened to prevent the glass door from falling out, which could potentially cause damage and possible injury.
- Do not attempt to substitute the materials used on this door, or replace cracked or broken glass.
- Handle this glass with extreme care! Glass is susceptible to damage — Do not scratch or handle roughly while reinstalling the glass door frame.
- The glass door of this appliance must only be replaced as a complete unit as provided by the manufacturer. Do not attempt to replace broken, cracked or chipped glass separately.
- Do not attempt to touch the front enclosure glass with your hands while the fireplace is in use.
- The door should easily close without needing to be pressed down. If it has to be pressed down to close, the gasket in the top of the door should be dressed so it lays on the glass.

Installing Glass Enclosure Panel (see Figure 47)

Retrieve the glass door. Visually inspect the gasket on the backside of the frame. Gasket surface must be clean, free of irregularities and seated firmly.

Position the door in front of the firebox opening with the top of the door held away from the fireplace (*Figure 47*). Lower the bottom of the door assembly on the bottom door track and set on padded surface. Pivot the door up after engaging and centering in the base channel.

Using a Phillips screwdriver, fasten the door frame to the door latch with the two (2) screws. The latch should pull forward to engage the door frame.


Install the door modesty shield on top flange glass door as follows: grab the door modesty shield with both hands, with the open hem going down and engage it with the upper lip of the glass door frame by pushing it all the way down. Make sure the installed shield is firmly in place.

Barrier (see Notice, Page 28)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.


To remove barrier follow these steps.

- 1.Lift barrier up by the frame at the top.
- 2.Remove lower filler piece by pulling down off of the barrier.
- 3.Lower barrier and push barrier to left to release right side.
- 4. Pull the right side out of fireplace.
- 5. Remove barrier.





FINISHING REQUIREMENTS Wall Details

Complete finished interior wall. To install the appliance facing flush with the finished wall, position framework to accommodate the thickness of the finished wall (*Figure 51*).



- ① Installations with horizontal terminations which have minimum vertical vent height only will require 4"(102mm) minimum side clearance as shown in shaded zone above. All other installations require 1" (26 mm) minimum side clearance as specified in Figure 4 on Page 8.
- * Insulation is NOT ALLOWED in the clearance zones around vent components. Keep this area free from combustible materials.



NOTE: A hearth extension is not required with this appliance.

Non-combustible materials, such as surrounds and other appliance trim, may be installed on the appliance front face with the exceptions.

Vertical installation clearances to combustible mantels vary according to the depth of the mantel (see *Figure 8 on Page 10*). Mantels constructed of non-combustible materials may be installed at any height above the appliance opening.

Combustible materials may project beyond the side of the fireplace opening as long as it is kept within the shaded area illustrated in *Figure 9 on Page 10*.



NOTE: A finish trim piece is shipped with your fireplace to extend the base 1/2" to be flush with the finish flanges on the side of the fireplace. This filler is shipped on top of the fireplace wrapped in foam. If desired this piece can be placed on the base of the fireplace. It is secured with bend tabs on either side. Lay the extension in front of the base then secure by bending tabs on each side over to secure to the base. While this piece is provided it is not required.

Step 1. TURN OFF THE GAS SUPPLY TO THE APPLIANCE and disconnect power supply at the circuit breaker. Ensure appliance is cold.



Step 2. Remove the front glass door/frame and the access plate from the appliance. See *Figures 37 and 47*.

Step 3. Carefully remove the logs and the grate assembly / contemporary media. Exercise care so as not to break the logs / contemporary media.

Step 4. Refer to *Figure 55.* Remove the two 5/16" screws securing the burner to the burner brackets. Carefully slide the burner to the left to clear the venturi from the orifice. Set aside the screws and burner assembly in a secure location for later reinstallation.



Step 5. Remove the control compartment access door and gasket by removing the twelve (12) screws securing it, and set it aside for later reinstallation. The gas valve can be accessed through the opening, or the complete assembly can be removed by sliding the assembly to the right.

Step 6. Refer to the instructions provided with the SIT regulator conversion kit. Using a Torx T20 (with 1/4" shank and center hole) or slotted screwdriver, remove and discard the two pressure regulator mounting screws, the pressure regulator tower, and the diaphragm assembly (if applicable). Properly dispose of all removed components. Make sure the rubber gasket installed on the back of the replacement pressure regulator is properly positioned.

Step 7. Install the new stepper motor pressure regulator assembly using the supplied screws. Securely tighten the screws (25 in-lbs).

Step 8. Attach the enclosed identification label to the valve body where it can be easily seen.

Step 9. Make stepper motor and valve electrical connections.








Use pipe joint compound or Tef-Ion tape on all pipe fittings before installing (ensure propane resistant compounds are used in propane applications, do not use pipe joint compounds on flare fittings).
- B. Retrieve the burner and slide the venturi tube over the orifice. Set the burner assembly into its position and secure it.
- C. Reinstall the grate assembly.

Step 13. Reassemble the remaining components by reversing the procedures outlined in the preceding steps.

Step 14. Attach the conversion label provided in the conversion kit to the rating plate on the appliance.

Step 15. Apply gas to the system and relight appliance. With the main burner "ON", test the new pressure regulator assembly and all gas line joints for leaks using a gas leak test solution. See Test All Connections For Gas Leaks on *Page 25*.





Step 16. Relight the main burner and verify proper burner ignition and operation. See *Burner* Adjustments Pages 41 and 42.





If they are not affixed at these spots, locate the multi-lingual adhesive labels provided with these instructions and proceed as follows:

- Locate the wall receiver that controls the fireplace (verify the switch operates the fireplace by turning it on and off). Clean the wall receiver plate thoroughly to remove any dust and oils. Affix the label to the surface of the plate of the wall receiver that controls the fireplace (*Figure A*). Choose the language primarily spoken in the home.
- Locate the remote control transmitter and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld transmitter (Figure B). Choose the language primarily spoken in the home.
- If you are unable to locate the labels, please call Innovative Hearth Products or your nearest Innovative Hearth Products dealer to receive additional safety instruction labels free of charge.

GENERAL INFORMATION

The fireplace models covered in this manual are direct-vent, sealed combustion gas fireplaces designed for residential application. Directvent appliances operate with the combustion chamber completely isolated from the indoor environment.

All air for combustion is brought in from the outside and exhaust gases are vented through the same direct-vent, co-axial (intake/exhaust) vent system.

The appliances are designed to operate on natural or propane gas only and contain an electronic intermittent pilot system. Electrical power (120 Vac line voltage) is recommended to operate the fireplace; however, four (4) "AA" batteries can be used for full-time operation or as a backup in case of a power outage.

These appliances comply with National Safety Standards and are tested and listed by PFS TECO (Report No. F14-106) to ANSI Z21.50 (in Canada, CSA-2.22), and CAN/CGA-2.17-M91 in both the USA and Canada as vented gas fireplaces.

The Installation must conform to local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54-latest edition, or the Natural Gas and Propane Installation Code, CAN/CGA-B149.1—latest edition. The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70—latest edition, or the Canadian Electrical Code, CSA C22.1—latest edition.

Test gauge connections are provided on the front of the gas control valve, identified IN for the inlet and OUT for the manifold side (see Figure 60 on Page 38). The control valves have a 3/8" (10 mm) NPT thread inlet and outlet side of the valve.

Propane tanks are at pressures that will cause damage to valve components. Verify that the tanks have step down regulators to reduce the pressure to safe levels.

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures in excess of 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures **equal to or less than** 1/2 psi (3.5 kPa).

Orifice Sizes— Sea Level to High Altitude (All Models)

These appliances are tested and approved for installation at elevations of 0-4500 feet (0-1372 meters) above sea level using the standard burner orifice sizes (marked with an "*" in Table 14).

For elevations above 4500 feet, contact your gas supplier or qualified service technician.

Deration-At higher elevations, the amount of BTU fuel value delivered must be reduced by either using gas that has been derated by the gas company or by changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1—latest edition or, in Canada, the CAN/ CGA-B149.1 codes—latest edition.

Install the appliance according to the regulations of the local authorities having jurisdiction and, in the USA, the National Fuel Gas Code NFPA 54 / ANSI Z223.1—latest edition or, in Canada. the CAN/CGA-B149.1—latest edition.

Flame breadth, height and width will diminish 4% for every 1,000 feet of altitude.

Burn-in Period

During the first few fires of this appliance there will be some odor due to the curing of the paint and burning off of lubricants used in the manufacturing process. Depending on your use, the burn-in period may take a few hours or a few days.

KEEP YOUR HOUSE WELL VENTILATED **DURING THE CURING PROCESS. THE ODOR** AND HAZE EMITTED DURING THE CURING PROCESS CAN BE QUITE NOTICEABLE AND MAY SET OFF A SMOKE DETECTOR.

NOTICE: A white film may develop on the glass enclosure panel during the first few fires as part of the burn-in process.

The first few times you use the fireplace, clean the glass after each use (AFTER THE GLASS HAS COMPLETELY COOLED); otherwise, the white film will bake onto the glass and become difficult to remove.


Operation and Care of Your Appliance

Familiarize yourself with the gas control valve that your appliance uses. Refer to *Figure 2* for access to the gas control valve.

Appliances are fitted with the electronic valve shown in *Figure 61*.


To light the appliance refer to the detailed lighting instructions (see *Pages 46 and 47*). The appliance lighting instructions can also be found on the pull-out lighting instruction labels attached to the gas control valve.

Your appliance is equipped with a wall receiver switch and a remote control.



Variable Flame Height Adjustment

All appliances are equipped with a variable gas control valve. Flame height for these models may be adjusted through a range between fixed low and high settings, alternately, while the appliance is in operation. Use the remote control to adjust the flame height as desired.



MAINTENANCE

(See Maintenance Schedule, Page 48)

Refer to the maintenance schedule for maintenance tasks, procedures, frequency and by whom they should be performed. Always verify proper operation of the appliance after servicing.



WARNING

Turn off gas and electrical power to the fireplace and allow it to cool before cleaning or servicing the appliance.

CAUTION: Wear gloves and safety glasses for protection while doing required maintenance.

Verify proper operation after servicing. S'assurer que l'appareil fonctionne adéquatement une fois l'entretien terminé.

Always turn off the gas before cleaning. Before re-lighting, refer to the lighting instructions in this manual. Instructions are also found on a pull-out panel located in the control compartment.

Always keep the appliance area clear and free from combustible materials, gasoline and other flammable liquids.

Inspect Venting System

NOTE: Inspect exhaust termination for blockage or obstruction such as plants, bird nests, leaves, snow. debris. etc.

The appliance and venting system should be thoroughly inspected before initial use and at least annually by a qualified service technician (inspection should include ensuring that exhaust or intake passages are unobstructed and vent components are properly assembled and not damaged). Homeowner must contact a qualified service technician at once if any abnormal condition is observed.

If the venting system is disassembled for any reason, a qualified service technician should follow vent installation instructions for proper reassembly and proper sealing of the venting system components. However, more frequent periodic inspections and cleanings should be performed by the homeowner.

Glass Cleaning

(see Front Glass Enclosure Panel, Removal and Installation on Page 40).

NOTE: Clean glass after first two weeks of operation (after Burn-In period is over) and then only when necessary and when the fireplace is cool. Wipe surface with a clean, dampened, soft cloth. Follow with a dry, soft towel as desired. Take care not to scratch the glass surface.

WARNING: Do not use abrasive cleaners on glass. Never clean the glass when it is hot.

The viewing glass should be cleaned periodically to remove any build-up caused from the following:

- During start-up, it is normal for condensation to form on the inside of the glass (this condensation and fog will usually disappear in a few minutes). The moisture can cause lint, dust and other airborne particles to cling to the glass surface.
- Initial curing of the high temperature paint and burning off of lubricants used in the manufacturing process may result in a film on the glass.
- A white coating may form on the glass as a result of impurities and minerals in the fuel.

It is recommended that the glass be cleaned two or three times during each heating season. depending on the circumstances present. The following cleaning solutions are approved for use to clean glass:

- Non-ammonia based household cleaner
- · Gas fireplace/stove glass cleaner

Inspect Glass Gasket—Visually inspect the gasket on the backside of the glass enclosure panels. The gasket surface must be clean, free of irregularities and seated firmly.

Clean Control Compartment

Keep control compartment clean by vacuuming or brushing at least twice a year. More frequent cleaning may be required due to excessive lint from carpeting, bedding materials, etc. It is important that control compartments, burners and circulating air passageways of the appliance be kept clean.

Clean Logs and Burner

Carefully remove the logs (use care when handling the fiber logs, as they become quite fragile after curing). Vacuum out any foreign matter (lint, carbon, etc.) on the burner. Ensure the burner ports are "open." Remove any carbon deposits from the under side of the logs using a vacuum cleaner, or a soft bristled brush (i.e. paint brush).

NOTE: Improper positioning of logs can create carbon build-up and will alter the performance of the appliance.

Replacing Logs

If the logs become damaged by accident or improper handling and need replacement, use only the proper replacement logs from manufacturer (see *Page 43* for ordering information).

Reinstall Embers, Volcanic Stone and

Carefully follow placement instructions on Pages 27 and 28. All logs should fit onto corresponding pins and/or log stoppers. This will ensure a proper flame and safe combustion.

NOTE: If installing the Contemporary Burner/ Floor Kit. skip this step and instead refer to the instructions provided with the kit.

Inspect Wiring

Refer to wiring diagrams on Page 43.

CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.

Low Battery Power Detection

The life span of the remote control system batteries depends on these factors:

- the quality of the batteries used
- the number of appliance ignitions

When the batteries are low, the receiver will emit two (2) "beeps" (low battery alert) every time it receives a command from the transmitter.

After the batteries are replaced it will emit one (1) "beep" when a command is sent by pressing any key on the transmitter. See "Initialization of The System" located in the Installation Instructions.

Inspect Burner Flame and Pilot Flame Appearance

Periodically do a visual check of the burner flame and the pilot flame. Ensure that the burner flame appearance resembles the flame shown in Figures 71 and 72 on Page 41 and as described in Flame Appearance and Sooting on Page 41. Refer to Figure 73 on Page 42 for more information about the pilot flame appearance. Contact a qualified service technician at once if any abnormal condition is observed.

Small Area Paint Touch-up

Only use a factory supplied paint kit for touchups. Paint is available at your local Innovative Hearth Products dealer. Never attempt to paint a hot fireplace.

Do not attempt to repaint the appliance until the finish is completely cured (see Burn-In Period on Page 37). If the surface later becomes stained or marred, it can be lightly sanded and touched up with spray paint (see Page 44).

FRONT GLASS ENCLOSURE PANEL, REMOVAL AND INSTALLATION

M WARNING

- When reinstalling the glass door, the door latch screws must be securely tightened to prevent the glass door from falling out, which could potentially cause damage and possible injury.
- Do not attempt to substitute the materials used on this door, or replace cracked or broken glass.
- Handle this glass with extreme care! Glass is susceptible to damage Do not scratch or handle roughly while reinstalling the glass door frame.
- The glass door of this appliance must only be replaced as a complete unit as provided by the manufacturer. Do not attempt to replace broken, cracked or chipped glass separately.
- Do not attempt to touch the front enclosure glass with your hands while the fireplace is in use.

Barrier (see Notice, Page 28)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

To remove barrier follow these steps.

- 1.Lift barrier up by the frame at the top.
- 2.Remove lower filler piece by pulling down off of the barrier.
- 3.Lower barrier and push barrier to left to release right side.
- 4. Pull the right side out of fireplace.
- 5.Remove barrier.
- 6. Install the new, approved factory barrier with flat side of barrier toward firebox.

To install the front glass door assembly, proceed as follows:

- 1. Retrieve the glass door assembly. Visually inspect the gasket on the backside of the panel. The gasket surface must be clean, free of irregularities and seated firmly.
- 2. Position the door frame in front of the firebox opening and engage the bottom flange over the rail at the bottom of the firebox opening.
- Swing the door up and back. Ensure the gasket seats evenly as the door draws shut. Engage the nut insert and fasten with two screws to secure the door.
- 4. Install the door modesty shield on top flange glass door as follows: grab the door modesty shield with both hands, with the open hem going down and engage it with the upper lip of the glass door frame by pushing it all the way down. Make sure the installed shield is firmly in place.
- 5. With the firescreen hanging on the screen rod, drop in the right side of the rod to the right modesty panel. Then drop in the left side of the rod through the slot of the left modesty panel. Make sure that the rod is supported by the bracket in the center of the fireplace.




Figure 62—Glass Door Assembly Removal/Installation

BURNER ADJUSTMENTS (QUALIFIED TECHNICIANS ONLY)

Flame Appearance and Sooting

Proper flame appearance is a flame which is blue at the base and becomes yellowish-orange in the body of the flame.

When the appliance is first lit, the entire flame may be blue and will gradually turn yellowish-orange during the first 15 minutes of operation. If the flame remains blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the logs, appliance inside surfaces and on exterior surfaces adjacent to the vent termination.

Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellowish-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

Figure 71—Burner Flame Appearance




Figure 72—Burner Flame Appearance



Soot will be produced if the air shutter is closed too much. Any damage due to carboning resulting from improperly setting the air shutter is not covered under the warranty.

To adjust the flame, rotate the air shutter toward the back or toward the front of the fireplace. Position the air shutter to the factory setting as shown in *Figure 73*. Allow the burner to operate for at least 15 minutes. Observe the flame. If it appears weak or sooty as previously described, adjust the air shutter until the flame appearance is as desired.

Use the remote to adjust the flame height as desired.

Propane models may exhibit a flame pattern that may "candle" or appear stringy. If this is problematic or persists as the appliance is continually operated, close the air shutter, as described here. Operate the appliance for a period of time as the effect diminishes, ensuring that the appliance does not develop sooty flames. When satisfied that the appliance operates properly, proceed to finish the installation.





THE WARRANTY

Innovative Hearth Products ("IHP") Limited Lifetime Warranty warrants your Astria® brand gas fireplace ("Product") to be free from defects in materials and workmanship at the time of manufacture. The product body, firebox and barrier carry the Limited Lifetime Warranty. Ceramic glass carries the Limited Lifetime Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the Limited Lifetime Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this Limited Lifetime Warranty as described herein.

COVERAGE COMMENCEMENT DATE

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

This Limited Lifetime Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The product body, firebox and barrier carry the Limited Lifetime Warranty from the date of installation. Vent components, trim components and paint are excluded from this Limited Lifetime Warranty. The following do not carry the Limited Lifetime Warranty but are warranted as follows:

Burner - Repair or replacement for five years from the date of installation

Gas components & electrical components – Repair or replacement for one year from the date of installation

Gaskets – Repair or replacement for one year from the date of installation

Gold & nickel plating - Replacement for two years from date of installation. Excludes tarnishing

Labor coverage – Prevailing IHP labor rates apply for the warranty period of the component

Light bulbs & batteries – Replacement for 90 days from the date of installation

Logs – Replacement for five years from the date of installation against thermal breakage only

Optional blowers & remote controls – Repair or replacement for one year from the date of installation
Optional glass doors & optional glass accessories – Repair or replacement for 90 days from the date of installation

Optional surrounds - Stone/Natural Materials: Replacement for one year against cracking or breakage due to thermal stress. Other Materials: Replacement for one year. Excludes surface and hairline cracks and scratches or slight color changes that do not affect the operation or safety of the unit

Tempered Glass -Replacement for one year from the date of installation

Parts not otherwise listed carry a 90 day warranty from the date of installation.

Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

To receive the benefits and advantages described in this Limited Lifetime Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.

Contact IHP at the address provided herein to obtain a listing of approved dealers/distributors. IHP shall in no event be responsible for any warranty work done by a contractor that is not approved without first obtaining IHP's prior written consent.

HOW TO REGISTER A CLAIM AGAINST WARRANTY

In order for any claim under this warranty to be valid, you must contact the IHP dealer/distributor from which you purchased the product. If you cannot locate the dealer/ distributor, then you must notify IHP in writing. IHP must be notified of the claimed defect in writing within 90 days of the date of failure.
