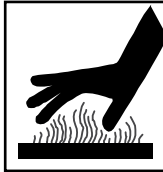

## IMPORTANT SAFETY INFORMATION

### Important Safety Information

1. **WARNING:** Do not operate appliance with the glass front removed, cracked, or broken.
2. Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.
3. Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.
4. Children and adults should be alerted to the hazards of high surface temperature and should stay away to avoid burns or clothing ignition.
5. Clothing or other flammable material should not be placed on or near the appliance.
6. Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children, and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at-risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children, and other at-risk individuals out of the room and away from hot surfaces.
7. Any safety screen, guard or barrier removed for servicing an appliance must be replaced prior to operating the appliance.
8. Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, et cetera. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean. See maintenance instructions on *Page 48*.

### L'information de sûreté importante

1. **AVERTISSEMENT.** Ne pas utiliser l'appareil si le panneau frontal en verre n'est pas en place, est craqué ou brisé.

Il est recommandé d'installer une barrière physique si des personnes à risques habitent la maison. Pour empêcher l'accès à un foyer ou à un poêle, installez une barrière de sécurité ; cette mesure empêchera les tout petits, les jeunes enfants et toute autre personne à risque d'avoir accès à la pièce et aux surfaces chaudes.
7. Tout écran ou protecteur retiré pour permettre l'entretien de l'appareil doit être remis en place avant de mettre l'appareil en marche.
8. L'installation et la réparation devrait être confiées à un technicien qualifié. L'appareil devrait faire l'objet d'une inspection par un technicien professionnel avant d'être utilisé et au moins une fois l'an par la suite. Des nettoyages plus fréquents peuvent être nécessaires si les tapis, la literie, et cetera produisent une quantité importante de poussière. Il est essentiel que les compartiments abritant les commandes, les brûleurs et les conduits de circulation d'air de l'appareil soient tenus propres. ### Información importante de seguridad

Para restringir el acceso a una chimenea o estufa, instale una puerta de seguridad ajustable para mantener a los niños pequeños, jóvenes y otras personas en riesgo fuera del cuarto y lejos de las superficies calientes.
7. Cualquier malla o resguardo de seguridad quitado para dar servicio a un artefacto, debe reinstalarse antes de operar el artefacto.

### **Vented Gas Fireplace Heater — Not for Use with Solid Fuel**

These vented gas fireplace heaters are sealed combustion, air-circulating gas fireplaces designed for residential, manufactured home, and commercial applications. Direct-vent appliances operate with the combustion chamber isolated from the indoor environment. All air for combustion is brought in from the outside, and exhaust gases are vented through the same direct-vent, coaxial (intake/exhaust) vent system. These fireplaces must be installed with IHP 6DVL Direct Vent Pipe components and terminations.

This fireplace must be installed by a qualified (certified or licensed) service person. If the glass door assembly and venting pipe are not properly seated, connected and sealed, carbon monoxide leakage (spillage) can occur.

**! DANGER****Carbon monoxide poisoning may lead to death!**

**Carbon Monoxide Poisoning:** Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness or nausea. If you have these signs, the fireplace may not be working properly. **Get fresh air at once!** Have fireplace serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol and those at high altitudes.

**Natural and Propane/LP Gas:** Natural gas is odorless, although it has an odor-making agent added to the gas. Propane/LP gas has a natural odor. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists. Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this fireplace.

**! WARNING**

**Any change to this fireplace or its controls can be dangerous. Do not modify this fireplace under any circumstances. Any parts removed for servicing must be replaced prior to operating fireplace.**

**! WARNING**

**Do not use a blower insert, heat exchanger insert or other accessory not approved for use with this fireplace.**

**! WARNING**

**This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases unless a certified kit is used.**

**! WARNING**

**Do not allow fans to blow directly into the fireplace. Avoid any drafts that alter burner flame patterns.**

**Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.**

**Do not place clothing or other flammable material on or near the appliance. Never place any objects on the appliance.**

**Do not use this fireplace to cook food or burn paper or other flammable material.**

**This fireplace reaches high temperatures. Keep children and adults away from hot surface to avoid burns or clothing ignition. Fireplace will remain hot for a time after shutdown. Allow surface to cool before touching.**

**Carefully supervise young children when they are in the room with fireplace.**

**Keep the area around your fireplace clear of combustible materials, gasoline and other flammable vapor or liquids. Do not run fireplace where these are used or stored.**

1. For propane/LP fireplace, do not place propane/LP supply tank(s) inside any structure. Locate propane/LP supply tank(s) outdoors. To prevent performance problems, do not use propane/LP fuel tank of less than 100 lb. capacity.
2. If you smell gas
  - shut off gas supply
  - do not try to light any appliance
  - do not touch any electrical switch; do not use any phone in your building
  - leave the building immediately
  - immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions
  - if you cannot reach your gas supplier, call the fire department.
3. Never install the fireplace
  - in a recreational vehicle
  - in windy or drafty areas where curtains or other combustible (flammable) objects can make contact with the fireplace front
  - in high traffic areas
4. Turn fireplace off and let cool before servicing, installing or repairing. Only a qualified service person should install, service or repair this fireplace. Have fireplace inspected annually by a qualified service person.
5. You must keep control compartments, burners and circulating air passages clean. More frequent cleaning may be needed due to excessive lint and dust from carpeting, bedding material, etc. Turn off the gas valve and pilot light before cleaning fireplace.
6. Have fireplace and venting system inspected annually by a qualified service person. If needed, have venting system cleaned or repaired. See *Cleaning and Maintenance, Page 48*.
7. Do not use any solid fuels (wood, coal, paper, cardboard, etc.) in this fireplace. Use only the gas type indicated on fireplace nameplate.
8. This appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70 or Canadian Electrical Code, CSA C22.1.
9. Do not use fireplace if any part has been exposed to or under water. Immediately call a qualified service person to arrange for replacement of the unit.
10. Do not operate fireplace with glass door removed, cracked or broken.
11. Provide adequate clearances around air openings.
12. This vented gas fireplace heater is not for use with air filters.

Install and use fireplace with care. Follow all local codes. In the absence to local codes, use the current National Fuel Gas Code ANSI Z223.1/NFPA 54\* (USA) or the current CAN/CGA B149.1 Installation Code (Canada).

### Codes and Standards

**Listing:** These fireplaces comply with National Safety Standards and are tested and listed by PFS TECO (Report No. F18-195) to ANSI Z21.88-2017 / CSA-2.33-2017, and CSA 2.17-2017 in both USA and Canada, as vented gas fireplace heaters.

These appliances comply with CSA P.4.1:24 "Testing Method for Measuring Annual Fireplace Efficiency. P4 (EnerGuide) is a measurement of the Canadian Office of Energy Efficiency.

These fireplaces are listed for installation in bedrooms, aftermarket mobile homes, and manufactured homes.

The installation must conform to local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54—latest edition, or the Natural Gas and Propane Installation Code, CSA B149.1.

The fireplace, when installed, must be electrically grounded and wired in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70—latest edition, or the Canadian Electrical Code, CSA C22.1—latest edition.

## PRODUCT FEATURES

These are a few facts that can help you understand and enjoy your direct vent fireplace:

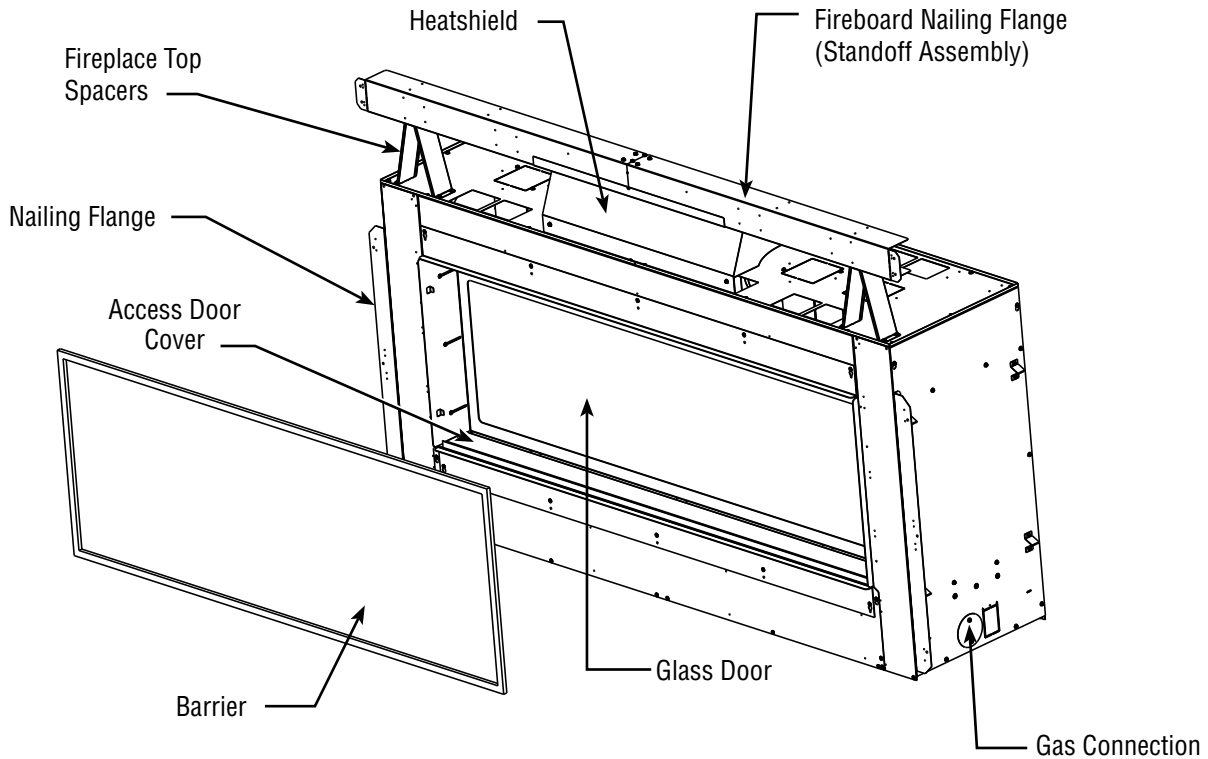
- The venting system may be routed to the outside of your home in several ways. It may vent through the roof (vertical) or it may vent to an outside/exterior wall (horizontal). The vent pipe installation is very important to allow for proper operation. You must follow the venting instructions very carefully for either vertical or horizontal applications.
- This fireplace may be installed in any room of your house provided all local codes and these installation instructions are followed.
- Each time you turn on your fireplace, you may notice some amount of condensation on the inside of the fireplace glass. This is normal and will disappear after 10-20 minutes of operation.
- Your direct vent fireplace system (fireplace and venting) is a balanced and sealed combustion system. It requires approximately 10-20 minutes of operating time before the flame pattern stabilizes.

### REQUIREMENTS FOR THE COMMONWEALTH OF MASSACHUSETTS

These appliances are approved for installation in the U.S. state of Massachusetts if the following additional requirements are met:

- Install this fireplace in accordance with Massachusetts Rules and Regulations 248 C.M.R. 4.00 through 8.00.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36" (914 mm) in length.
- The individual manual shutoff must be a T-handle type valve.

#### Massachusetts Horizontal Vent Requirements

In the Commonwealth of Massachusetts, horizontal terminations installed less than seven (7) ft above the finished grade must comply with the following additional requirements:

- A hard wired carbon monoxide detector with an alarm and battery back-up must be installed on the floor level where the gas fireplace is installed. The carbon monoxide detector must comply with NFPA 720, be ANSI/UL 2034 listed and be CSA certified.
- A metal or plastic identification plate must be permanently mounted to the exterior of the building at a minimum height of eight (8) ft above grade and be directly in line with the horizontal termination. The sign must read, in print size no less than one-half (1/2) inch in size, GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS.

### COLD CLIMATE INSULATION

For cold climate installations, seal all cracks around your fireplace with noncombustible material and wherever cold air could enter the room. It is especially important to insulate outside chase cavity between studs and under floor on which fireplace rests, if floor is above ground level. Gas line holes and other openings should be caulked or stuffed with unfaced fiberglass insulation. Caulk the firestop only where the pipe penetrates an outside wall, attic, or other unconditioned space.

**NOTE:** *Caulking used must have a minimum of 300°F continuous exposure rating.*

**NOTE:** *Do not use loose, or blown-in insulation in the cavity surrounding the fireplace.*

If the fireplace is being installed on a cement slab in cold climates, a sheet of plywood or other raised platform can be placed underneath to prevent conduction of cold transferring to the fireplace and into the room. It also helps to sheetrock inside surfaces and tape for maximum air tightness and caulk firestops.

## HIGH ALTITUDE REQUIREMENTS

### Orifice Sizes—Sea Level to High Altitude

These fireplaces are tested and approved for installation at elevations of 0–4500 ft (0–1372 m) above sea level using the standard burner orifice sizes (*see specifications table, Page 53*). For elevations above 4500 ft, contact your gas supplier or qualified service technician.

### Deration

At elevations above 4500 ft, the amount of BTU fuel value delivered must be reduced by either:

- Using gas that has been derated by the gas company.
- Changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1—latest edition or, in Canada, the CAN/CGA-B149.1 codes—latest edition.

IN CANADA - CSA 2.17-2017 (HIGH ALTITUDE):

The conversion shall be carried out by a manufacturer's authorized representative, in accordance with the requirements of the manufacturer, provincial or territorial authorities having jurisdiction and in accordance with the requirements of the CAN/CGA-B149.1 or CAN/CGA-B149.2 Installation codes.

## MANUFACTURED HOME REQUIREMENTS

This appliance may be installed in an aftermarket, permanently located, manufactured home (USA only) or mobile home, where not prohibited by local codes.

This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases, unless a certified kit is used.

### ⚠ CAUTION

Ensure that the cross members are not cut or weakened during installation. The structural integrity of the manufactured home floor, wall, and ceiling / roof must be maintained.

### ⚠ CAUTION

This appliance must be grounded to the chassis of the manufactured home in accordance with local codes or in the absence of local codes, with the National Electrical Code ANSI / NFPA 70—latest edition or the Canadian Electrical Code CSA C22.1—latest edition.

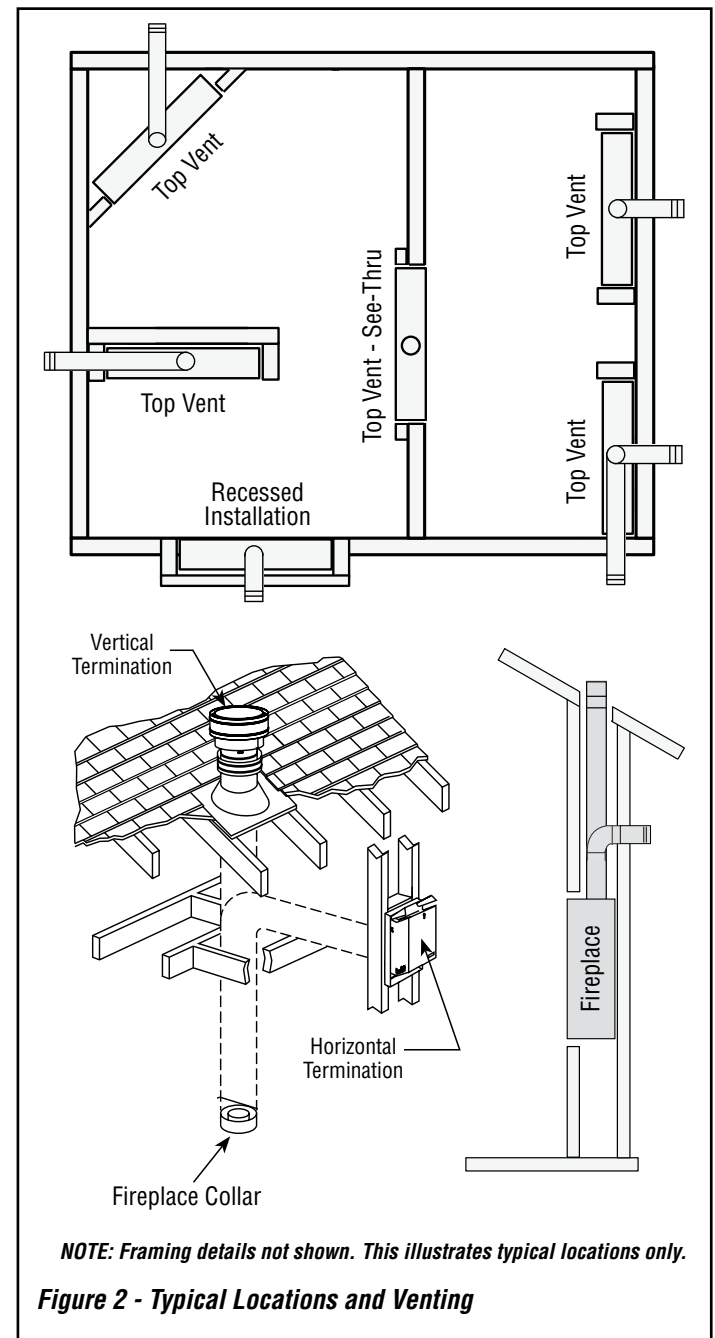
## TYPICAL LOCATIONS

In selecting the location, the aesthetic and functional use of the fireplace are primary concerns. However, vent system routing to the exterior and access to the fuel supply are also important. The fireplace may be located on or near conventional construction materials. See **Location and Space requirements Page 11** for more information.

**Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.**

The location should also be free of electrical, plumbing or other heating/air conditioning ducting.

**Be aware that this is a heat producing fireplace. Objects placed above the unit are exposed to elevated temperatures. Do not insulate the space between the fireplace and the area above it.**



## PRE-INSTALLATION

### LOCATION AND SPACE REQUIREMENTS

Determine the safest and most efficient location for your direct vent fireplace. Make sure that rafters and wall studs are not in the way of the venting system. Choose a location where the heat output is not affected by drafts, air conditioning ducts, windows or doors. Be aware of all restrictions and precautions before deciding the exact location for your fireplace and termination cap.

When deciding the location of your fireplace, follow these rules:

- Do not connect this fireplace venting to a chimney flue serving a separate solid-fuel burning fireplace or appliance.
- Due to high temperatures, do not locate this fireplace in high traffic areas, windy or drafty areas or near furniture or draperies.
- Proper clearances must be maintained.
- If your fireplace is to be installed directly on carpeting, vinyl tile or any combustible material other than wood, it must be installed on a metal or wood panel extending the full width and depth of the fireplace (*see Figure 11, Page 16*).
- Standoff spacers attached to your fireplace can be placed directly against the wall or framing material. See framing details, *Pages 12-15*.
- When locating the termination cap, it is important to observe the minimum clearances shown in *Table 2, Page 17*.
- Do not recess the termination cap into a wall or siding.
- You may paint the termination cap with high temperature heat-resistant paint to coordinate with the exterior finish.
- There must not be any obstruction such as bushes, garden sheds, fences, decks or utility buildings within 24" from the front of the termination cap and the front of outside air vent.
- Do not locate the termination cap and outside air vent where excessive snow or ice build up may occur. Be sure to clear vent termination area after snow falls to prevent accidental blockage of venting system. When using snow blowers, do not direct snow towards vent termination area.

### CLEARANCES

Minimum clearances to combustibles for the fireplace are as follows:

Do not pack with insulation or other materials around the fireplace.

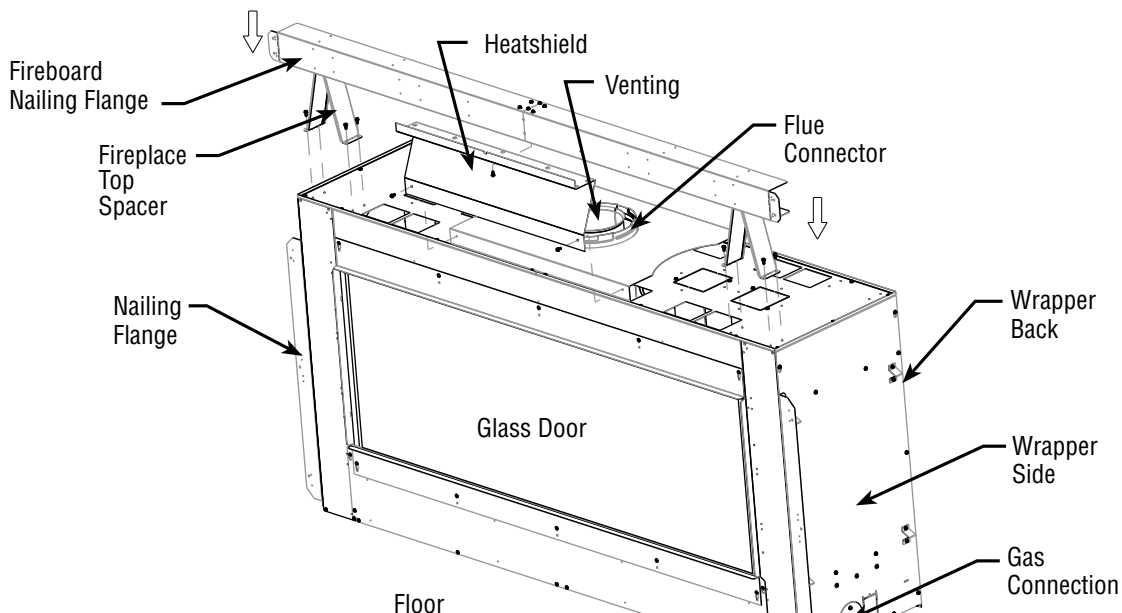
### NOTICE

**This fireplace is intended for use as supplemental heat. Use this fireplace along with your primary heating system. Do not install this fireplace as your primary heat source. If you have a central heating system, you may run system's circulating blower while using fireplace. This will help circulate the heat throughout the house**

### IMPORTANT! TOP STANDOFF AND HEATSHIELD SUB-ASSEMBLY MUST BE INSTALLED PRIOR TO APPLIANCE INSTALLATION!

1. Identify top standoff sub-assembly and heat shield packaged on top of appliance during shipping.
2. Using screws provided, attach assembly to forward portion of appliance top as shown in *Figure 3*.

**NOTE: If appliance is being upgraded to a See-Thru application, install second top standoff sub-assembly and heat shield to the rear portion of appliance top as supplied with and shown in the See-Thru kit instructions.**

## FRAMING AND FINISHING

**IMPORTANT!** Before you begin framing, determine whether you will be installing the fireplace as a one-sided application or See-Thru application, with or without a HeatFlo Kit (see *Accessories, Page 58*). Follow instructions included with applicable kits and appropriate framing dimensions in this manual.

The fireplace will come factory installed as a one sided appliance. If you will be using the fireplace for a one sided regular application, you can install it as is. If you will be upgrading the fireplace to a See-Thru application a conversion kit is required (see *Accessories, Page 58*). Follow instructions included with the Kit.

**NOTE:** The optional Blower Kit is not compatible with the See-Thru Kit. If the Blower Kit is installed, it must be removed or disabled when a See-Thru Kit is installed.

### ONE SIDED / SEE-THRU INSTALLATION

#### Fireplace Framing

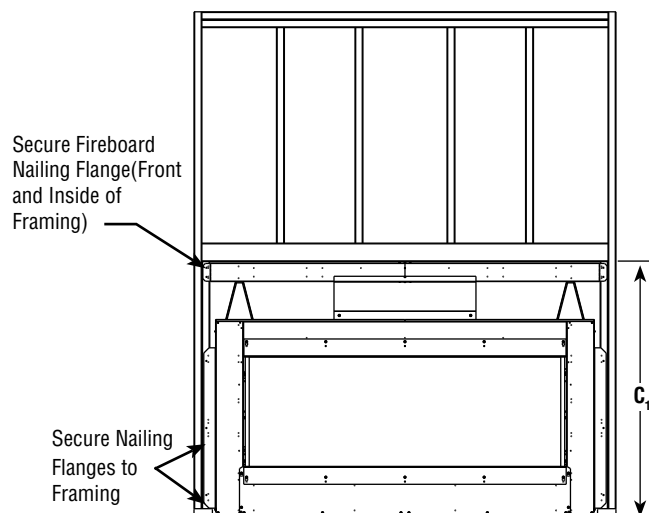
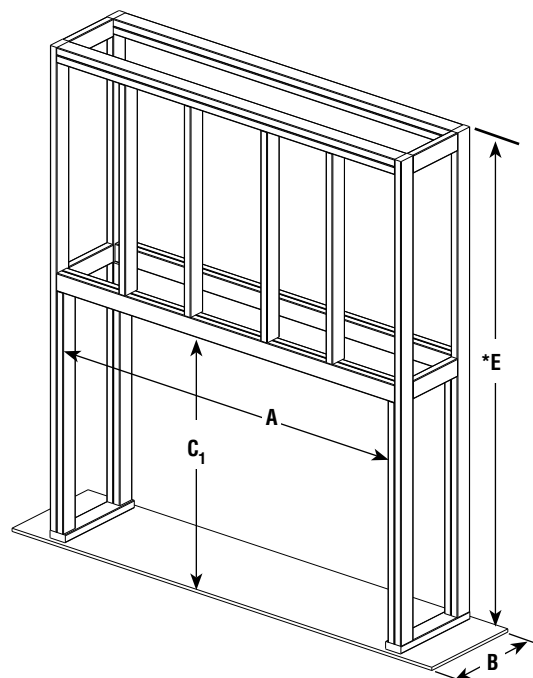
1. Frame the fireplace as illustrated in **Figures 4-9, Pages 12-15**. All framing details must allow for a minimum clearances to combustible framing members as shown in **Table 1, Page 11**.
2. Mount the fireplace on the floor or on a fully supported base extending the full width and depth of the unit. If installed over combustible materials, such as carpeting, vinyl tile, or combustible material other than wood flooring, the appliance must be installed on a metal or wood panel extending the full width and depth of the fireplace.
3. Headers may be in direct contact with the top of the nailing flange, maintaining the 11" clearance to the fireplace top, but must not be supported by them or notched to fit around them after self supporting (see **Figure 4**). All construction above the fireplace must be self-supporting. DO NOT use the fireplace for structural support.
4. All minimum clearances must be met. Vent pipe needs to maintain 1" clearance. Wood studs may be notched. Fireboard is provided for facing around the fireplace.
5. If you are using a separate combustible mantel piece, refer to **Figure 40, Page 34** for proper installation height.

**NOTE:** Fireplace is designed for 1/2" thickness of non-combustible fireboard on the face of the unit (Included with one sided application). If installing a two sided application, the non-combustible fireboard will be included with the See-Thru kit, see accessories Page 58).

## INSTALLING TELEVISION (TV) ABOVE FIREPLACE

The following section details two options for installing a television (TV) above Fireplace

### IMPORTANT NOTICE

**Most television manufacturers instruct the homeowner to not place the television above a heat source. Doing so may negatively affect the longevity of the television and may negate the warranty. If you do place a television above the fireplace, please be aware of the large amount of heat generated by the fireplace and consider placing the television above the fireplace at 12" minimum on a flush wall and at 18" for a recessed installation, to reduce the amount of heat that reaches the television. The homeowner must understand that IHP does not take responsibility for any negative impact to televisions placed near this fireplace.**

TVs should not be used in situations where the actual TV temperature exceeds the manufacturer's technical specification. Contact the TV manufacturer directly if you cannot locate this information or have questions regarding this information.

***NOTE: Clearances to TV are provided only for guidance, please follow TV manufacturer's recommendation for installation.***

### WARNING

Ensure clearances to combustibles are maintained when building a mantel or shelves above the fireplace. Elevated temperatures on the wall or in the air above the fireplace can cause melting, discoloration or damage to decorations, a television (TV) or other electronic components.

### IMPORTANT NOTE

**HeatFlo Kits allow for a recessed wall pocket above the fireplace. Follow instructions for *Fireplace Framing Dimensions for Recessed Wall Pocket*.**

**See Figures 6-9** for TVs Installed above the fireplace:

**WIRING NOTE:** If running wiring into the enclosure, use thermal insulating wrap around the wiring. Secure the wiring to protect from contact with hot surfaces.

***NOTE:*** On a recessed wall pocket installation, discard fireboard nailing flange leaving fireplace top spacers and heatshield (see **Figure 8**). Header may be in direct contact with the fireplace top spacers and heatshield maintaining the 7-1/2" clearance to the fireplace top.

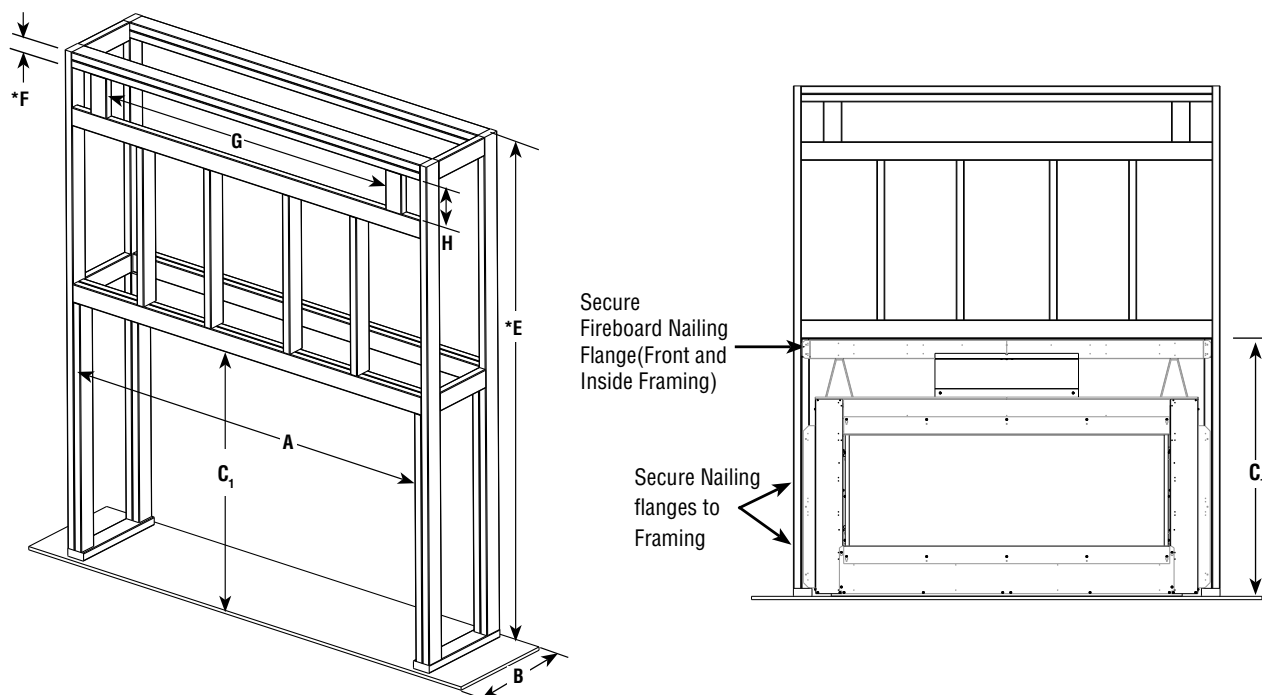

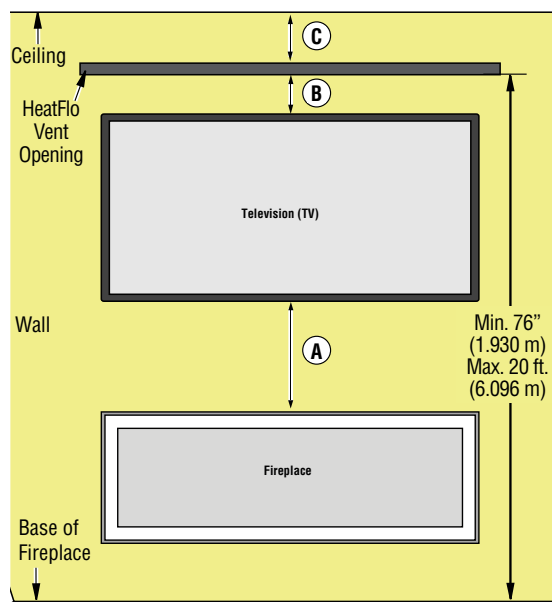

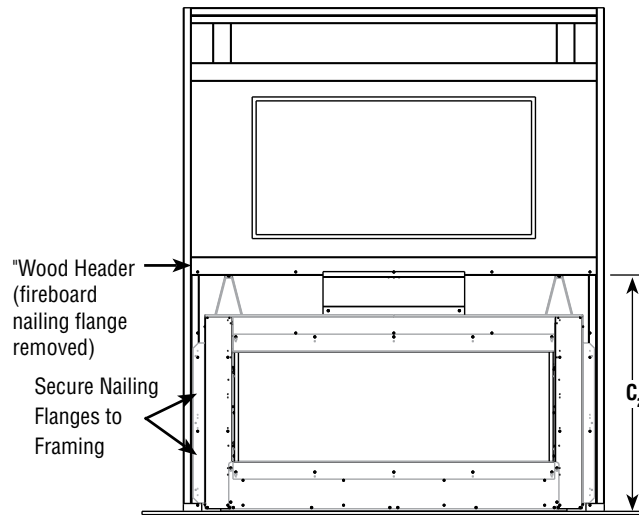

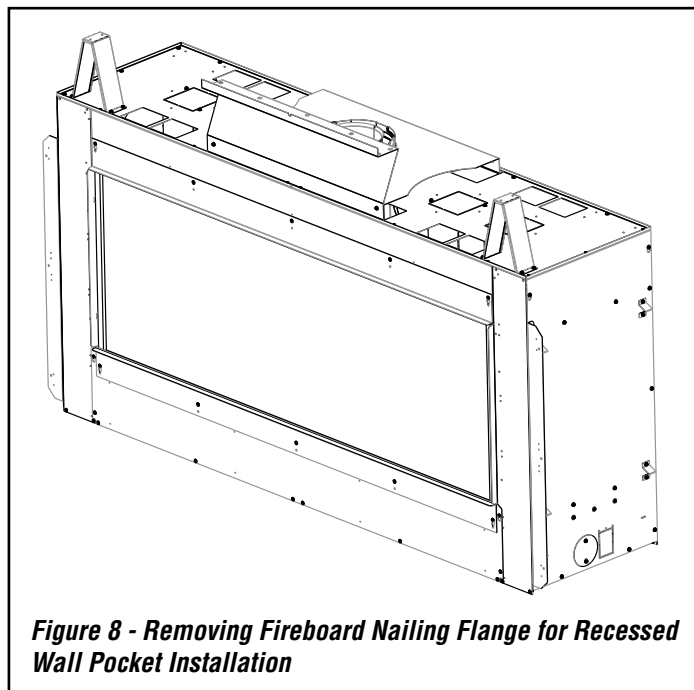

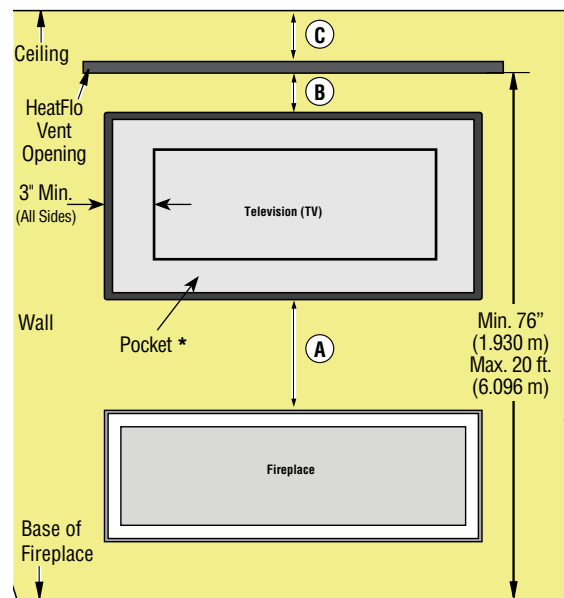

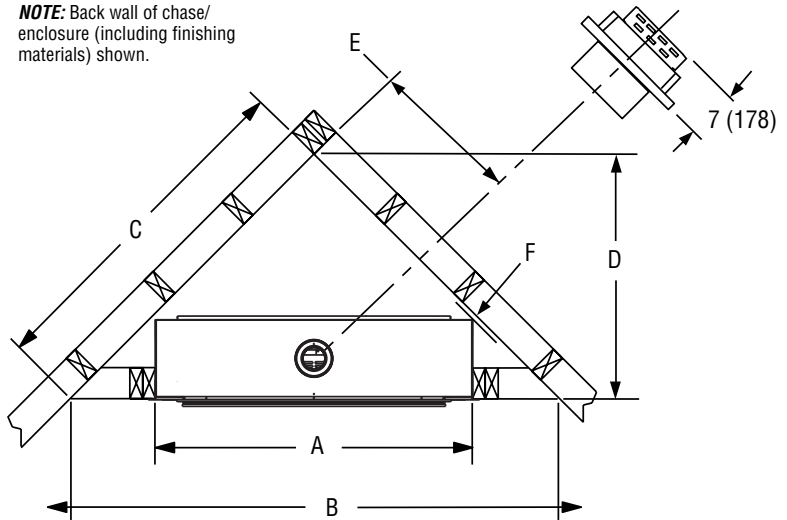
**Figure 9 - Dimensions for Television (TV) Installed Above Fireplace on a Recessed Wall Pocket**

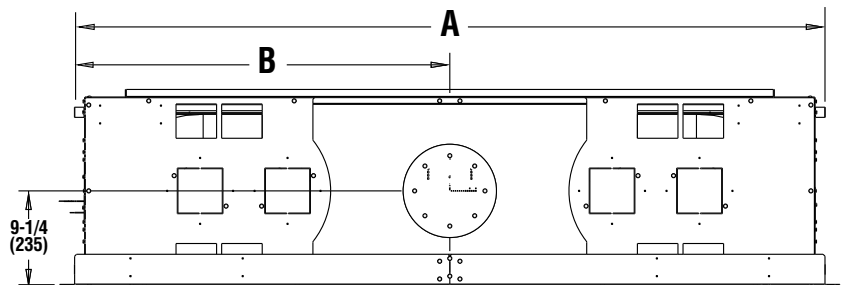

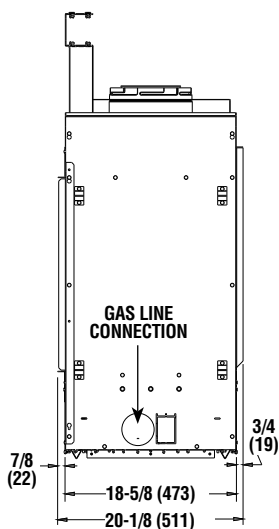
**Figure 10 - Fireplace Framing Specifications - Corner Installation with Horizontal termination**

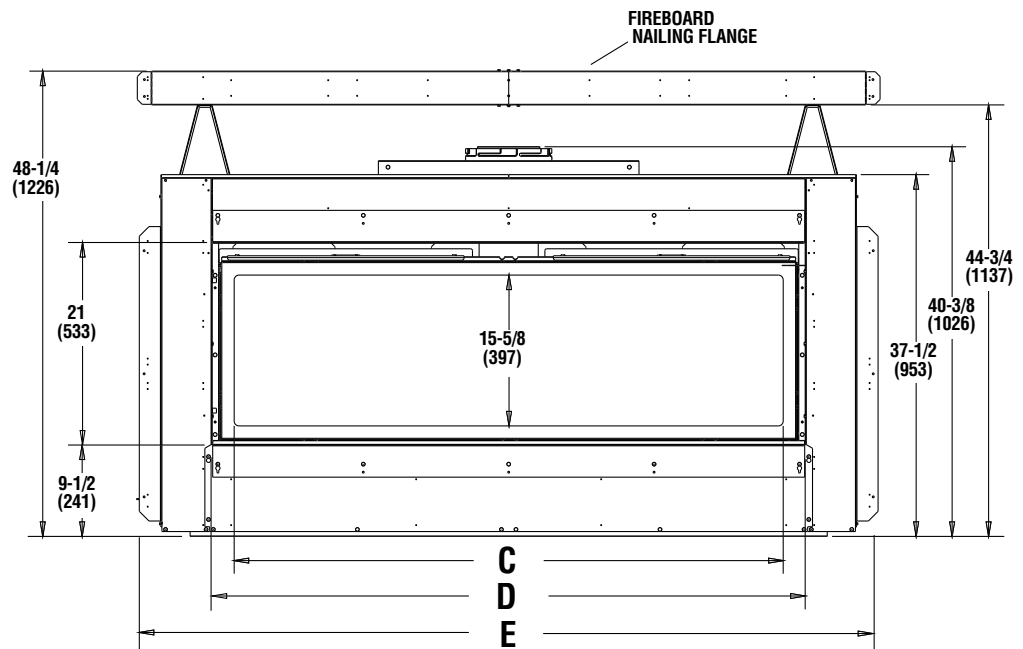

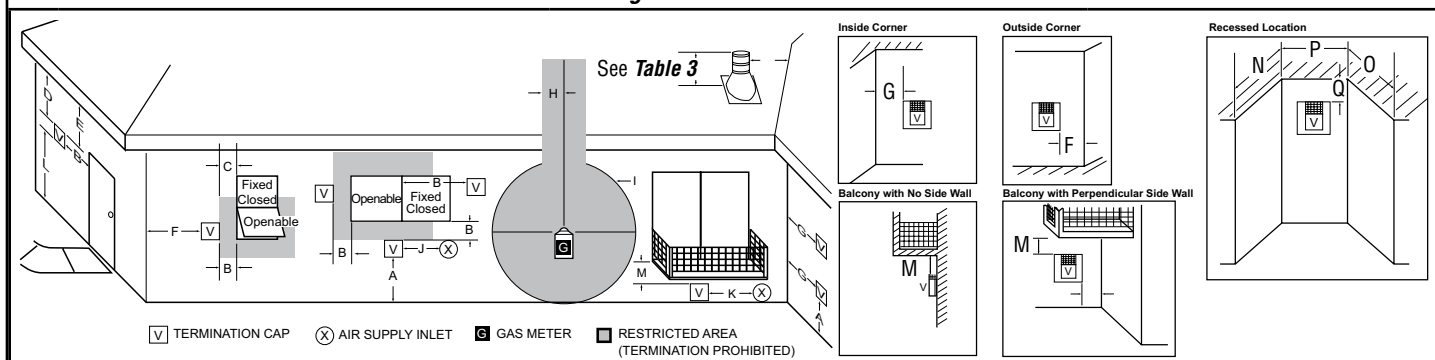

## VENTING INSTALLATION

### NOTICE

**Read these instructions completely before attempting installation.**

These fireplaces are tested and approved for use with IHP 6DVL Direct Vent Pipe components and terminations.

The venting system must terminate on the outside of the structure and can not be attached to a chimney or flue system serving a separate solid fuel or gas burning appliance. A direct vent appliance must have its own venting system. **DO NOT** common vent this appliance. These models are approved to be vented either horizontally through an outside wall or vertically through a roof or chase enclosure using the following guidelines:

- When venting system terminates horizontally on an outside wall, you may install a standoff if the termination cap is to be installed directly on a combustible finish such as vinyl, wood, stucco, etc.
- Never run the vent downward as this may cause excessive temperatures which could cause a fire.
- Vent pipe air space clearances to combustibles are 1" on all sides except on the horizontal sections, which requires 3" clearance from the top of the pipe including horizontal terminal.
- Have fireplace and selected vent components on hand to help determine the exact measurements when elbowing or offsetting. Always use wall firestops when penetrating walls and firestops when penetrating ceilings or attic spaces.

### WARNING

**Read all instructions completely and thoroughly before attempting installation. Failure to do so could result in serious injury, property damage or loss of life.**

### NOTICE

**Failure to follow these instructions will void the warranty.**

### NOTICE

**Do not seal termination cap to vent pipe. Cap must be removable for vent inspection and maintenance.**

#### INSTALLATION PRECAUTIONS

- Wear gloves and safety glasses for protection
- Use extreme caution when using ladders or when on roof tops
- Be aware of electrical wiring locations in walls and ceilings

**The following actions will void the warranty on your venting system:**

- Installation of any damaged venting component
- Unauthorized modification of the venting system (Do not cut or alter vent components)
- Installation of any component part not manufactured or approved by INNOVATIVE HEARTH PRODUCTS
- Installation other than as instructed by these instructions

### WARNING

**This gas fireplace and vent assembly must be vented directly to the outside. The venting system must NEVER be attached to a chimney serving a separate solid fuel burning appliance. Each direct vent gas appliance must use a separate vent system. Do not use common vent systems.**

### WARNING

**Vent pipe air space clearances to combustibles are 1" on all sides except on horizontal sections, which require 3" clearances from the top of the pipe including the horizontal terminal. Where the Vertical termination cap penetrates a combustible space, 1" air space clearance is required.**

#### VENT INSTALLATION PLANNING

There are two basic types of direct vent installation:

- Horizontal Termination
- Vertical Termination

##### Horizontal Termination Installation

**IMPORTANT:** Horizontal terminations require only inner portion of wall firestop.

1. Set fireplace in its desired location and determine the route your horizontal venting will take. Do not secure fireplace until all venting has been installed. Some installations require sliding fireplace in and out of position to make final venting connections. **Figures 15-16 on Page 20** show different configurations for venting with horizontal termination that will help you decide which application best suits your installation. Check to see if wall studs or roof rafters are in the path of your desired venting route. If they are, you may want to adjust location of fireplace.
2. Direct vent pipe sections and components are designed with special twist-lock connections.

**Twist-Lock Procedure:** Female ends of pipes have locking lugs (indentations). These lugs will slide straight into matching slots on male ends of adjacent pipes. Push pipe sections together and twist one section clockwise approximately one-quarter turn until sections are fully locked (see **Figure 12, Page 19**).

**NOTE:** Horizontal vent must be sloped to 1/4" per foot rise from inlet to termination. Use non-combustible hanger straps (such as plumbers tape) to support horizontal sections every 4 feet. Pipe must not sag.

3. Assemble desired combination of pipe and elbows to fireplace flue collar. If there are long portions of venting run, pre-assembled pipe sections may be installed as subassemblies for convenience.

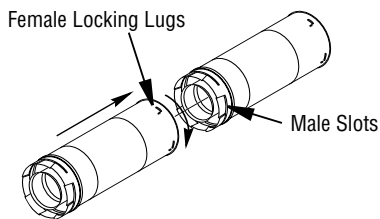

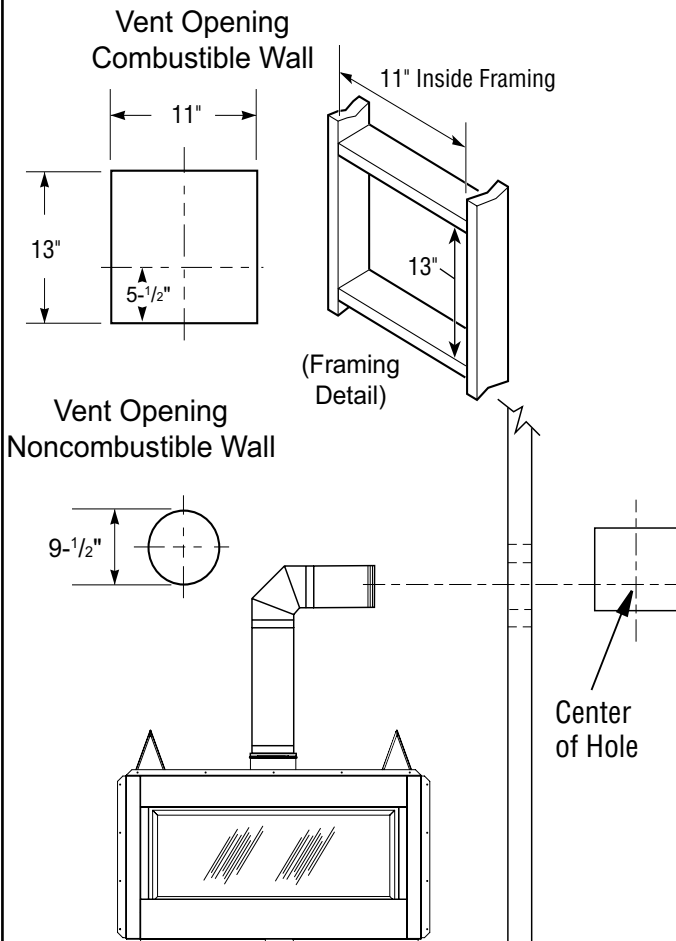

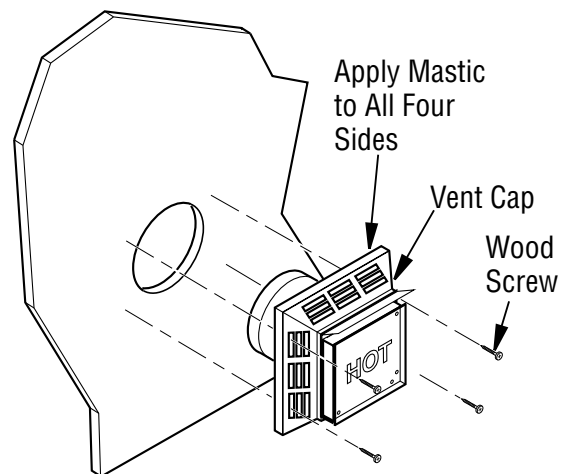
**Figure 13 - Vent Opening Requirements**

4. Carefully determine location where vent pipe assembly will penetrate outside wall. Mark center line of pipe on wall. Mark wall for a 13" x 11" square hole, where bottom of square starts 5-1/2" below center line of pipe (see **Figure 13**). This will provide the 3" minimum spacing needed on top of horizontal pipe. Cut and frame 13" x 11" rectangular hole in exterior wall where vent will be terminated. If wall being penetrated is constructed of noncombustible material, such as masonry block or concrete, a 9-1/2" hole with zero clearance is acceptable (see **Figure 13**).

### ! WARNING

**Do not recess vent termination into any wall. This will cause a fire hazard.**



**Figure 12 - Vent Pipe Connections**

5. **Noncombustible Exterior Wall:** Position horizontal vent cap in center of the 9-1/2" round hole and attach to exterior wall with four fasteners. Before attaching vent cap to exterior wall, run a bead of non-hardening mastic (pliable sealant) around outside edges to make a seal between it and outside wall.

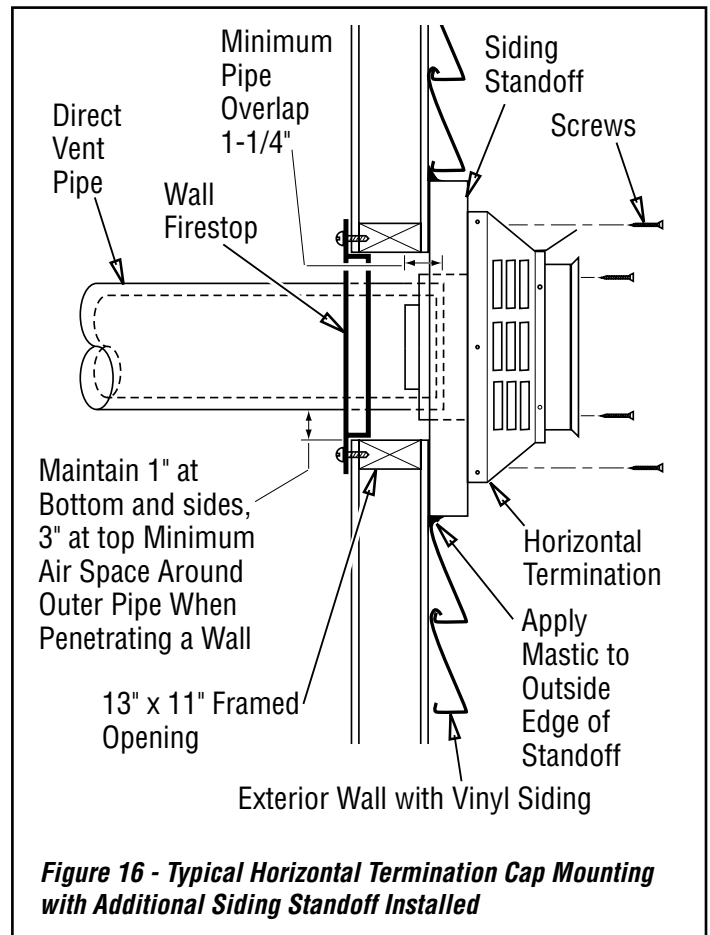
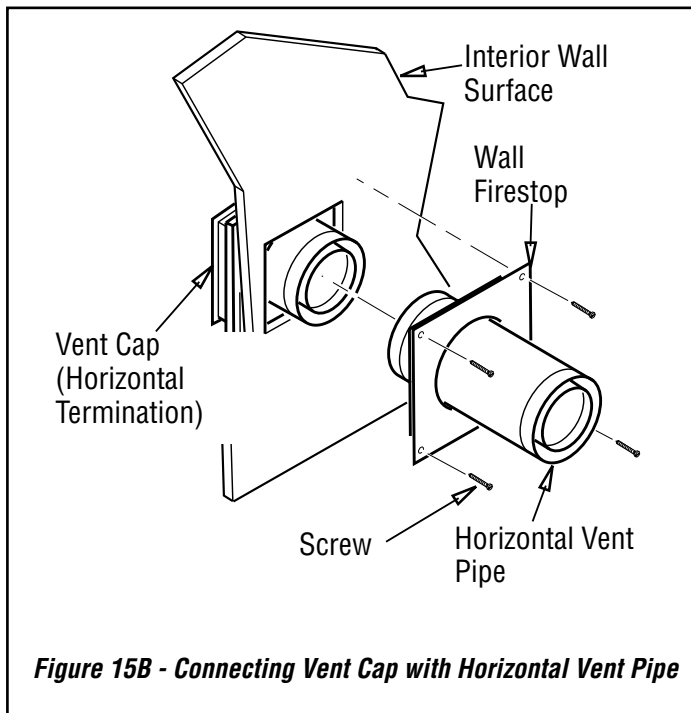
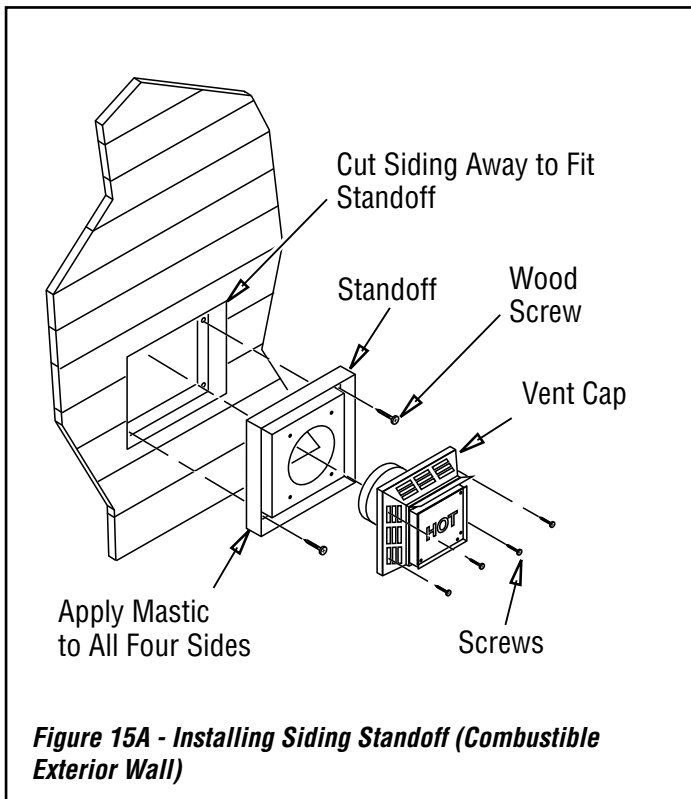


**Figure 14 - Installing Horizontal Vent Cap (Noncombustible Exterior)**

**NOTE:** Use the appropriate type fasteners for stucco, brick, concrete or other types of sidings (see **Figure 14**).

**Combustible Exterior Wall:** A combustible siding standoff is required when terminating thru combustible siding materials. For vinyl siding, stucco or wood exteriors, a siding standoff may be installed between the vent cap and the exterior wall. Siding standoff prevents excessive heat from damaging siding materials. Siding material must be cut to accommodate standoff. Fasten vent cap to standoff. Apply non-hardening mastic around outside edge of standoff. Position standoff/cap assembly over the 13" x 11" rectangular hole and attach to exterior wall with appropriate type fasteners for wall material (see **Figure 15A, Page 20**). Siding standoff must sit flush against exterior fascia material.

6. **Connecting Vent Cap with Horizontal Vent Pipe:** Slide wall firestop over vent pipe before connecting horizontal run to vent cap (see **Figure 15B, Page 20**).

Carefully move fireplace, with vent assembly attached, toward wall and insert vent pipe into horizontal termination. Pipe overlap should be a minimum of 1-1/4" (see **Figure 16, Page 20**).

Slide wall firestop against interior wall surface and attach with screws. See **Figure 16, Page 20** for horizontal termination details. Place fireplace into position and shim with noncombustible material if needed. Nail or screw side flanges to framing to secure unit in place. **IMPORTANT:** Make sure fireplace is level before securing. If fireplace is not level it will not work properly.

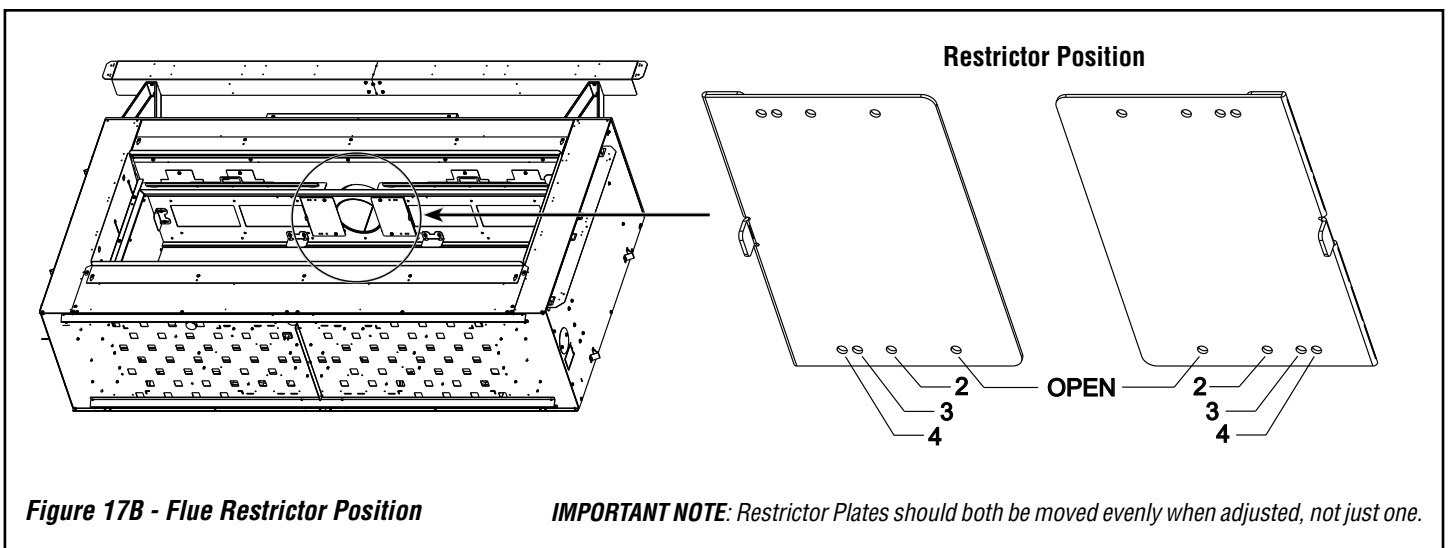
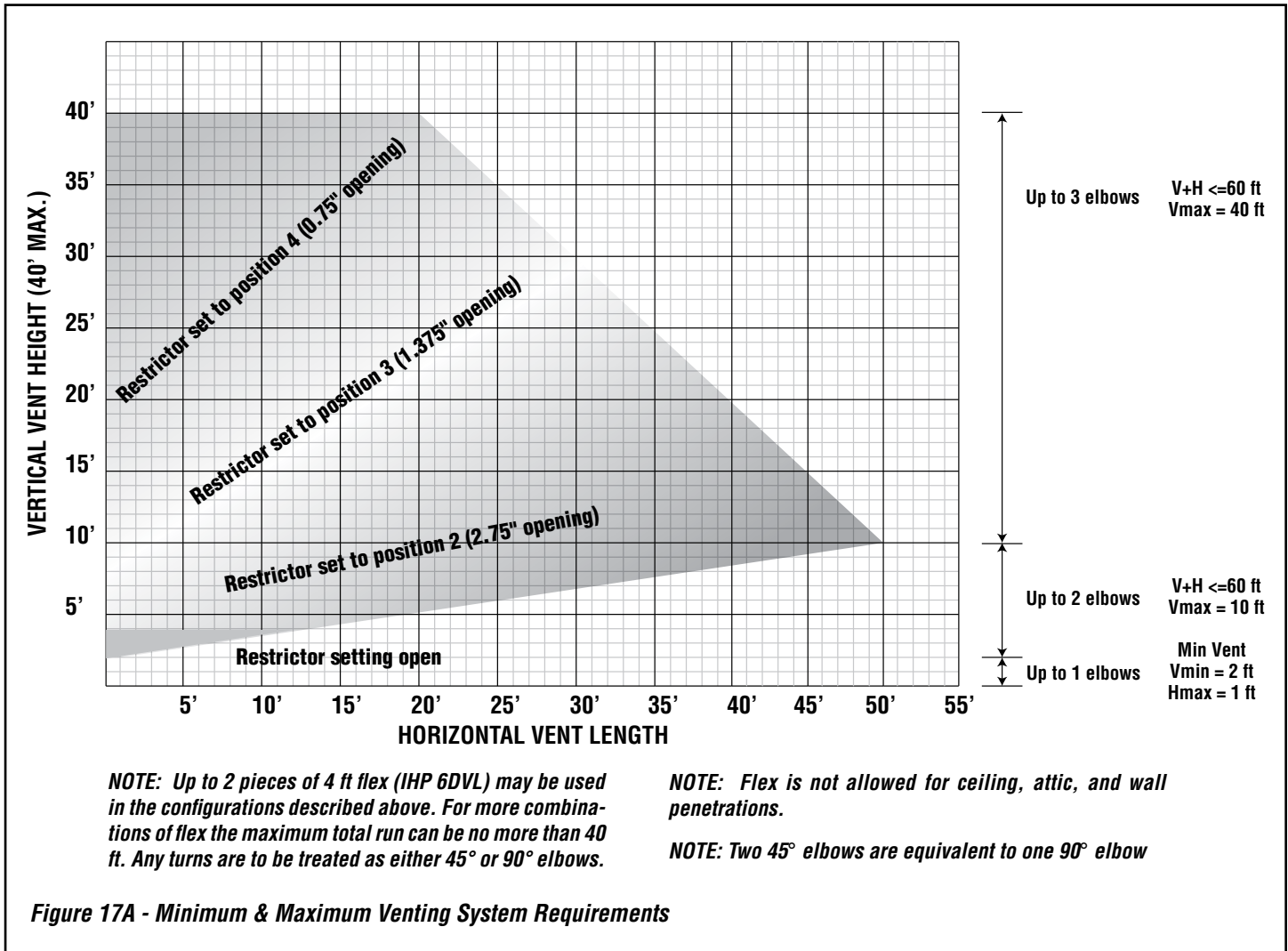
**Do not seal termination cap to vent pipe. Cap must be removable for vent inspection and maintenance.**

### ! WARNING

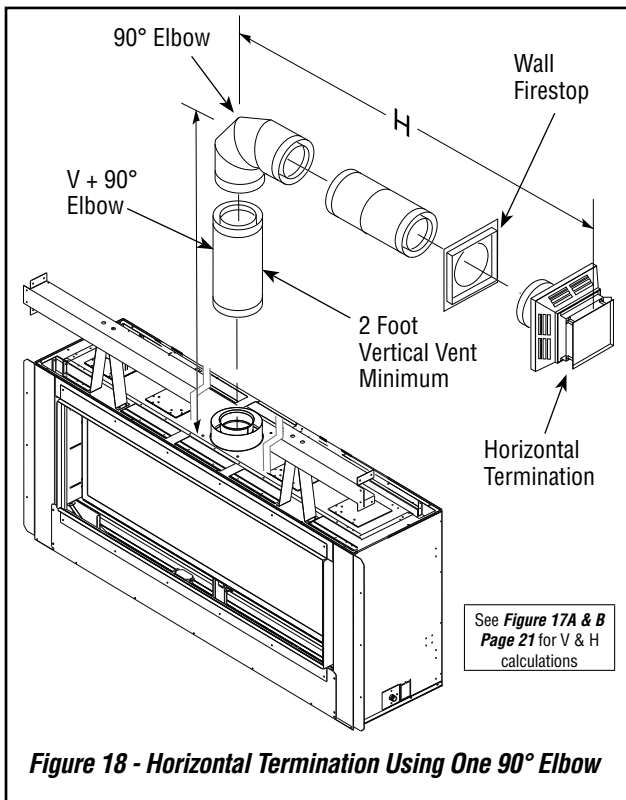
**Never run vent downward as this may cause excessive temperatures which could cause a fire. Operation of improperly installed and maintained venting system could result in serious injury, property damage or loss of life.**

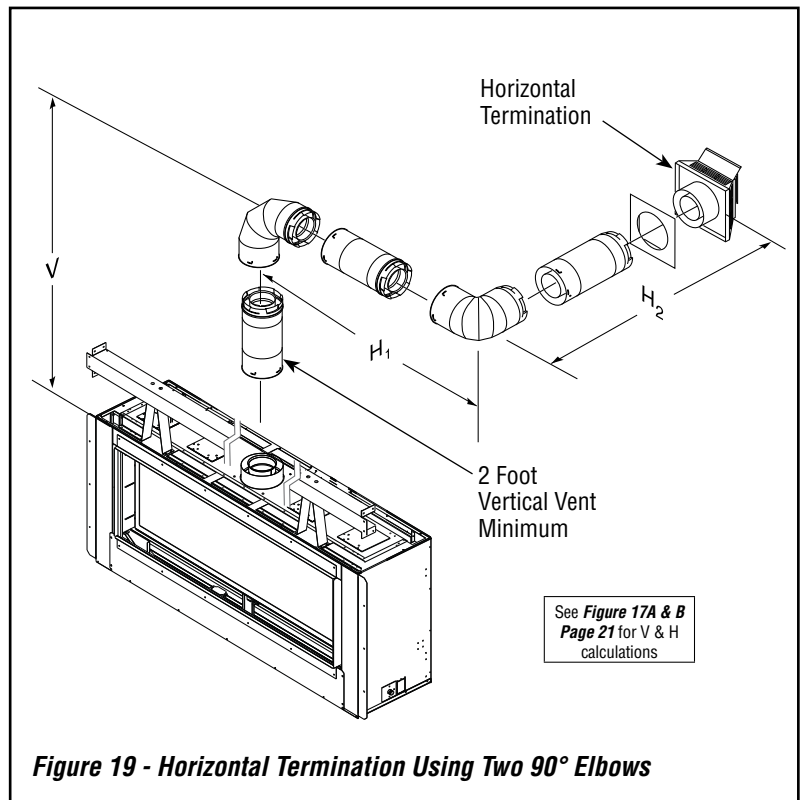
### VENT SYSTEM CONFIGURATIONS - HORIZONTAL AND VERTICAL TERMINATION



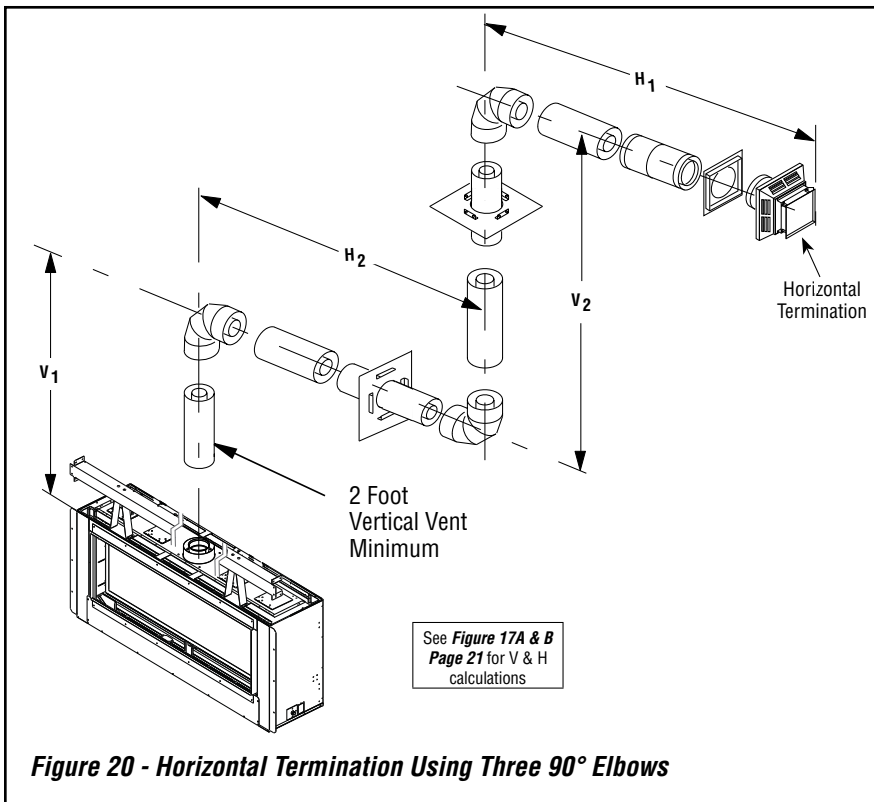

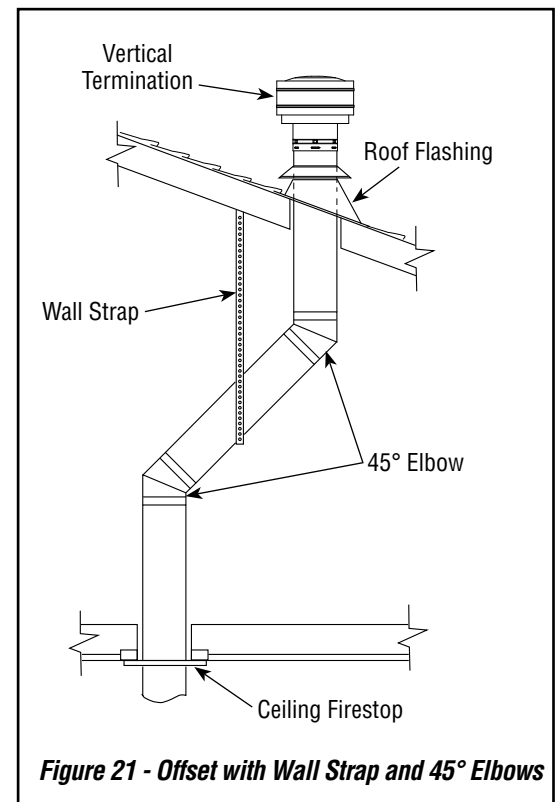
**Figure 18 - Horizontal Termination Using One 90° Elbow**

### Vertical Termination Installation.

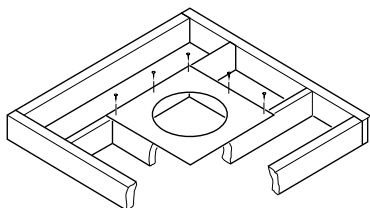
1. Determine route your vertical venting will take. If ceiling joists, roof rafters or other framing will obstruct venting system, consider an offset (see **Figure 21**) to avoid cutting load bearing members. **NOTE:** Pay special attention to these installation instructions for required clearances (air space) to combustibles when passing through ceilings, walls, roofs, enclosures, attic rafters, etc. Do not pack air spaces with insulation. Also note maximum vertical rise of venting system and any maximum horizontal offset limitations (see **Figures 17A**).
2. Set fireplace in desired location. Drop a plumb line down from ceiling to position of fireplace exit flue. Mark center point where vent will penetrate ceiling. Drill a small locating hole at this point.
3. Drop a plumb line from inside of roof to locating hole in ceiling. Mark center point where vent will penetrate roof. Drill a small locating hole at this point.

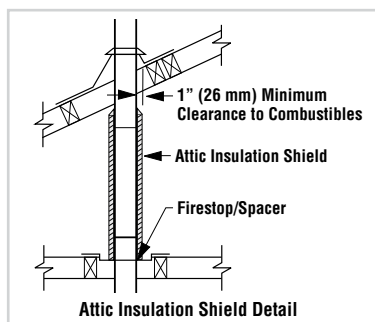
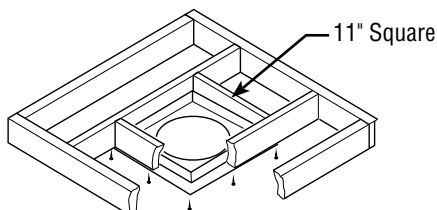
### Flat Ceiling Installation

1. Cut an 11" square hole in ceiling using locating hole as a center point. Opening should be framed to 11"x 11" inside dimensions, as shown in **Figure 22** using framing lumber the same size as ceiling joists. If area above ceiling is an insulated ceiling or an attic, nail firestop from top side. This prevents loose insulation from falling into required clearance space. If area above ceiling is a living space, install firestop below framed hole. Firestop should be installed with no less than three nails per side (*see Figure 22*).
2. Assemble desired lengths of pipe and elbows necessary to reach from fireplace flue up through firestop. Be sure all pipe and elbow connections are fully twist-locked (*see Figure 12, Page 19*).

If area above is an attic or insulated area, install firestop above framed hole.



If area above is a living space, install firestop below framed hole.



**NOTE:** The Attic Insulation Shield must be installed when blown or loose-fill insulation is used, and is required for all attic installations.

3. Cut a hole in the roof using locating hole as a center point. (Cover any exposed open vent pipes before cutting hole in roof.) The 11"x 11" hole must be measured on the horizontal; actual length may be larger depending on pitch of roof. There must be a 1" clearance from vent pipe to combustible materials. Frame opening as shown in **Figure 22**.
4. Connect a section of pipe and extend up through hole.

**NOTE:** If an offset is needed to avoid obstructions, you must support vent pipe every 3 feet. Use wall straps for this purpose (*see Figure 21, Page 22*). Whenever possible, use 45° elbows instead of 90° elbows. The 45° elbow offers less restriction to the flow of flue gases.

5. Place flashing over pipe section(s) extending through roof. Secure base of flashing to roof and framing with roofing nails. Be sure roofing material overlaps top edge of flashing as shown in **Figure 21, Page 22**. There must be a 1" clearance from vent pipe to combustible materials.
6. Continue to add pipe sections until height of vent cap meets the minimum building code requirements described in **Table 2** on **Page 17**.
7. Twist-lock vent cap onto last section of vent pipe.

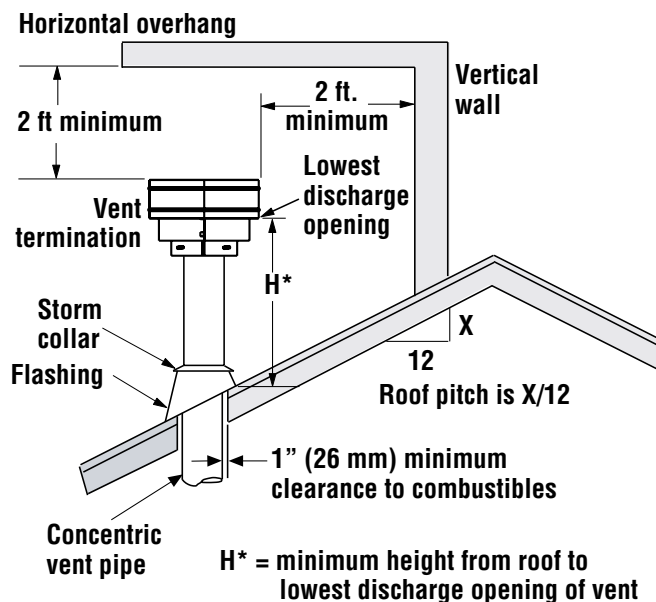
**NOTE:** You must increase vent height for steep roof pitches, nearby trees, adjoining rooflines, steep pitched roofs and other similar factors may cause poor draft or down-drafting in high winds. Increasing vent height may solve this problem.

**NOTE:** If vent pipe passes through any occupied areas above first floor, including storage spaces and closets, you must enclose pipe. You may frame and sheetrock enclosure with standard construction material. Make sure and meet the minimum allowable clearances to combustibles. Do not fill any required air spaces with insulation.

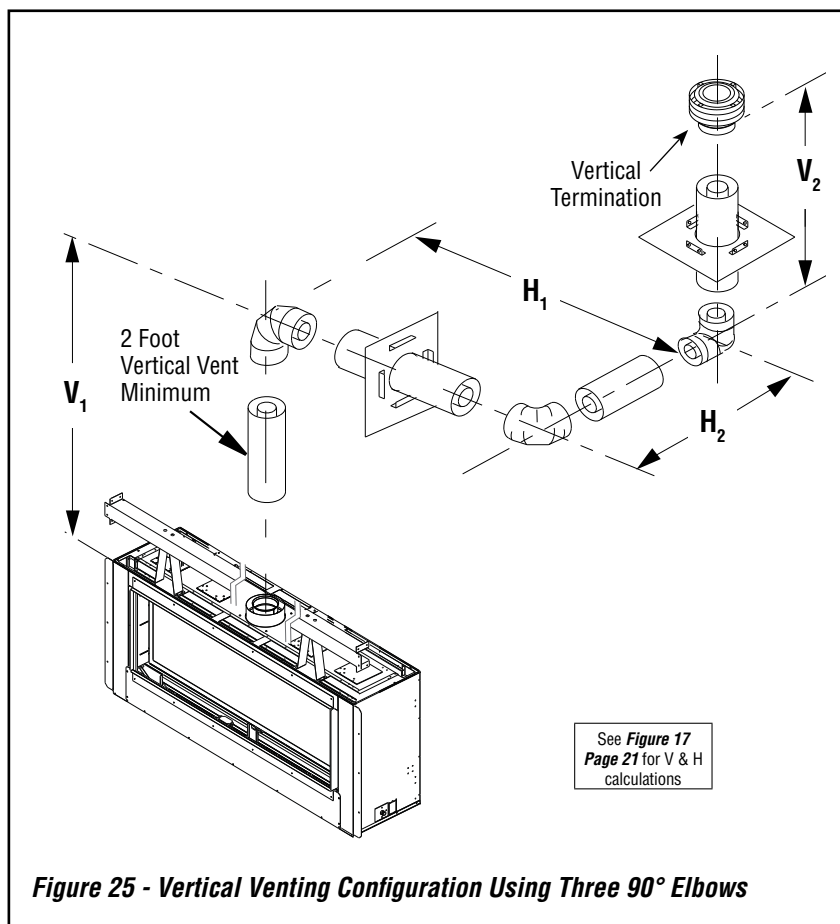
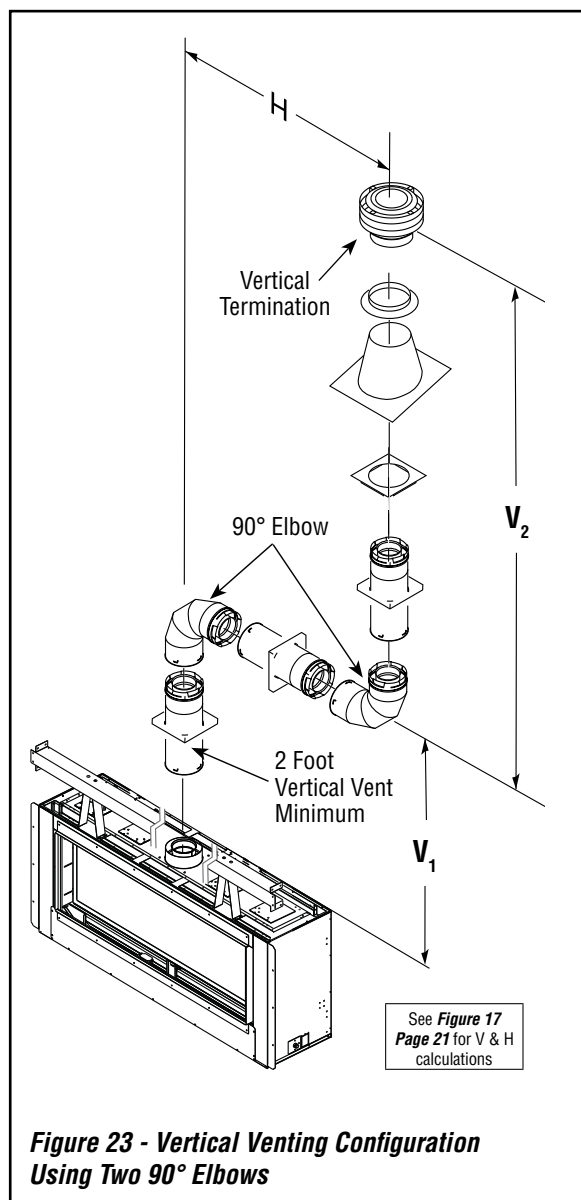

### FLEX VENT INSTALLATION

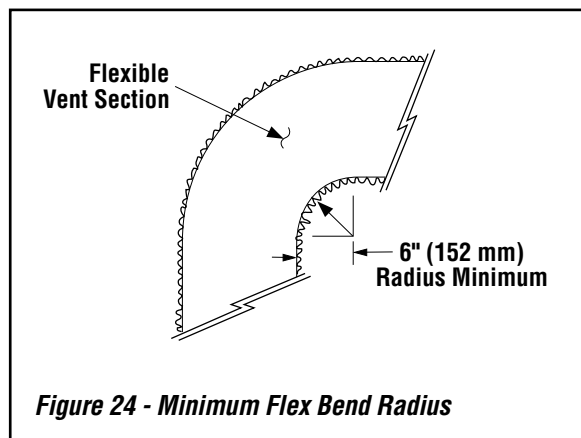
IHP 6DVL Direct Vent Flex may also be used when venting this fireplace model. The flex venting sections contain a flexible vent section that can be connected to other flexible or rigid vent sections on this appliance. The flex venting is designed to aid in installation where the cost and complexity of the installation may be impractical to use rigid pipe alone.

All restrictions such as venting length, height, routing, horizontal to vertical ratio requirements or clearance considerations as detailed in these instructions for rigid vent must be adhered to when also using flexible vent unless otherwise stated. See **Figure 17A**.

Flexible vent pipe is packaged and shipped in its uncompressed state. When installing flexible vent pipe, its length may be compressed slightly to fit the desired installation. The IHP 6DVL Flex Pipe may be used in conjunction with rigid pipe vent sections. Each flex vent section comes with male and female twist lock ends already installed and ready to connect to other vent pipe sections.

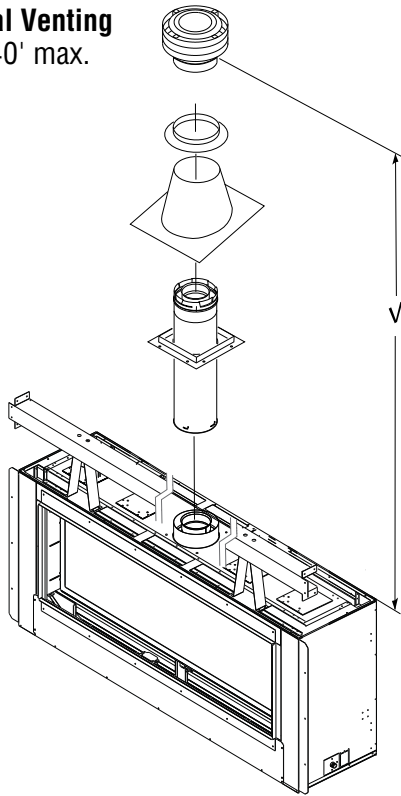
Ensure that the flex vent is properly routed to provide the required clearance. Do not allow the flexible vent to bend in a radius tighter than 6" (152mm). Refer to **Figure 24**. It is recommended that venting be sloped upward toward the termination a minimum of 1/4" rise per foot (20mm per meter) of horizontal vent run. Support the horizontal vent sections using metal straps spaced at 2' (0.61 meter) intervals.

**NOTE:** Rigid vent sections must be used when routing venting through firestops.

### POWER VENT INSTALLATION

This fireplace supports the use of a Power Vent system with horizontal termination for additional venting configurations not supported using natural draft venting. See the **Accessory Components** section of this manual for the base Power Vent Kit components. Additional components are required (see Power Vent Kit installation instructions for details). The Power Vent Kit installation instructions include additional instructions specific to this fireplace model.

**NOTE:** The Power Vent Kit is designed to use Secure Vent Rigid (SV4.5) or Secure Flex (SF4.5) vent systems. A separate flue pipe adaptor is required for converting the flue pipe from the 6" x 9" venting on the fireplace to the 4-1/2" x 7-1/2" venting used by the Power Vent system. Venting components for 4-1/2" x 7-1/2" are required in addition to the base Power Vent Kit (see kit manual). **THE FLUE ADAPTOR IS FOR POWER VENT USE ONLY.**

### HIGH ALTITUDE INSTALLATION

Your IHP direct vent fireplace has been tested and approved for elevations from 0-2000 feet in the USA.

When installing a fireplace at an elevation above 2000 feet, you may need to decrease the input rating by changing the existing burner orifice to a smaller size. Reduce input 4% for each 1000 feet above sea level. Check with your local gas company for proper orifice size identification.

When installing this fireplace at an elevation above 4500 feet, check with local authorities.

In Canada, this fireplace does not require input reduction up to 4500 feet (1370m) above sea level. Please consult with provincial and/or local authorities having jurisdiction for installations above 4500 ft (1370m) or contact IHP through your dealer.

\* If heating value of gas has been reduced, these rules do not apply.

Check with your local gas supplier.

## FIREPLACE INSTALLATION

### CHECK GAS TYPE

Use proper gas type for the fireplace unit you are installing. If you have conflicting gas types, do not install fireplace. See retailer where you purchased the fireplace for proper fireplace according to your gas type or conversion kit.

### INSTALLING GAS PIPING TO FIREPLACE LOCATION

#### **! WARNING**

**A qualified service person must connect fireplace to gas supply. Follow all local codes.**

#### **! CAUTION**

**For propane/LP units, never connect fireplace directly to the propane/LP supply. This heater requires an external regulator (not supplied). Install the external regulator between the fireplace and propane/LP supply.**

#### **! WARNING**

**Never connect this appliance to private (non-utility) gas wells. This gas is commonly known as wellhead gas and does not have odorants and may have impurities, and variations in BTU content. The use of well-head gas will void the manufacturer's warranty to this appliance.**

### Installation Items Needed

Before installing fireplace, make sure you have the items listed below.

- external regulator (supplied by installer)
- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve \*
- test gauge connection \*
- sediment trap
- tee joint
- pipe wrench
- approved flexible gas line with gas connector (if allowed by local codes)

\* An equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the equipment shutoff valve from your retailer.

For propane/LP connection only, the installer must supply an external regulator. The external regulator will reduce incoming gas pressure. You must reduce incoming gas pressure to between 11" and 14" of w.c. pressure. If you do not reduce incoming gas pressure, fireplace regulator damage could occur. Install external regulator with the vent pointing down as shown in **Figure 27A**. Pointing the vent down protects it from freezing rain or sleet.

**NOTE:** When setting/measuring gas pressure, make sure the pressure is measured with operating at maximum setting. If other appliances are connected to the same supply line, have them operating at max setting also. If the supply line and regulator is sized correctly, the difference between the inlet pressure when fireplace is OFF and ON at max will be within 1 to 2 inches of WC.

IHP recommends an inlet pressure of the following to the appliance:

For NG 5.5" to 7.0" of WC

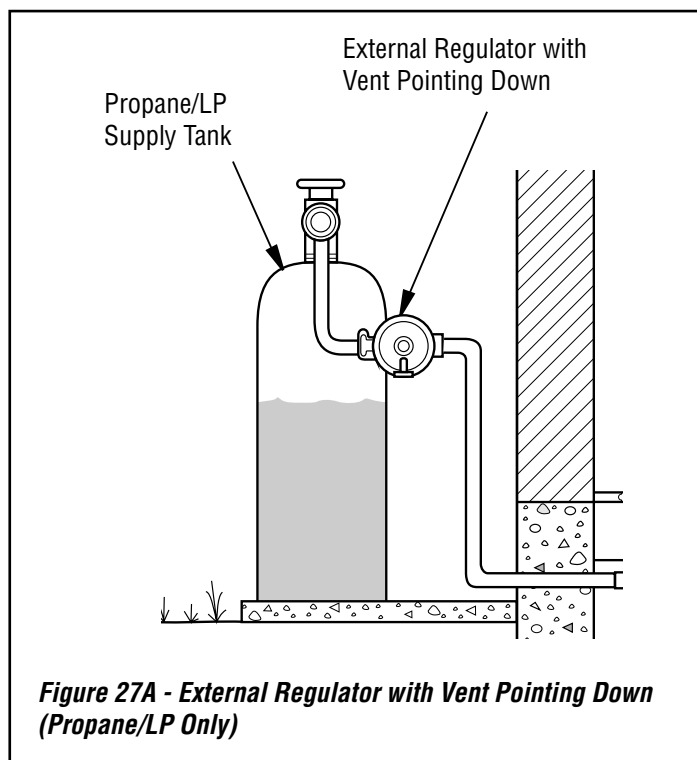
For LP 11.0 " to 12.0" of WC

#### **! CAUTION**

**Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" diameter or greater to allow proper gas volume to fireplace. If pipe is too small, undue loss of volume will occur.**

Installation must include an equipment shutoff valve, union and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from fireplace (**see Figure 27B, Page 28**).

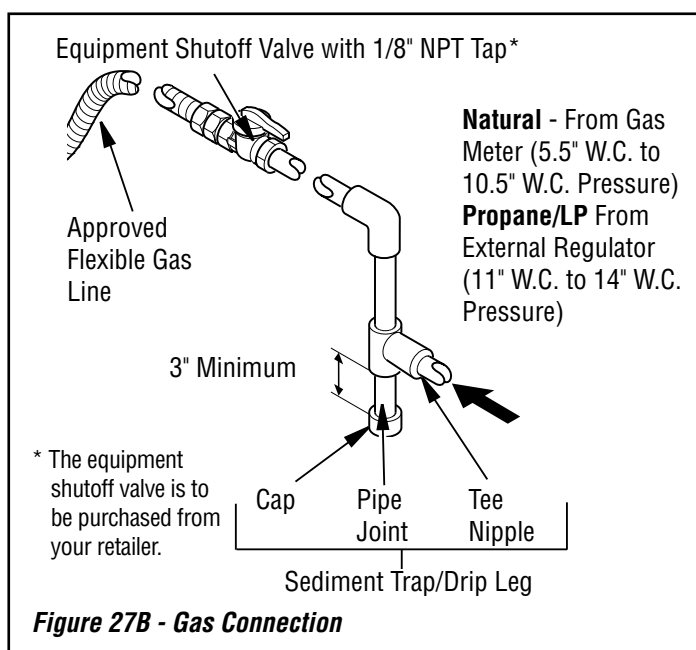
**IMPORTANT:** Install main gas valve (equipment shutoff valve) in an accessible location. The main gas valve is for turning on or shutting off the gas to the appliance.



Check your building codes for any special requirements for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged fireplace valves.

## FIREPLACE INSTALLATION *Continued*



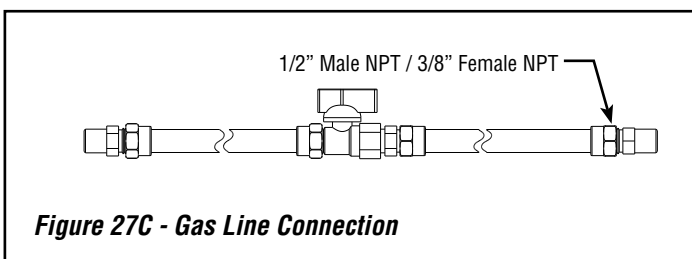
**NOTE:** Ensure the CPI/IPI switch is set to intermittent mode with the pilot in the OFF position. See control compartment door label for more information.

**NOTE:** A sediment trap is recommended in the gas piping within the home to prevent moisture and debris in the line from damaging the valve.

**NOTE:** Secure all joints tightly using appropriate tools and sealing compounds (ensure propane resistant compounds are used in propane applications). Seal around the gas line to prevent cold air leakage. Gas line holes and other openings can be caulked or stuffed with unfaced fiberglass insulation.

These fireplaces are equipped with a gas flex line for use (where permitted) in connecting the unit to the gas line. A gas flex line is provided to aid in attaching the direct-vent fireplace to the gas supply. The gas flex line can only be used where local codes permit. The flex line is rated for both natural and propane gas. A manual shut off valve is also provided with the flex line.

The gas control valve is located in the lower control compartment (**Figure 43, Page 39**).



### ! NOTICE

**The gas line and connectors in the fireplace is rated for both natural gas and propane.**

For ease of installation and servicing, IHP recommends the use of "union coupler" before connecting to the fireplace.

### ! WARNING

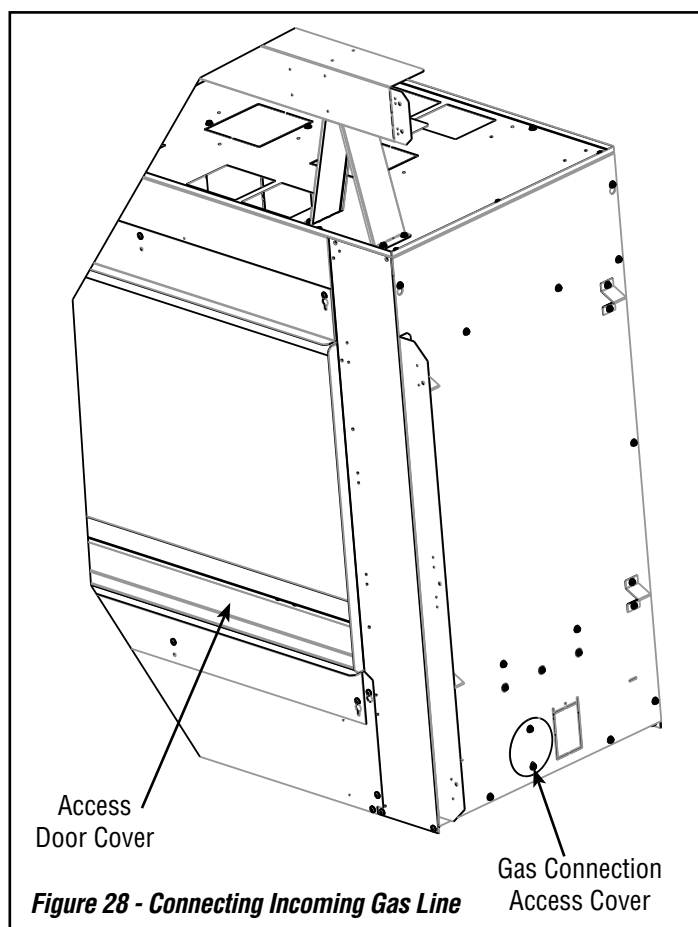
**Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.**

We recommend that you install a sediment trap/drip leg in supply line as shown in **Figure 27B**. Locate sediment trap/drip leg where it is within reach for cleaning. Install in piping system between fuel supply and fireplace. Locate sediment trap/drip leg where trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into fireplace gas controls. If sediment trap/drip leg is not installed or is installed wrong, fireplace may not run properly.

### CONNECTING FIREPLACE TO GAS SUPPLY

#### Connect the Gas Line

All codes require a shutoff valve mounted in the supply line. The flex-line method is acceptable in the U.S., however, Canadian requirements vary depending on locality. Installation must be in compliance with local codes.



## FIREPLACE INSTALLATION *Continued*

### CHECKING GAS CONNECTIONS

#### **! WARNING**

Test all gas piping and connections, internal and external to unit, for leaks after installing or servicing. Correct all leaks at once.

#### **! WARNING**

Never use an open flame to check for a leak. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

### PRESSURE TESTING GAS SUPPLY PIPING SYSTEM

IHP Strongly recommends conducting these tests before installing the finishing materials on the fireplace face.

#### Test Pressures In Excess Of 1/2 PSIG (3.5 kPa)

1. Disconnect fireplace and its individual equipment shutoff valve from gas supply piping system. Pressures in excess of 1/2 psig (3.5 kPa) will damage fireplace gas regulator.
2. Cap off open end of gas pipe where equipment shutoff valve was connected.
3. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas fireplace or opening main gas valve located on or near gas meter for natural gas fireplace or using compressed air.
4. Check all joints of gas supply piping system. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.
5. Reconnect fireplace and equipment shutoff valve to gas supply. Check reconnected fittings for leaks.

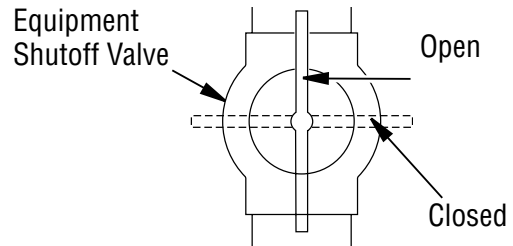
#### Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)

1. Close equipment shutoff valve (see **Figure 29**).
2. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas fireplace or opening main gas valve located on or near gas meter for natural gas fireplace or using compressed air.
3. Check all joints from propane/LP supply tank or gas meter to equipment shutoff valve (see **Figure 30 or 31**). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
4. Correct all leaks at once.

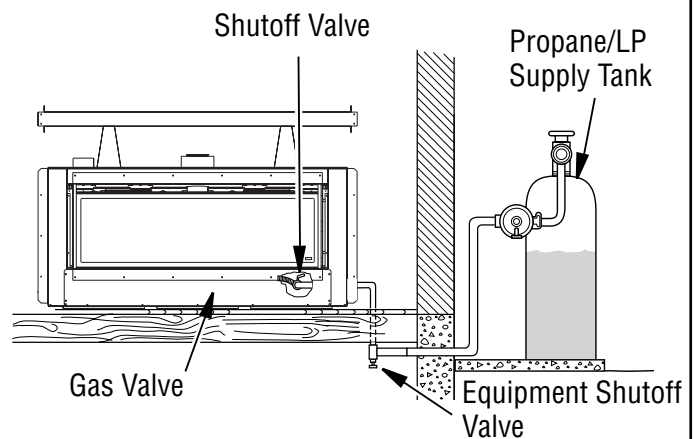
### PRESSURE TESTING FIREPLACE GAS CONNECTIONS

1. Open equipment shutoff valve (see **Figure 29**).
2. Open propane/LP supply tank valve for propane/LP fireplace or main gas valve located on or near gas meter for natural gas fireplace.
3. Open shutoff valve underneath valve access cover.
4. Make sure control of fireplace is in the OFF position.

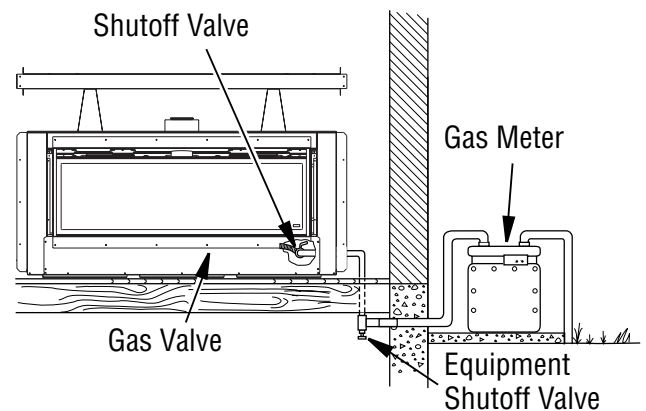
5. Check all joints from equipment shutoff valve to gas valve (see **Figure 30 or 31**). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.
6. Light fireplace (see *Operation*, **Pages 38-47**). Check all other internal joints for leaks.
7. Turn off fireplace (see *To Turn Off Gas to Appliance*, **Page 41**).

### REMOVING/INSTALLING GLASS DOOR

#### **⚠ CAUTION**

Do not operate this fireplace with a broken glass door panel or without the glass door panel securely in place. Only doors certified with the appliance shall be used.

#### **⚠ CAUTION**

Wear gloves and safety glasses while handling or removing broken glass. Do not remove if glass is hot. Keep children and pets away from glass.

#### **⚠ WARNING**

If fireplace has been running, turn off fireplace. Let cool before removing glass doors.

#### **⚠ WARNING**

A barrier designed to reduce the risk of burns from the hot viewing glass is provided with this appliance and shall be installed.

Discontinue use of the appliance immediately if doors are damaged and contact a qualified installer for repair. Only doors certified with the appliance shall be used.

#### Removing Glass Door

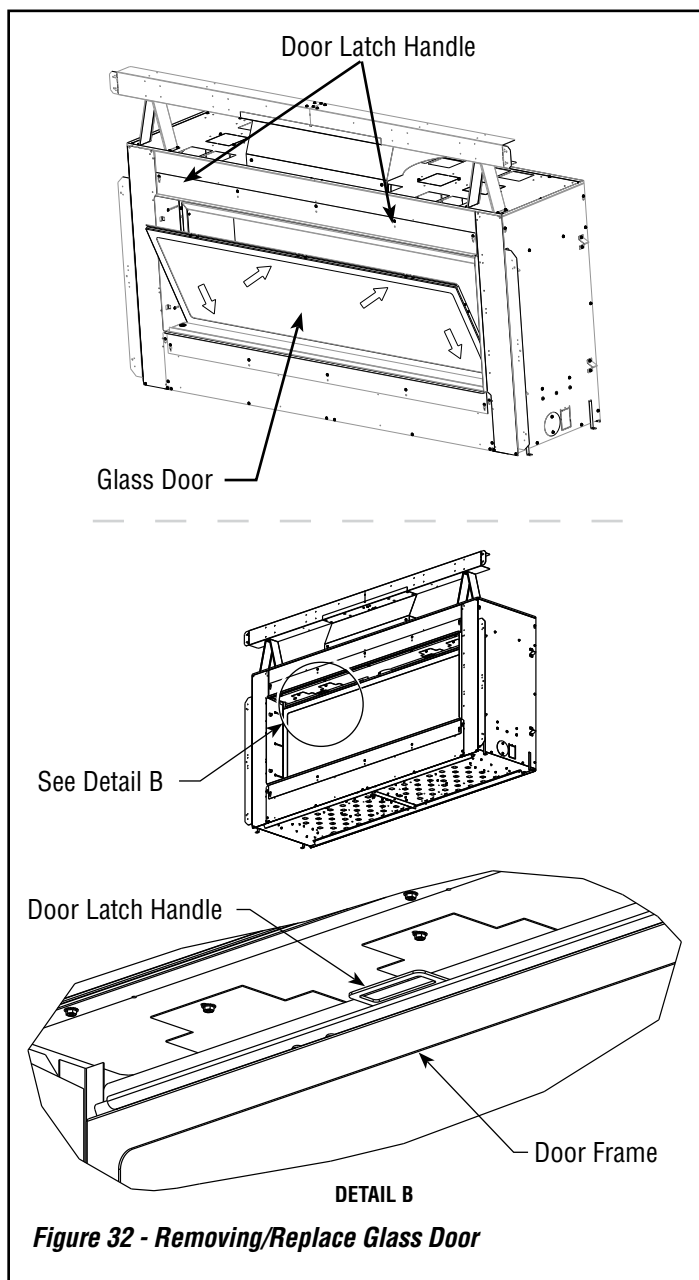
If replacement of glass is necessary, the entire frame assembly must be replaced.

Gloves must be worn when removing/replacing glass door. If glass is broken tape remaining glass onto frame before removing.

1. Remove bottom access panel.
2. Pull forward and upward on left and right door latch handles to release door.
3. Tilt open glass door about 15° from the top of the firebox and lift up to release door from retaining channel (see **Figure 32**).

#### Installing Glass Door

1. Position door frame in front of firebox opening tilting top of door about 15° toward you. Insert bottom flange of glass door into the retaining channel at the bottom of firebox (see **Figure 32**). Make sure door is center with firebox opening.
2. Tilt top of door up toward top of firebox.
3. Pull forward and upward on door latch handles and hook top of door.



**Figure 32 - Removing/Replace Glass Door**

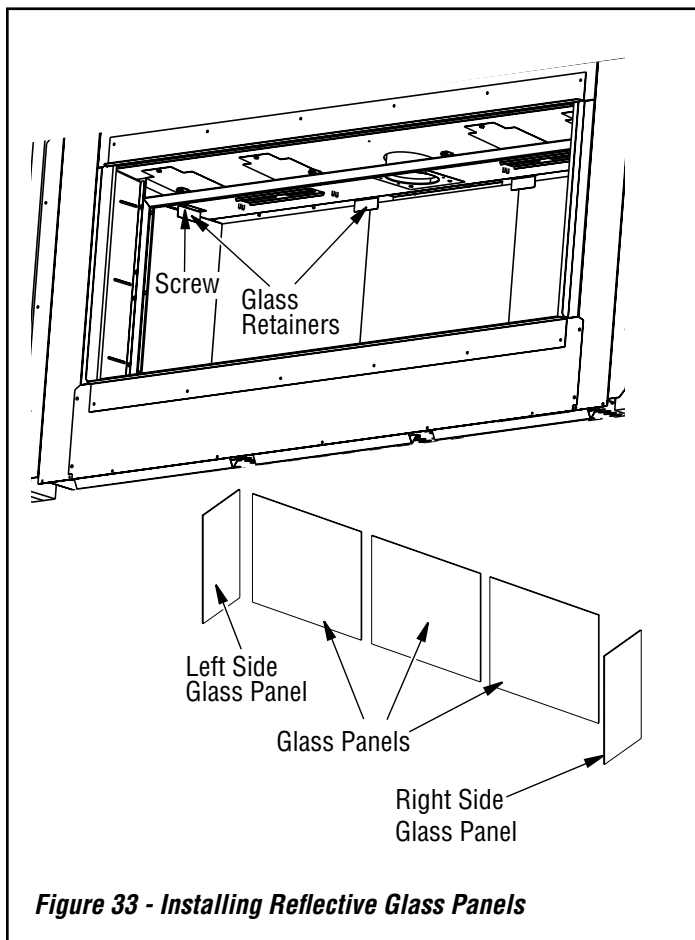

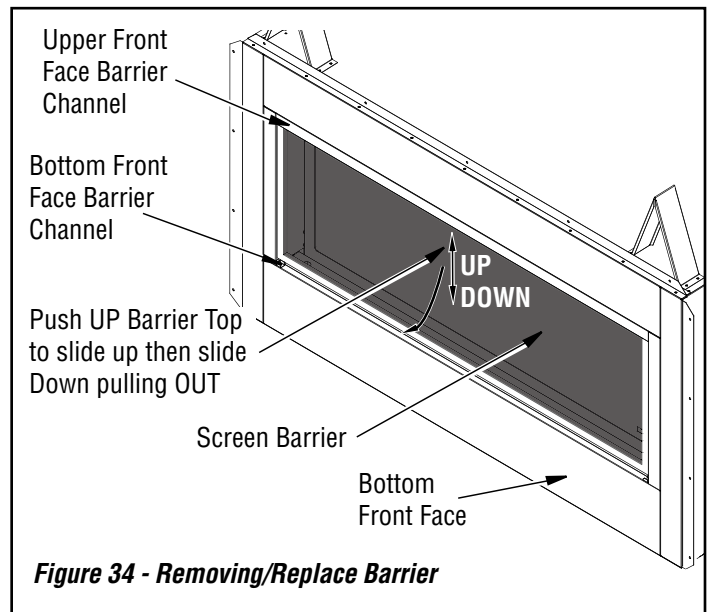
1. Remove glass door from front of fireplace. Refer to [Removing/Installing Glass Door](#) of this manual when removing glass door.
2. Loosen 8 screws from underneath firebox top, sides and rear, and remove glass retaining brackets.
3. Open the glass kit, identify the glass panels; 3 of the same size are for the rear and 2 of the same size are for the left/right sides.
4. Install the left and right side panels, insert the glass panel in the firebox bottom channel using 2 retaining brackets and the screws removed in step 2.
5. Install the three rear glass panels using 2 retaining brackets and screws starting from the left to right side (**Figure 33**).

### Installing/Removing Barrier

1. To remove barrier, push barrier top up to slide it up then slide down pulling barrier out (*see Figure 34*).
2. Install the barrier by sliding in into the top channel with the flat side toward the fireplace, then swinging the base of the barrier into the bottom channel and lowering it into place (*see Figure 34*).

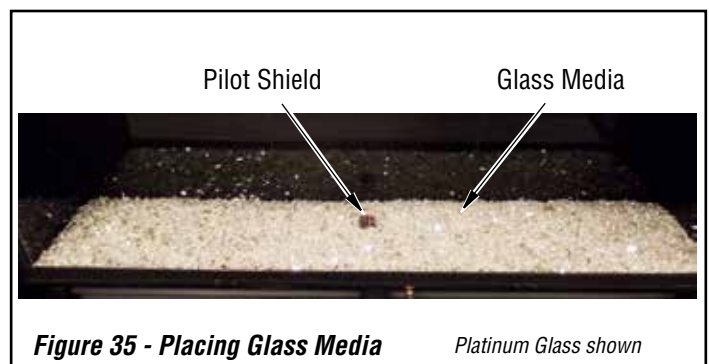
**Do not change or substitute glass media provided with this fireplace. If replacing, use only replacement glass media approved for this fireplace. See [accessories Page 58](#).**

#### **! WARNING**

**Do not cover pilot shield with glass media.**

Platinum glass media (three [3] 5 lb. bags for 60", four [4] 5 lb. bags for 72" and five [5] 5 lb. bags for 84") is included with your fireplace. Install it while glass doors are open and/or removed.

1. Place glass media in a layer evenly make sure only one layer of media on top of the burner and remaining media could be spread evenly across the remaining pan media. Ensure not to place media on top of the pilot shield, it is okay to place media around the shield (*see Figure 35*).
2. Logs and/or river rocks are optional and can be used to tailor the looks of the fireplace to your preference. If adding these accessories, install them per the instructions included with the kits.

### Complete the Field Wiring

Electrical connections and operation verification must be done prior to installing finishing materials on the fireplace face.

**Verify proper operation after servicing.**

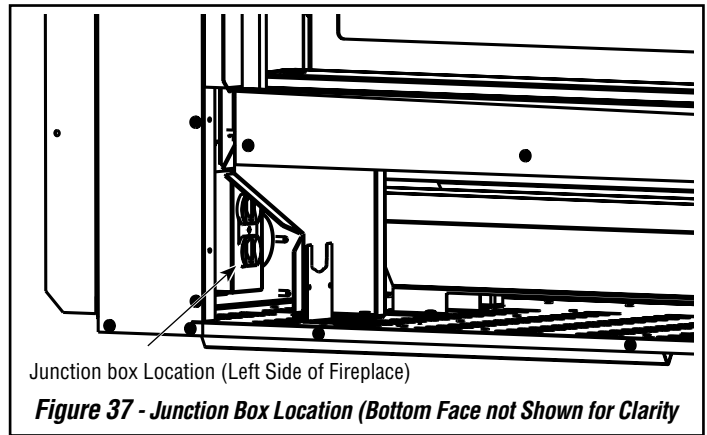
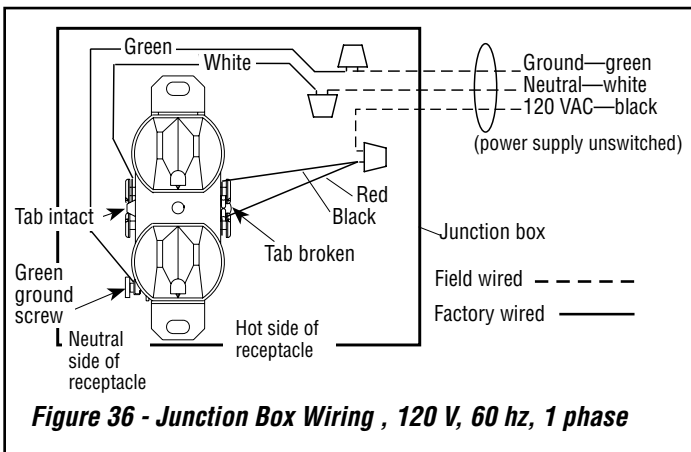
**The gas valve is set in place and pre-wired at the factory.**

**NOTE:** Must be connected to the main power supply.

**NOTE:** The junction box is located on the left side of the fireplace (*Figure 37*).

### Wire the Fireplace

1. Route a 3-wire, 120 Vac, 60 Hz, 1 ph unswitched power supply to the fireplace junction box.
2. Remove the electrical inlet cover plate from the outside of the unit by removing the plate securing screws.
3. Feed the power supply wires through the strain relief in the cover plate and into the unit junction box.
4. Connect the black power supply wire to the power outlet red and black pigtails together. Connect the white power supply wire to the outlet common terminal (*Figure 36*).
5. Connect the ground supply wire to the pigtail lead attached to the outlet's green ground screw (*Figure 36*). Restrain the inlet power lead per NEC or local codes.
6. After the wiring is complete, replace the cover plate.



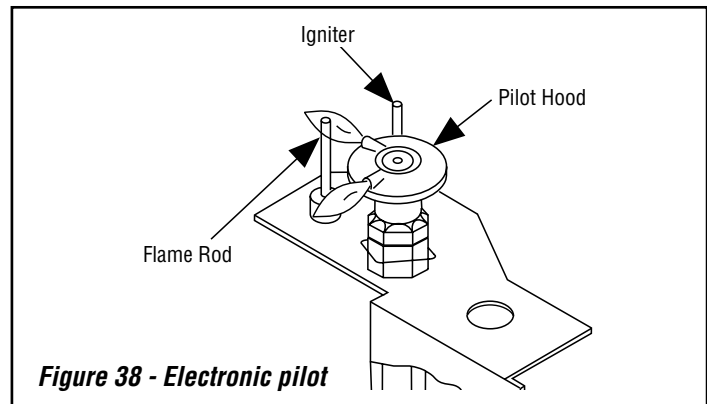
### Verify Proper Fireplace Operation

With the gas line installed and electrical connections made, inspect the system before closing the front of the unit.

Follow the pilot lighting instructions (*Page 41*).

When lighting the fireplace for the first time, it will take a few minutes for the gas line to purge itself of air. When purged, the pilot and burner will light and operate as indicated. Subsequent lighting of the fireplace will not require purging.

To light the burner, turn ON the wall or remote control switch. Ensure the igniter lights the pilot. The pilot flame should engulf the flame rod (*Figure 38*).



1. Verify operation of fireplace on Main Power Only (remove backup battery for this step)
2. Verify operation of the fireplace with backup battery (Disconnect the Main Power Cord from the Junction for this test)
3. Turn on the lights and verify Operation



## FIREPLACE INSTALLATION *Continued*

### Adjust the Air Shutter to Ensure Proper Flame Appearance

The air shutter opening is preset for natural gas (NG) at 1/8" when it leaves the factory. Air shutter opening may be adjusted if gas type is converted from NG to propane (LP).

#### ! WARNING

- Air shutter adjustment should only be performed by a qualified professional service technician.
- Ensure glass door is in place and sealed during adjustment.

#### ! WARNING

- Soot will be produced if the air shutter is closed too much. Any damage due to sooting, resulting from improperly setting the air shutter, is not covered under the warranty.
- The air shutter rod and nearby appliance surfaces are hot. Exercise caution to avoid injury while adjusting flame appearance.

### Flame Appearance and Sooting

The flame should be blue at the base, and yellow-orange in the body of the flame.

When the fireplace is first lit, the entire flame may be blue and will gradually turn yellow-orange during the first 30 minutes of operation. If the flame remains blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the fireplace inside surfaces and on exterior surfaces adjacent to the vent termination.

Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellow-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

### Air Shutter Adjustment Guidelines


- If there is smoke or soot present, first ensure that the flames are not impinging on any of the panels or interior media options. If the panels or interior media options are properly positioned and a sooting condition still exists, increase the air shutter opening.
- The more offsets in the vent system, the wider the air shutter will need to be opened.
- The length and configuration of the chimney vent will affect flame appearance.
- A fireplace operated with the air shutter opened too far may have flames that appear blue and transparent.
- Propane models may exhibit flames that candle or appear stringy. If this condition is present and persists, adjust the air shutter to a more open position, then operate the fireplace for a few more minutes to ensure that the flame normalizes and the flames do not appear sooty.

- The following chart is provided to help achieve the correct air shutter adjustment for your installation.

**Table 6 - Air Shutter Adjustment Guidelines**

Amount of Primary Air	Flame Color	Air Shutter Adjustment
If air shutter is closed too far →	Flame will be orange →	Air shutter gap should be increased: PULL lever toward front of fireplace
If air shutter is open too far →	Flame will be blue →	Air shutter gap should be decreased: PUSH lever toward Back of fireplace

1. Move the adjustment lever (**Table 6**) back to decrease air flow and forward to increase it. Position the air shutter to the factory setting (**Table 6**).
2. Light the fireplace. Follow the lighting procedure on the lighting label in the control compartment on **Page 41**.
3. Allow the burner to operate for at least thirty (30) minutes while observing the flame continuously to ensure that the proper flame appearance is achieved (**Figure 39**). If the following conditions are present, adjust accordingly.
  - If flame appears weak or sooty, adjust the air shutter, incrementally, to a more open position until the proper flame appearance is achieved.
  - If flame remains blue, adjust the air shutter, incrementally, to a more closed position until the proper flame appearance is achieved.
4. When satisfied that the burner flame appearance is normal, proceed to finish the installation.

## FINISHING FIREPLACE

### WARNING

#### RISK OF FIRE AND PROPERTY DAMAGE.

All finishing material must comply with all minimum clearances. Framing closer than minimums listed must be constructed with non-combustible materials only. The fireplace chase cavity volume must not be reduced even with non-combustible materials or will result in overheating of the fireplace and fireplace control components.

Clearances to combustible mantels vary according to mantel depth (*Figure 40*).

Minimum clearance requirements include any projections such as shelves, window sills, mantels, etc above the fireplace.

**NOTE:** NEVER install combustible material (wall finish, surround, trim, etc.) on, in front of, or overlapping any part of the fireplace front face.

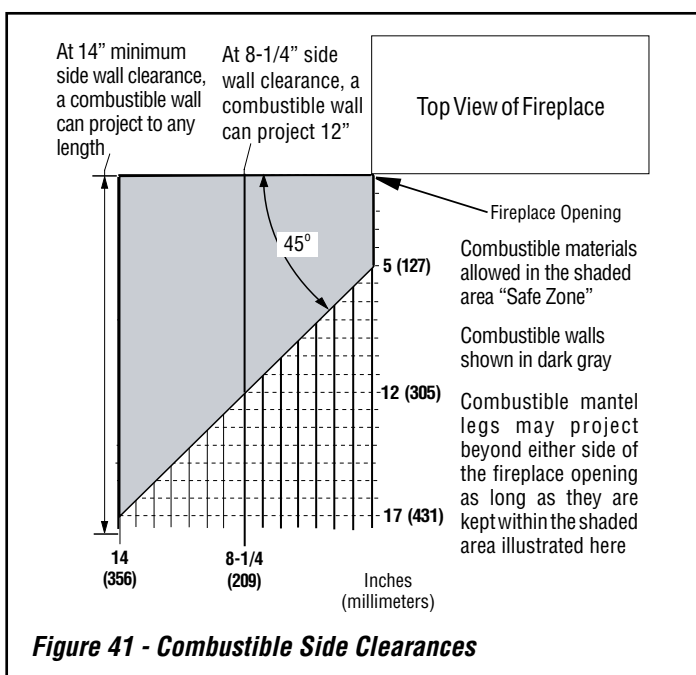
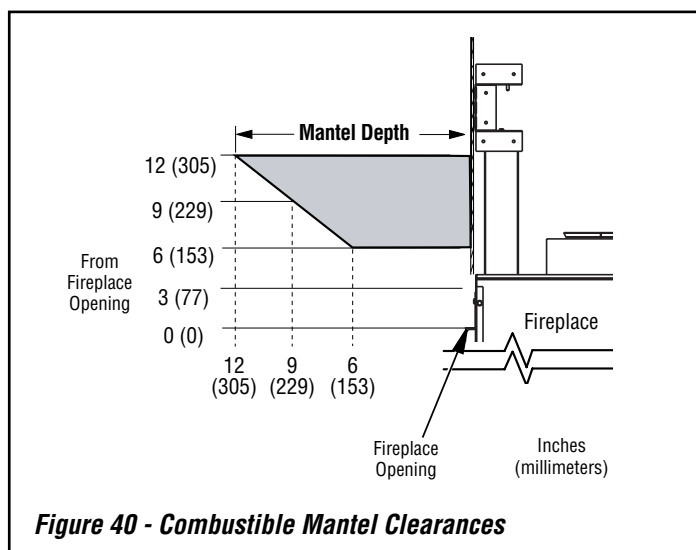
**NOTE:** Non-combustible fireboard is provided with the fireplace. DO NOT SUBSTITUTE.

**NOTE:** Factory supplied tile stops protrude 3/4" from unit and will allow installation of standard tile and thin set on top of the noncombustible fireboard.

#### Installing Fireboard

1. Using 1" self drill bugle drywall screws (supplied), install non-combustible fireboard at bottom, sides and top of fireplace face (*see Figure 42, Page 35*).

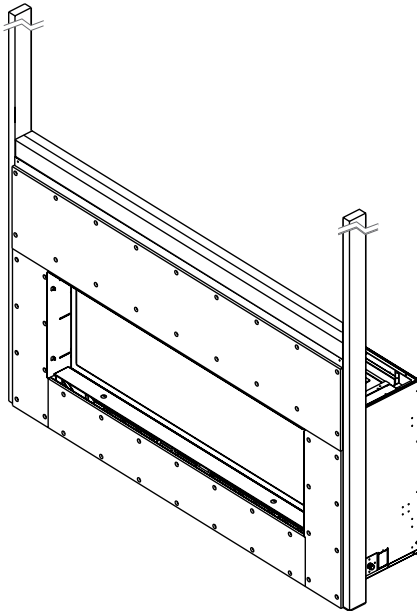
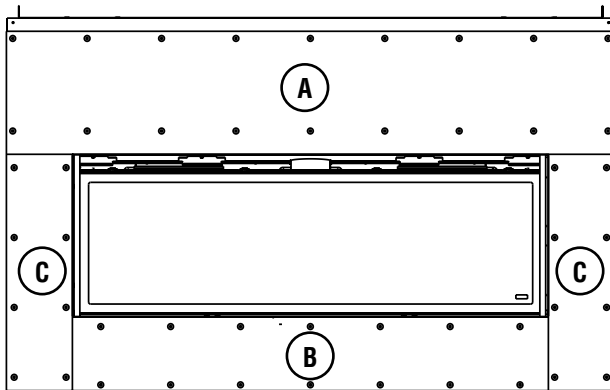

**Comply with all minimum clearances to combustibles as specified. Framing closer than the minimums listed must be constructed entirely of non-combustible materials (i.e., steel studs, concrete board, etc.).**

### Finishing Instructions

It is important to follow the framing and finishing instructions to ensure proper placement of fireplace into the surrounding framing/finishing materials.

Wall sheathing materials 1/2 in. thick will properly align with the factory-included non-combustible material.

**WARNING! Risk of Fire!** Factory-included non-combustible fireboard **MUST** be installed. **DO NOT** remove or cover it with combustible material, such as:

- Drywall (gypsum board)
- Plywood
- Materials that do not meet the ASTM E 136 Non-combustibility standard (below).

*Removal of installed, non-combustible board and/or use of materials not meeting the ASTM E 136 standard could cause fire.*

### Non-Combustible Materials Specification

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750 °C.

### **! WARNING**

#### **RISK OF FIRE!**

**Maintain specified air space clearances to combustibles. Inadequate air space could cause overheating and fire.**

## FINISHING FIREPLACE *Continued*

### Finishing Materials

When finishing the wall around the fireplace, it is critical that wall sheathing be fastened properly.

#### **WARNING**

##### **Risk of Fire, Explosion or Asphyxiation!**

**DO NOT use screws longer than the ones supplied (1" long, self tapping, countersunk head) while attaching non-combustible board to fireplace/framing may penetrate gas line or damage valve or electrical components.**

The appliance is designed to mate with 1/2 in. wall sheathing materials such as drywall, plywood, wood composites, or non-combustible materials.

### Finishing and Sealing Joints

All joints between the finished wall sheathing and the appliance must be sealed with non-combustible materials. Sealants, such as caulk or mastic used to seal the gap between the wall and the fireplace, should be rated at a minimum continuous exposure to 300 °F.

### Finishing Around Opening with Gypsum Wallboard

Gypsum wallboard (drywall) joints adjacent to the fireplace opening, including the non-combustible board on the appliance, require special attention to minimize cracking. When installing gypsum wallboard around the fireplace, install the hole for the fireplace opening in a single wallboard sheet, if possible. This will minimize the joints adjacent to the fireplace opening.

Tape wall board joints around the fireplace opening with fiberglass-mesh tape. It will provide a more crack-resistant joint than paper tape. Fill, smooth and finish wall joints with chemically setting-type joint compound. It will provide a more crack-resistant joint than air-drying light-weight compound.

### Painting

If desired finishing includes a painted wall, 100% acrylic latex with compatible primer is recommended around this appliance. Oil-based or standard acrylic paints may dis-color due to heat exposure.

In extreme cases, lab tests have shown yellow pigments fading out of paints over time due to heat. Vent run and installation location will have an effect on wall temperature and fading. If fading occurs, consider avoiding paint that contains yellow pigment.

In regards to the sheetrock mud, apply a smooth, even layer, covering a wide area of the wall for the best results. For best results, see **Table 7, Page 36**.

**Table 7 - Do's and Don'ts**

#### **To Reduce the Risk of Sheetrock Cracking: DO**

Use all purpose joint compound.

Use 100% acrylic latex paint.

#### **To Avoid Sheetrock Cracking: DO NOT**

Use a quick set or light weight joint compound.

Use flat paint.

If a crack does emerge adjacent the fireplace, it can be permanently repaired by filling it with paintable latex caulk, followed by repainting.

#### **WARNING**

##### **Risk of Fire!**

**DO NOT apply combustible materials beyond the minimum clearances. Comply with all minimum clearances to combustibles as specified in this manual. Overlapping materials could ignite and will interfere with proper operation of doors and louvers.**

#### **WARNING**

##### **Risk of Fire!**

**DO NOT install drywall or other combustible materials directly onto the installed noncombustible board.**

### Facing Material

- Facing and/or finishing materials must not interfere with air flow through louvers or decorative fronts.
- Facing and/or finishing materials must never overhang into the glass opening.
- Observe all clearances when applying combustible materials.

## INSTALLER INSTRUCTIONS - ATTACHING SAFETY IN OPERATION WARNINGS

It is the installer's responsibility to ensure these warnings are properly affixed during installation. These warning labels are a critical step in informing consumers of safe operation of this appliance.

### ATTACHING SAFETY IN OPERATION WARNINGS

It is required that the set of safety instruction labels that have been furnished with the fireplace be affixed to the operation and control points of the fireplace. A safety instruction label must be affixed to the receiver wall switch plate where the fireplace is turned on and off (see **Figure A**) and on the remote control handheld Remote control (see **Figure B**). To properly complete the installation of this fireplace, locate the multi-lingual adhesive labels provided with the Care and Operation Instructions and proceed as follows:

1. Locate the wall receiver that controls the fireplace (verify the switch operates the fireplace by turning it on and off). Clean the wall receiver plate thoroughly to remove any dust and oils. Affix the label to the surface of the plate of the wall receiver that controls the fireplace (**Figure A**). Choose the language primarily spoken in the home. If unknown, affix the English language label.
2. Locate the remote control Remote control and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld Remote control (**Figure B**). Choose the language primarily spoken in the home. If unknown, affix the English language label.
3. If you are unable to locate the labels, please call Innovative Hearth Products or your nearest Innovative Hearth Products dealer to receive additional safety instruction labels free of charge.

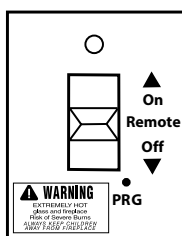

## OPERATION

### **WARNING**

**Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at-risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children and other at-risk individuals out of the room and away from hot surfaces.**

**CARBON MONOXIDE POISONING:** Early signs of carbon monoxide poisoning are similar to the flu with headaches, dizziness and/or nausea. If you have these signs, obtain fresh air immediately. Turn off the gas supply to the appliance and have it serviced by a qualified professional, as it may not be operating correctly. Some people are more affected by carbon monoxide than others, including pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

**NOTE:** Do not place furniture or other combustible materials within 36" of the front of viewing area(s).

**NOTE:** Children and adults should be alerted to the hazards of high surface temperature and should stay away to avoid burns or clothing ignition.

**NOTE:** Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning might be required due to excessive lint from carpeting, bedding material, et cetera. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean.

**NOTE:** Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.



## OPERATION *Continued*

### Burn-in Period

The first few times this fireplace is operated, there will be an odor from the curing of paint and the burning off of the lubricants used in the manufacturing process. Depending on usage, the burn-in period may take a few hours or a few days.

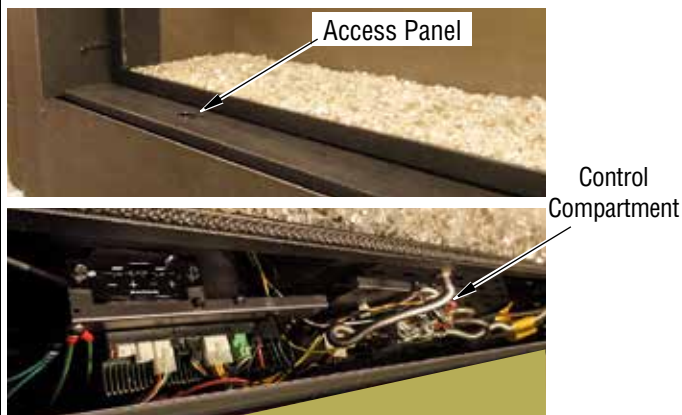
**NOTE:** Ventilate the site during the burn-in period. The resulting odor and haze may set off a smoke detector. Do not operate the blower during the burn-in period.

A white film may develop on the glass front during the first few fires as part of the burn-in period. The glass should be kept clean during the burn-in period to prevent the film from baking on—making it very difficult to remove (**Cleaning the glass door and firebox on Page 48**)

### Accessing the Control Compartment

Access the control compartment by removing the following components, as necessary, in this order:

- Remove the trim kit if installed
- Remove the barrier
- Remove the control compartment access panel (**Figure 43**).

### Closing the Control Compartment

Reinstall the items removed in **Accessing the Control Compartment**, in reverse order.

## GAS CONTROLS

### Shutoff Valves

As part of your fireplace installation, the installer may have provided a readily accessible gas shutoff valve near your fireplace. Make sure this valve is fully open before operating the fireplace. If gas is not flowing to the pilot and burner, the service shutoff valve located in the fireplace control compartment may need to be opened. Contact your dealer or distributor for more information.

To access the service shutoff valve:

- Remove the trim kit if installed
- Remove the barrier
- Remove the control compartment access panel (**Figure 43**).

### To light the fireplace in a power outage:

1. Confirm that batteries are installed in the battery pack.
2. Set the unit-mounted switch, or wall switch to the ON Position.
3. The unit should spark at the pilot and light.  
**NOTE:** If there is no spark, replace the batteries.
4. Operate the fireplace normally.

**NOTE:** Install new batteries (4 AA) in the battery holder before the burn season. Then, the fireplace can automatically switch to battery power in the event of a power outage.

**NOTE:** Blowers and lighting will not operate while unit is on battery power.

### Continuous Pilot Ignition Switch

This appliance has the option to change from an electronic intermittent pilot ignition (IPI) to a standing pilot (Continuous Pilot) for cold climates. The control switch (standing pilot) is located underneath the access cover close to the Proflame Control Module. Using your finger, flip the switch ON for standing pilot or OFF for intermittent pilot ignition. Turning the CPI switch on will allow the pilot flame to burn continuously. This mode will minimize the condensation which forms on the inside of the glass when the main burner is first turned on. It will also help the appliance and vent system stabilize more quickly during the colder months. During the warmer winter and summer months, the CPI switch can be turned off to minimize fuel consumption.

### HOMEOWNER'S INSTRUCTIONS - ATTACHING SAFETY IN OPERATION WARNINGS

#### ATTACHING SAFETY IN OPERATION WARNINGS

Your fireplace has been furnished with safety instruction labels that are to be affixed to the operation and control points of the fireplace. A safety instruction label should be affixed to the receiver wall switch plate where the fireplace is turned on and off (*see Figure A*) and the remote control handheld Remote control (*Figure B*). The warnings should already have been put in place when the fireplace initial set-up was completed. If they are not affixed at these spots, locate the multi-lingual adhesive labels provided with these instructions and proceed as follows:

1. Locate the wall receiver that controls the fireplace (verify the switch operates the fireplace by turning it on and off). Clean the wall receiver plate thoroughly to remove any dust and oils. Affix the label to the surface of the plate of the wall receiver that controls the fireplace (*Figure A*). Choose the language primarily spoken in the home.
2. Locate the remote control Remote control and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld Remote control (*Figure B*). Choose the language primarily spoken in the home.
3. If you are unable to locate the labels, please call Innovative Hearth Products or your nearest Innovative Hearth Products dealer to receive additional safety instruction labels free of charge.

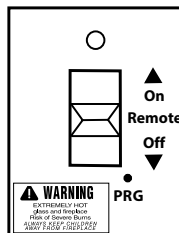

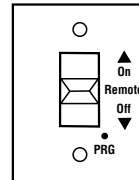

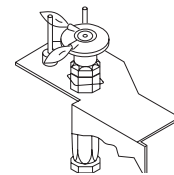
Electronic Gas Control Valve - SIT Proflame

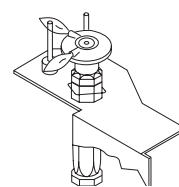

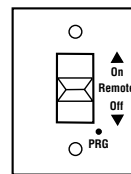

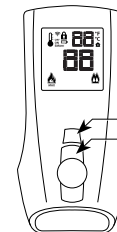

## OPERATION *Continued*

### 1) Initializing the Remote control/Receiver link System for the first time

Install the 4 AA batteries in the Proflame II receiver/battery holder battery bay. **NOTE:** The polarity of the battery and insert into battery bay as indicated on the cover (+/-). Place the 3 position slider switch in the "Remote" position (**Figure 45**). Insert the end of a paper clip or similar object into the hole marked "PGR" on the receiver front cover (**Figure 45**). The receiver will beep three (3) times to indicate that it is ready to synchronize with a Remote control. Install the 3 AAA type batteries in the Remote control battery bay, located on the base of the Remote control and push the On button. The receiver/battery will "beep" four times to indicate the Remote control's command is accepted and set to the particular code of that Remote control. The system is now initialized.

### 2) Ignition Sequence

Starting from OFF, press the remote power button. Approximately four seconds after it is pushed the IFC module will send spark to the pilot hood. It will spark for 60 seconds.

If there is no flame ignition during the first try for ignition, the IFC module will stop sparking for approximately 35 seconds and then it will begin sparking again. The second attempt will spark for another 60 seconds.

If there is no positive signal after the second sequence, the IFC module will go into a Lock Out and the red diagnostic light will blink three times in intervals until the system is reset.

#### In Summary:

a. Ignition sequence is 60 seconds spark, 35 second wait, 60 second spark and then lock out if flame is not sensed by IFC board.

b. Lock Out blink on the red diagnostic light is 3 blinks in sequence

#### Resetting Proflame II IFC Module When In Lock Out:

##### Reset Using the Remote control ON/OFF power button:

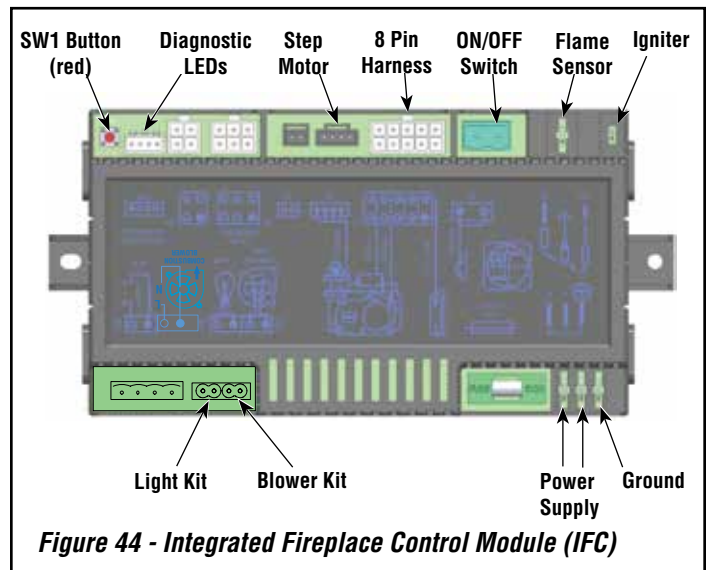
Turn the system off by pressing the remote power button. After approximately 2 seconds press it again.

##### Reset Using the Remote Flame Adjustment buttons:

In the manual mode, use the down arrow to lower the flame all the way to OFF. Wait 2 seconds and then use the up arrow to turn the flame back on.

##### Reset Using Receiver Switch:

With the remote off, move the ON-REMOTE-OFF switch to the OFF position on the receiver. Wait approximately 2 seconds and slide back to ON position. (**NOTE:** You will need to move to REMOTE if you prefer to turn on via remote).

### 3A) BATTERY HOLDER/REMOTE CONTROL

The Proflame II receiver/battery holder includes: a three position switch On/Remote/Off, Remote control Programming button (PRG) and gives the possibility, when used with the Proflame II system, to mount the batteries in a single gang junction box away from the hearth appliance.

The Proflame II IFC Board can be powered by battery pack for back up in case of main power interruption.

#### Functions

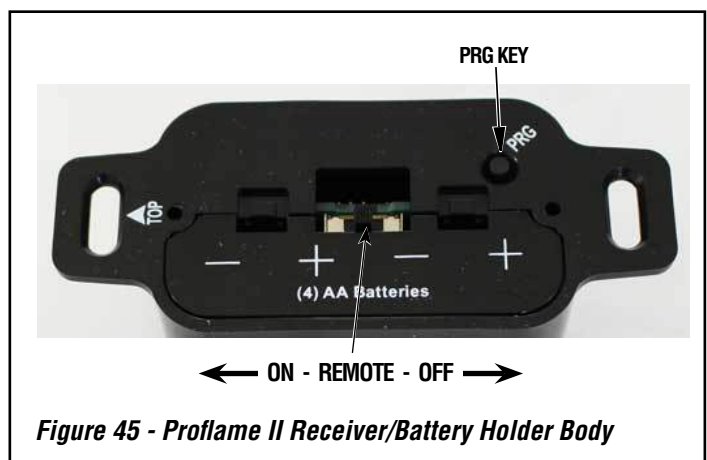
The Proflame II battery holder provides back up system power during line power interruption through the installed 4 AA type batteries.

The Proflame II receiver/battery holder connects directly to the Proflame II integrated fireplace control (IFC) board.

The Proflame II receiver/battery holder has a three position slider switch for system control. The slider switch can be set to one of three positions :

#### OFF position

With the slider in OFF position, the system is "OFF". No function can be selected by the Remote control. No "beep" will be emitted from the Proflame II IFC when a command is sent by pressing any key on the Remote control (for example the ON/OFF key).

### 3B) ON position

With the slider in ON position, the burner flame is "ON". Only the other functions (Fan, Lights, etc.) can be selected by the Remote control.

#### REMOTE position

With the slider in Remote position, all the functions can be selected by the Remote control.

Programming button (PRG)

When pushed allows a Remote control to be accepted for use by the system. See "Initializing the system for the first time."

#### Preliminary Check Of The Battery Holder

Operations can be done, before switching on the remote control:

- Check that the wiring harness connections are made correctly between the Proflame II receiver/battery holder and the Proflame II Integrated Fireplace Control (IFC).

### 4) LOW BATTERY POWER DETECTION

The life span of the Proflame II IFC batteries depends on various factors: quality of the batteries used, the number of ignitions of the appliance, the number of changes to the room thermostat set point, etc.

When the Proflame II IFC batteries are low, two (2) "beeps" will be emitted from the Proflame II IFC every time it receives a command from the Remote control. This is an alert for a low battery condition for the Proflame II IFC. When the batteries are replaced, one (1) "beep" will be emitted from the Proflame II IFC when a command is sent by pressing any key on the Remote control (for example the ON/OFF key), see "Initialization of the system".

5) **Low Battery Condition (<4V) Remote Control:** Battery Icon will appear on LCD remote control display. Replace batteries.

**Low Battery Condition (<4V) Battery Backup:** Red diagnostic light will blink (1) time in intervals. Low double-beep emitted from IFC control module when it receives an ON/OFF command from the remote control. Replace Batteries.

**Pilot Flame Error Condition:** Red diagnostic light will blink (2) times in intervals. Contact your dealer if this occurs.

**System Lock Out Condition:** Red diagnostic light will blink (3) times in intervals. Make sure gas is turned on. Make sure sensor is not shorted. Follow **Reset IFC Control Module When System Goes Into Lock Out** instructions above.

## REMOTE CONTROL OPERATION

### Remote Control System

The Proflame II system consists of the following elements:

1. Pilot Assembly
2. Proflame Gas Valve.
3. Proflame II Control Module
4. Wiring Harness
5. Variable Speed Blowers
6. Halogen Accent Lighting
7. Proflame II remote control
8. Receiver/Battery Pack and manual ON/OFF switch

The Proflame II Remote control controls the following fireplace functions:

1. Main Burner On/Off
2. Main Burner flame modulation (6 levels).
3. Choice of standing or intermittent pilot (CPI/IPI).
4. Thermostat and Smart thermostat functions.
5. Accent lighting modulation (6 levels)
6. Blower speed modulation (6 levels).

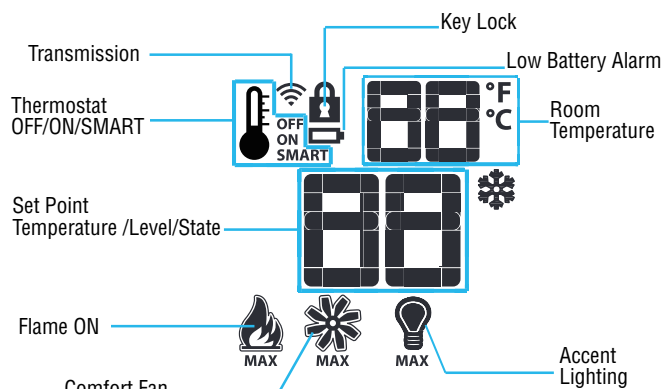
*Figure 46 - Proflame II Remote Control*

The Proflame II Remote control uses a streamlined design with a simple button layout and informative LCD display. A Mode Key is provided to index between the features and a Thermostat Key is used to turn On/Off or index through Thermostat functions, see *Figures 46 and 47*.

### **! WARNING**

**Property damage hazard. Excessive heat can cause property damage. The appliance can stay lit for many hours. Turn OFF the appliance if it is not going to be attended for any length of time. Always place the remote control Remote control where children cannot reach it.**

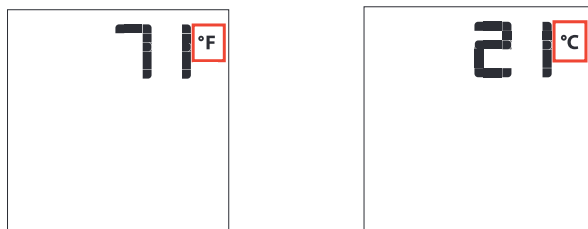

### Temperature Indication Display

With the system in the “Off” position, press the Thermostat Key and the Mode Key at the same time. Look at the LCD screen on the Remote Control to verify that a C or F is visible to the right of the Room Temperature display (**Figure 49**).

### Turn On the Fireplace

With the system Off, turn the Proflame II battery box switch to REMOTE position and press the On/Off Key on the Remote Control. The Remote Control display will show some other active Icons on the screen. At the same time the Control Module will activate the fireplace. A single “beep” from the Control Module will confirm reception of the command.

### Turn Off the Fireplace

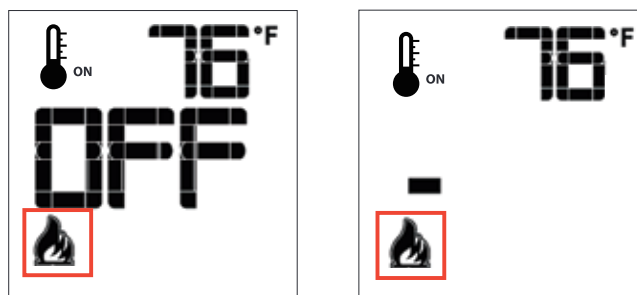
**Figure 50 - Remote Control Display**

With the system On, press the On/Off Key on the Remote Control. The Remote Control LCD display will only show the room temperature (**Figure 50**). At the same time the Control Module will turn off the fireplace. A single “beep” from the Receiver confirms reception of the command.

### Remote-Flame Control

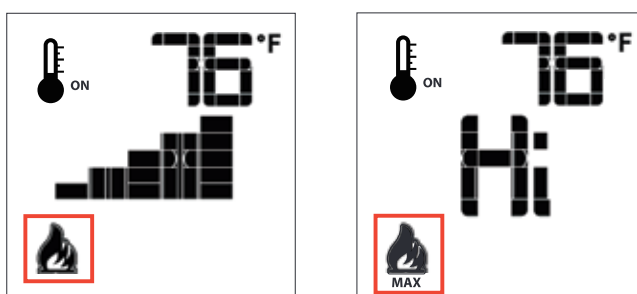
When you turn on the fireplace it starts on high. The Proflame II has six (6) flame levels. Each time you press the Down Arrow Key once the flame height will reduce by one step (**Figure 51**).

You can continue this until the main burner flame turns off. You can still operate the accent lights and fans in this mode.

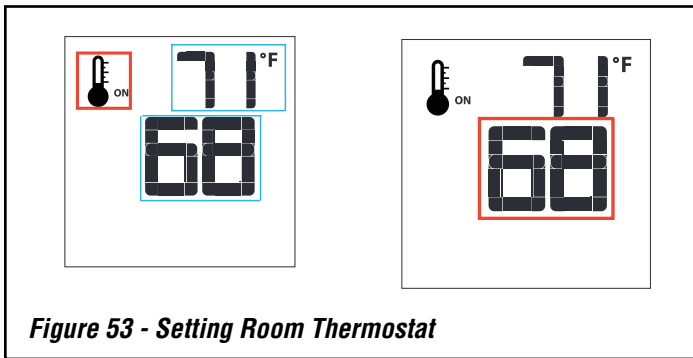
**Figure 52 - Flame Level 5 and Flame Level Maximum**

If the main burner flame is off and you press the up arrow key once, the flame will automatically go to high (**Figure 52**).



**Figure 51 - Flame Off and Flame Level 1**

### Room Thermostat (Remote Control Operation)

The Remote Control can operate as a room thermostat. The thermostat can be set to a desired temperature to control the comfort level in a room. To activate the function, press the Thermostat Key, see **Figure 53, Page 47**. The LCD display on the remote control will change to show that the room thermostat is “On” and the set temperature is now displayed. To adjust the set temperature press the Up or Down Arrow Keys until the desired set temperature is displayed on the LCD screen of the Remote control.



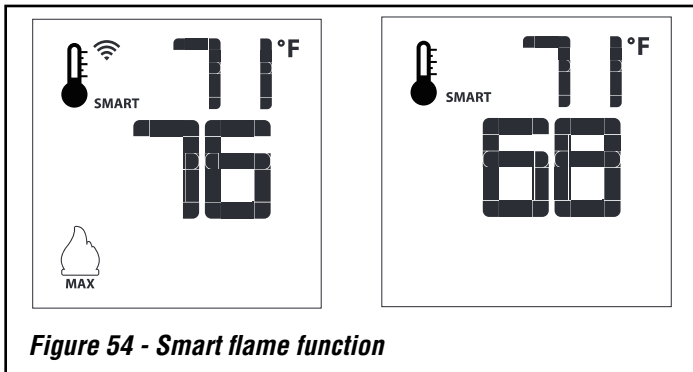

### Smart Thermostat (Remote Control Operation)

The Smart Thermostat function adjusts the flame height in accordance to the difference between the set point temperature and the actual room temperatures. As the room temperature gets closer to the set point the Smart Function will modulate the flame down. To activate the function, press the Thermostat Key, see **Figure 46, Page 45** until the word “SMART” appears to the right of the temperature bulb graphic, see **Figure 54**.

**NOTE:** When smart Thermostat is activated, manual flame height adjustment is disabled.

### Disabling Thermostat

Some jurisdictions and bedroom installations require the thermostat to be disabled.

1. Partially take out one battery, see **Figure 55**.

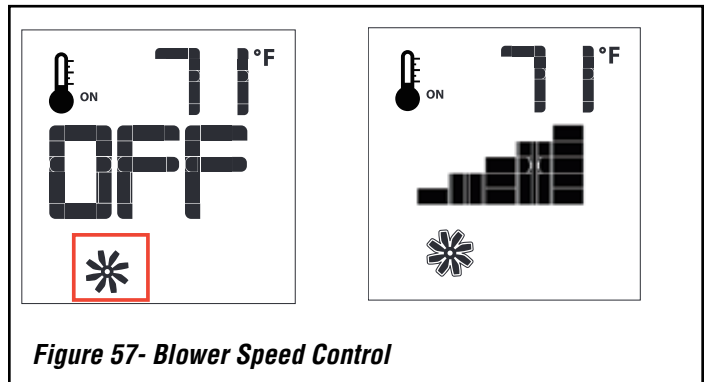


**Figure 56 - Disabling Thermostat**

2. Insert the battery while holding down the thermostat button. The remote screen will display ‘Clr’ while the button is held down. See **Figure 56**.



**Figure 55 - Disabling Thermostat**

1. To enable thermostat repeat steps 1-2. The remote screen will display "set" while the thermostat button is held down.

### Blower Speed Control

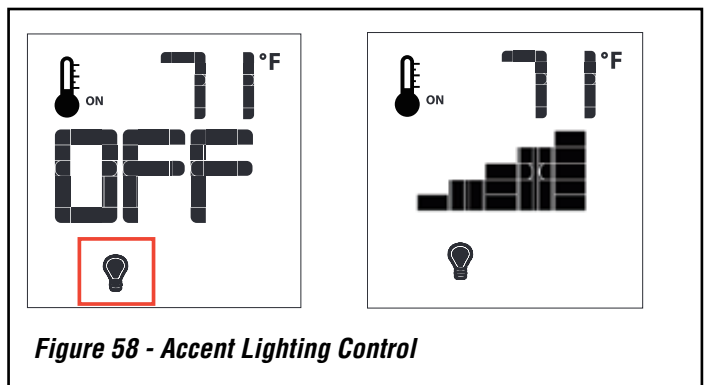


**Figure 57- Blower Speed Control**

The fireplace is equipped with optional hot air circulating blowers. The speed of the blowers can be controlled by the Proflame system. The blower speed can be adjusted through six (6) speeds. To activate this function use the Mode Key, see **Figures 46 and 47, Page 45**, to index to the blower control icon, see **Figure 57**. Use the Up/Down Arrow Keys to turn on, off, or adjust the blower speed. A single “beep” will confirm reception of the command.

### Accent Lighting Control

The fireplace is equipped with warm white colored halogen accent lights. The lights can be controlled by the Proflame system. Light intensity can be adjusted through six (6) levels of brightness. To activate this function use the Mode Key to index the Light icon, see **Figure 58**.

1. Pressing the Up Arrow Key will turn the lights on. Each time you press the Down Arrow Key, the lights intensity will reduce by one step (**Figure 58**).

## CLEANING AND MAINTENANCE

Refer to the **Maintenance Schedule** on **Page 50** for maintenance tasks, procedures, frequency, and a listing of by whom the tasks should be performed. Always verify proper fireplace operation after servicing.



### WARNING

**Turn OFF gas and electrical power to the fireplace and allow it to cool before cleaning or servicing the appliance.**



### CAUTION

**Wear gloves and safety glasses for protection while doing required maintenance.**

#### Verify proper operation after servicing.

**Always turn OFF gas before cleaning. Before relighting, refer to the lighting instructions in this manual. Instructions are also found on a pull-out panel located in the control compartment.**

**Always keep the appliance area clear and free from combustible materials, gasoline and other flammable liquids.**

#### Inspecting the venting system

**NOTE:** Prior to the first use of the fireplace and each burn season and periodically during the burn season, inspect the horizontal termination for debris such as bird nests, leaves, paper or branches. Remove any items from the surfaces of the termination prior to use. Also be aware of shrubs and plantings that may encroach on the termination.

The fireplace and venting system should be thoroughly inspected before initial use and at least annually by a qualified service technician. Inspection should include ensuring that exhaust or intake passages are unobstructed and vent components are properly assembled and not damaged.

**The homeowner must contact a qualified service technician at once if any abnormal condition is observed.**

If the venting system is disassembled for any reason, a qualified service technician should follow vent installation instructions for proper reassembly and proper sealing of the venting system components. However, more frequent periodic inspections and cleaning should be performed by the homeowner.

#### Inspecting the burner flame appearance

Periodically inspect the burner and pilot flame. Ensure that the burner flame appearance resembles the flame shown in **Figure 39, Page 33**. Any necessary burner flame adjustments must be performed by qualified personnel only. For more information about the pilot flame appearance. Contact a qualified service technician at once if any abnormal condition is observed.

#### Cleaning the glass door and firebox



### WARNING

**Do not use abrasive cleaners on glass. Never clean the glass when it is hot.**

Clean the glass and firebox during the **Burn-in Period**, and then only when necessary and when the fireplace is cool. Wipe the surface with a clean, dampened, soft cloth. Follow with a dry, soft towel as desired. Take care not to scratch the surface. Periodically, remove any build-up caused by the following:

- During start-up, it is normal for condensation to form on the inside of the glass (this condensation and fog will usually disappear in a few minutes). The moisture can cause lint, dust and other airborne particles to cling to the glass surface.
- Initial curing of the high temperature paint and burning off of lubricants used in the manufacturing process may result in a film on the glass.
- A white coating may form on the glass as a result of impurities and minerals in the fuel.

Clean the glass two or three times each heating season, depending on the circumstances present. The following cleaning solutions are approved for use:

- Non-ammonia based glass cleaner
- Gas fireplace/stove glass cleaner

#### Inspecting the glass gasket

Visually inspect the gasket on the backside of the glass door. The gasket surface must be clean, free of irregularities, and seated firmly.

#### Cleaning the control compartment

Keep the control compartment clean by vacuuming or brushing it out at least twice a year. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, et cetera. It is imperative that control compartments, burners and circulating air passageways of the appliance be kept clean.

#### Touching up paint in small areas

Only use a factory-supplied paint kit for any touch-ups. Paint is available at your local IHP dealer. Never attempt to paint a hot fireplace. Do not attempt to repaint the fireplace until the finish is completely cured (**Burn-in Period on Page 39**). If the surface becomes stained or marred, it may be lightly sanded and touched up. Allow 24 hours for the paint to cure at room temperature before turning on the flame.



## CLEANING AND MAINTENANCE *Continued*

### Glass Media

Removing and cleaning the glass media

#### CAUTION

**Risk of personal injury. Allow the media to completely cool before handling.**

Use a clean, dry, empty shop vac to remove glass media. Wash the media in warm, soapy water. Rinse and dry before reinstalling.

Reinstalling the glass media

Carefully follow the placement instructions (*Page 31*). This will ensure a proper flame and safe combustion.

**NOTE:** Improper positioning of media can create carbon build-up and will alter the performance of the fireplace.

**NOTE:** It is important to ensure proper glass media placement per the manual when installing these units. Verify pilot flame is not obstructed. Ensure media does not fall through the pilot cover holes.

Replacing the media. If the media needs replacement, use only the proper replacement media from manufacturer (*Accessories Page 58*).

### Cleaning the burner

Carefully remove the media. Vacuum out any foreign matter on the burner (e.g., lint, carbon, etc.). Ensure the burner ports are free of debris.

### Inspecting the wiring

Refer to the wiring diagram (*Page 51*).

#### CAUTION

**Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.**

#### ATTENTION

Inspect and clean all wire connections. Ensure that there is no wire melting or damage. The inspection should include:

- Terminals at the valve
- ON/OFF switch

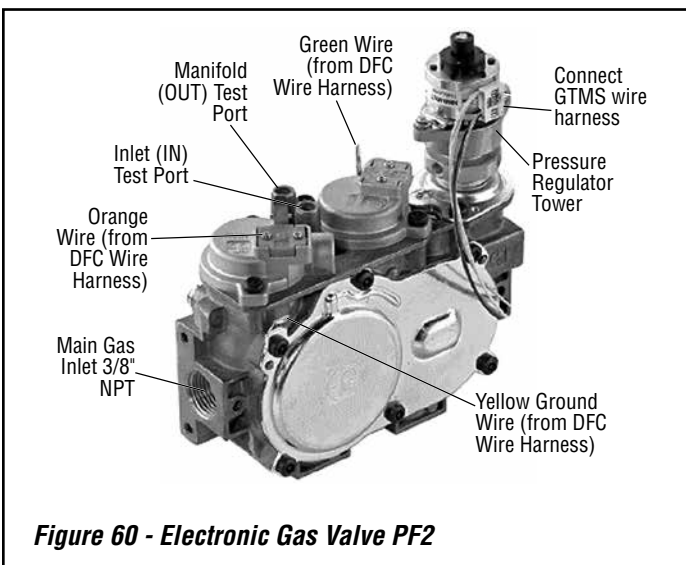

When Gas Pressure Is Too Low

- pilot will not stay lit
- burners will have delayed ignition
- fireplace will not produce specified heat
- propane/LP gas supply might be low (propane/LP units only)

You may feel your gas pressure is too low. If so, contact your local gas supplier.

## TROUBLESHOOTING

Before troubleshooting, ensure that the fireplace main line gas shutoff valve and the wall switch are in the ON position. The following troubleshoots the fireplace only to an elementary level. For detailed remote and ignition system troubleshooting, refer to the instructions provided with the remote.

Detailed valve system troubleshooting should only be performed by a qualified service technician.

	<b>c.</b> Loose wires to ignition module.	Check control compartment for any obviously loose wiring (call a service technician, if necessary).
	<b>d.</b> Air in the gas line.	Purge gas line of air (call a service technician if required).

### 20 Year Limited Warranty

#### THE WARRANTY

Innovative Hearth Products ("IHP") 20 Year Limited Warranty warrants your Superior® Brand gas fireplace, Stove or Insert ("Product") to be free from defects in materials and workmanship at the time of manufacture. The product body, firebox and barrier carry the 20 Year Limited Warranty. Ceramic glass carries the 20 Year Limited Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the 20 Year Limited Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this 20 Year Limited Warranty as described herein.

#### COVERAGE COMMENCEMENT DATE

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

#### EXCLUSIONS AND LIMITATIONS

This 20 Year Limited Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The product body, firebox and barrier carry the 20 Year Limited Warranty from the date of installation. Vent components, trim components and paint are excluded from this 20 Year Limited Warranty. The following do not carry the 20 Year Limited Warranty but are warranted as follows:

- Burner** – Repair or replacement for one year from the date of installation
- Gas components** – Repair or replacement for one year from the date of installation
- Gaskets** – Repair or replacement for one year from the date of installation
- Logs** – Replacement for one year from the date of installation against thermal breakage only
- Optional blowers & remote controls** – Repair or replacement for one year from the date of installation
- Optional glass doors** – Repair or replacement for 90 days from the date of installation
- Tempered glass** – Replacement for one year from the date of installation
- Labor coverage** – Prevailing IHP labor rates apply for the warranty period of the component

**Parts not otherwise listed carry a 90 day warranty from the date of installation.**

**Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.**

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

IHP is not responsible for inadequate fireplace system draft caused by air conditioning and heating systems, mechanical ventilation systems, or general construction conditions which may generate negative pressure in the room in which the appliance is installed. Additionally IHP assumes no responsibility for drafting conditions caused by venting configurations, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions that affect the operation of the unit.

This 20 Year Limited Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction, which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

#### LIMITATION ON LIABILITY

It is expressly agreed and understood that IHP's sole obligation and the purchaser's exclusive remedy under this warranty, under any other warranty, expressed or implied, or in contract, tort or otherwise, shall be limited to replacement, repair, or refund, as specified herein.

Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. The provisions of this 20 Year Limited Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

#### INVESTIGATION OF CLAIMS AGAINST WARRANTY

IHP reserves the right to investigate any and all claims against this 20 Year Limited Warranty and to decide, in its sole discretion, upon the method of settlement.

To receive the benefits and advantages described in this 20 Year Limited Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.
