## **Important Safety Information**

- WARNING: Do not operate appliance with the glass front removed, cracked or broken.
- Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.
- Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.
- Children and adults should be alerted to the hazards of high surface temperature and should stay away to avoid burns or clothing ignition.
- Clothing or other flammable material should not be placed on or near the appliance.
- 6. Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children, and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at-risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children, and other at-risk individuals out of the room and away from hot surfaces.
- Any safety screen, guard or barrier removed for servicing an appliance must be replaced prior to operating the appliance.
- 8. Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, et cetera. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean. See maintenance instructions on Page 63.

#### INTRODUCTION

These vented gas fireplace heaters are sealed combustion, air-circulating gas fireplaces designed for residential and commercial applications.

Electronic fireplaces are designed with an electronic intermittent pilot ignition system. External electrical power is required to operate these units. In the event of a power outage, four (4) **AA** batteries (in battery holder) provide backup power for fireplace operation (excluding the blower).

NOTE: Installation and repair should be done by a qualified service person. The fireplace should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, etc. It is imperative that control compartment, burners, and circulating air passageways of the fireplace be kept clean.

Use only the correct size venting (4-1/2" inner and 7-1/2" outer).

These approved vent system components are labeled for identification. DO NOT use any other manufacturer's vent components with these fireplaces.

#### **CODES AND STANDARDS**

These fireplaces comply with National Safety Standards and are tested and listed by PFS TECO (Report No. F13-094) to ANSI Z21.88•-2019 (in Canada, CSA-2.33•-2019), and CSA-2.17-2017 in both USA and Canada, as vented gas fireplace heaters.

These fireplaces are listed for installation in bedrooms and manufactured homes.

The installation must conform with local codes or, in the absence of local codes, the *National Fuel Gas Code*, ANSI Z223.1/NFPA 54. or the *Natural Gas and Propane Installation Code*, CSA B149.1.

The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the *National Electrical Code*, ANSI/NFPA 70, or the *Canadian Electrical Code*, CAN/CSA C22.1.



The outlet **manifold** test gauge connection is provided on the valve stem (see **Figure 1A**). The **inlet** line gas pressure test point is shown in **Figure 1B**. The control valves have a 3/8" (10 mm) NPT thread inlet and outlet side of the valve.

Figure 1A - MANIFOLD Outlet Gas Pressure Test Point




Propane tanks are at pressures that will cause damage to valve components. Verify that the tanks have step down regulators to reduce the pressure to safe levels.

Testing Inlet Line Gas Pressure (Qualified Technicians Only):

- 1. Turn off gas shutoff valve and electrical.
- 2. Remove 1/8" plug (shown in diagram to the right).
- 3. Install an 1/8" nipple in place of plug.
- 4. Connect manometer to nipple, using an 1/8" NPT air hose nipple/fitting.
- Turn on shutoff valve and check for proper inlet gas pressure.
- 6. Reverse steps 1-5.

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures **in excess of** 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures **equal to or less than** 1/2 psi (3.5 kPa).

#### ORIFICE SIZES—SEA LEVEL TO HIGH ALTITUDE

These fireplaces are tested and approved for installation at elevations of 0 - 4500 ft (0 - 1372 m) above sea level using the standard burner orifice sizes (*Table 5*). For elevations above 4500 ft, contact your gas supplier or qualified service technician.

#### DERATION

At elevations above 4500 ft, the amount of BTU fuel value delivered must be reduced by either:

- Using gas that has been derated by the gas company.
- Changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1—latest edition or, in Canada, the CAN/CGA-B149.1 codes—latest edition.

NOTE: Flame breadth, height and width will diminish 4% for every 1,000 ft of altitude.

IN CANADA—CAN/CGA-2.17-M91 (HIGH ALTITUDE):

THE CONVERSION SHALL BE CARRIED OUT BY A MANUFACTURER'S AUTHORIZED REPRESENTATIVE, IN ACCORDANCE WITH THE REQUIREMENTS OF THE MANUFACTURER, PROVINCIAL OR TERRITORIAL AUTHORITIES HAVING JURISDICTION AND IN ACCORDANCE WITH THE REQUIREMENTS OF THE CAN/CGA-B149.1 OR CAN/CGA-B149.2 INSTALLATION CODES.

#### COMMONWEALTH OF MASSACHUSETTS REQUIREMENTS

These appliances are approved for installation in the US state of Massachusetts if the following additional requirements are met:

- Install this appliance in accordance with Massachusetts Rules and Regulations 248 C.M.R. Sections 4.00 through 8.00.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36 inches (92 centimeters) in length.
- The individual manual shut-off must be a T-handle type valve.

#### MASSACHUSETTS HORIZONTAL VENT REQUIREMENTS

In the Commonwealth of Massachusetts, horizontal terminations installed less than seven (7) feet above the finished grade must comply with the following additional requirements:

- A hard wired carbon monoxide detector with an alarm and battery back-up must be installed on the floor level where the gas fireplace is installed. The carbon monoxide detector must comply with NFPA 720, be ANSI/UL 2034 listed and be ISA certified.
- A metal or plastic identification plate must be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade and be directly in line with the horizontal termination. The sign must read, in print size no less than one-half (1/2) inch in size, GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS.

#### **COLD CLIMATE INSULATION**

For cold climate installations, seal all cracks around your fireplace with noncombustible material and wherever cold air could enter the room. It is especially important to insulate outside chase cavity between studs and under floor on which fireplace rests, if floor is above ground level. Gas line holes and other openings should be caulked or stuffed with unfaced fiberglass insulation.

#### NOTE: Do not use loose, or blown-in insulation in the cavity surrounding the fireplace.

If the fireplace is being installed on a cement slab in cold climates, a sheet of plywood or other raised platform can be placed underneath to prevent conduction of cold transferring to the fireplace and into the room. It also helps to seal inside surfaces and tape for maximum air tightness and caulk firestops.

#### MANUFACTURED HOME REQUIREMENTS

This appliance may be installed in an aftermarket, permanently located, manufactured home (USA only) or mobile home, where not prohibited by local codes.

This appliance must be grounded to the chassis of the manufactured home in accordance with local codes or in the absence of local codes, with the National Electrical Code ANSI / NFPA 70—latest edition or the Canadian Electrical Code CSA C22.1—latest edition.

#### LOCATION

In selecting the location, the aesthetic and functional use of the fireplace are primary concerns. However, vent system routing to the exterior and access to the fuel supply are also important.

Due to high temperatures, the fireplace should be located out of traffic and away from furniture and draperies.


The location should also be free of electrical, plumbing, or other heating/air conditioning ducting.

These direct-vent fireplaces are uniquely suited for installations requiring a utility shelf positioned directly above the fireplace. Utility shelves like these are commonly used for locating television sets and decorative plants.

Be aware that this is a heat producing fireplace. Objects placed above the unit are exposed to elevated temperatures. Do not insulate the space between the fireplace and the area above it.

The minimum height from the base of the fireplace to the underside of combustible materials used to construct a utility shelf in this fashion is shown in *Table 9* (see *Page 15*).

Figure 2 - Typical Locations and Venting




#### **VENT TERMINATION CLEARANCES**

These instructions should be used as a guideline and do not supersede local codes in any way. Install venting with the most restrictive requirements as outlined in these instructions, local codes, these instructions, the current National Fuel Gas Code (ANSI Z223.1/NFPA 54) in the USA or the current standards of CAN/CGA-B149.1 in Canada.






#### **Horizontal Vent Termination Clearances**

The horizontal vent termination must have a minimum of 6" (152 mm) clearance to any overhead combustible projection of 2-1/2" (64 mm) or less (*Figure 4*). For projections exceeding 2-1/2" (64 mm) (*Figure 4*). For additional vent location restrictions refer to *Table 7*.

All horizontal terminations may be located as close as 6" (152mm) to any (non-combustible and combustible) exterior sidewall. This distance may be decreased to 2" (51mm) for noncombustible exterior sidewalls with all approved terminations (*Table 7*).



#### MINIMUM CLEARANCES TO COMBUSTIBLES

#### **Fireplace And Vent Clearances**

The fireplace is approved with zero clearance to combustible materials on all sides (*Table 8*), with the following exception: The unit may not be recessed (allowance made for mantel legs / side trim in (*Figure 5, Page 16*). When the unit is installed with one side flush with a wall, the wall on the other side of the unit must not extend beyond the front edge of the unit (*Figure 5, Page 16*).

The fireplace must be mounted on a fully supported base extending the full width and depth of the unit. The fireplace may be located on or near conventional construction materials. However, if installed on combustible materials, such as carpeting, vinyl, tile or other combustible material other than wood flooring, the appliance shall be installed on a metal or wood panel extending the full width and depth of the appliance.

#### **Hearth Extension**

A hearth extension is not required with this fireplace. If a hearth extension is used, do not block the facade from being installed or removed. Any hearth extension used is for appearance only and does not have to conform to standard hearth extension installation requirements.

#### **Shelf Height**

To provide for the lowest possible shelf surface, use the rear vent model. For top vent models, the venting attached to the top vent should be routed in a way to minimize obstructions to the space above the fireplace. Do not insulate the space between the fireplace and the area above it (*Table 9*). The minimum height from the base of the fireplace to the underside of combustible materials used to construct a utility shelf in this fashion is shown in *Table 9*.

Figure 5 - Combustible Side Clearances





Figure 6 - Mantel Height



#### Wall Finishes / Surrounds / Mantels

NOTE: Combustible wall finish materials and/or surround materials must not be allowed to encroach the area defined by the fireplace front face (black sheet metal). Non-combustible material up to 6 inches in depth, such as surrounds may be positioned in front of or overlapping the fireplace face but they must not cover any portion of the removable glass panel or impede the removal or installation of facade.

Non-combustible materials, such as surrounds and other fireplace trim, may be installed on the fireplace face, but they must not cover any portion of the removable glass panel or impede the removal or installation of facade.

Vertical installation clearances to combustible mantels vary according to the depth of the mantel (*Figure 6*). Mantels constructed of non-combustible materials may be installed at any height above the fireplace opening. However, do not allow anything to hang below the fireplace hood.

Minimum clearance requirements include any projections such as shelves, window sills, mantels, etc. above the fireplace.

NOTE: To avoid heat-related finish damage, we recommend the use of high temperature paint (rated 175° F or higher) on the underside of the mantel.

#### INSTALLATION PREPARATION

The fireplace is shipped with all gas controls and components installed and pre-wired. Before installing the fireplace, follow these steps:

- 1. Remove the shipping carton, and retain the front of the carton (used to protect the fireplace during construction).
- **2.** Remove the shipping pad, exposing the front glass door.
- 3. Remove the glass door (Pages 48 50).

NOTE: Place the glass door on the shipping carton to protect its surface.

#### INSTALLATION SEQUENCE

#### 1. Construct the Fireplace Framing

- 1. Frame the fireplace as illustrated in *Table 10*. For corner framing installations, use *Table 11*. All framing details must allow for a minimum clearance to combustible framing members as shown in *Table 8*.
- 2. If the fireplace is to be elevated above floor level, a solid continuous platform must be constructed below the fireplace.

NOTE: Headers may be in direct contact with the fireplace top standoff spacers when they are bent up vertically, and header shield installed, maintaining the 4" clearance to the fireplace top, but must not be supported by them or notched to fit around them. All construction above the fireplace must be self-supporting. DO NOT use the fireplace for structural support.



#### 2. Prepare the Fireplace Top Spacers

- 1. The two (2) 4" standoff spacers on top of the fireplace cabinet are shipped flat. Remove the screw adjacent to the detached end (*Figure 7A*).
- 2. Bend the standoffs as shown (Figure 7B).
- 3. Align the hole in the standoff with the hole in the fireplace top, and secure with the screw that was removed in **Step 1** (*Figure 7B*).

Figure 7A - Unassembled Standoff






#### 3. Route the Gas Supply Line to the Fireplace

1. Route a 1/2" (13 mm) gas line to the left side of the fireplace (Figure 8).

**NOTE:** Gas lines must be routed, assembled, and made of materials that are in strict accordance with local codes and regulations. All fireplaces are factory-equipped with a flexible gas line connector and a 1/2" shutoff valve (*Figure 30*, *Page 40*).

#### **Proper Sizing of Gas Line**

Properly size and route the gas supply line from the supply regulator to the area where the appliance is to be installed per requirements outlined in the National Fuel Gas Code, NFPA 54—latest edition (USA) or CAN/CGA-B149.1—latest edition (Canada).

The gas supply line should not be connected to the appliance until step 12. Connect the Gas Line (Page 40).

#### NOTE:

- All fireplaces are factory-equipped with a flexible gas line connector and 1/2" shutoff valve (Figure 30, Page 40).
- See Massachusetts Horizontal Vent Requirements for additional requirements for installations in the state of Massachusetts in the USA.
- A pipe joint compound rated for gas should be used on the threaded joints. Ensure propane-resistant
  compounds are used in propane applications. Be very careful that the pipe compound does not get inside the
  pipe.
- A sediment trap in the supply line as close as possible to the fireplace is recommended.
- Check with the local building official for local code requirements (e.g., Are below grade penetrations of the gas line allowed?, etc).

## **A** CAUTION

If propane is used, be aware that with a tank that is too small (i.e., under 100 lbs, if this is the only gas appliance in the dwelling—see NPFA 58), there may be a loss of pressure. This can result in insufficient fuel delivery that can cause sooting, delayed ignition, or other malfunctions. Any damage resulting from an improper installation is not covered by the limited warranty.

#### 4. Determining Vent Setup in the Combination Venting Unit

Combination venting units are shipped with round outer flue covers and inner flue cover plates installed that will require removal before connecting the vent pipe. If you require a rear vented unit, remove the round outer rear flue cover (2 screws, Figure 9A) and the inner rear flue cover plate (4 screws, Figure 9B). If you require a top vented unit, remove the round outer top flue cover (2 screws, Figure 9A) and the inner top flue cover plate (2 screws, Figure 9B).

NOTE: It may be necessary to remove the upper lintel and baffle to access the inner flue cover plates (3 screws).





#### 5. Installing Non-Combustible Front Fireboard Standoff and Header Shield

A non-combustible standoff board is provided with the fireplace to prevent overlap of drywall or other material of portions of the fireplace that may be prone to the buildup of heat. It is supported by a middle bracket and two side brackets.











Separate and note metal side (2) and center (1) brackets.

**Step 1:** Remove two screws from the top and side of the unit. Bend the side bracket securing tab over the edge of the unit and secure. Secure bracket to the top through the clearance screw hole.









**Step 2:** Remove screw holding standoff to firebox, bend to 4" tall (as seen above) and attach screw.

**Step 3:** Install the header shield by sliding it into the slot in the standoffs.

**Step 4:** Fireboard standoff can be secured to the capture screw holes.

#### 6. Rough in the Electrical Supply, if Needed

As necessary, rough in the fireplace electrical supply per NEC and local codes.

#### 7. Place the Fireplace in the Framing and Secure

NOTE: Nailing flanges, combustible members, and screw heads in areas directly adjacent to the nailing flanges are EXEMPT from the 1/2" clearance to combustible requirements for the firebox outer wrapper.

NOTE: Combustible framing may be in direct contact with the nailing flanges and may be located within 1/2" of screw heads and the firebox wrapper in areas adjacent to the nailing flanges.

Frame the opening to the exact dimensions specified in the framing details in this manual.


Figure 10 - Flush Mounting Bracket

- **1.** Bend out the appropriate nailing flanges for the drywall / finish material to be used (*Figure 10*). Nailing flanges are provided for:
  - 1/2", and
  - 5/8" framing depths.
- Secure the fireplace to the side framing members using the unit's nailing flanges —one top and bottom on each side of the fireplace front (*Figure* 10). Use 8d nails or the equivalent.
- **3.** A flush-mount mounting kit is available for purchase (order cat. number **F3695**). Attach the flush mounting bracket using two screws per bracket as shown in *Figure 10*.

Flush Mounting Bracket

#### 7A. (Optional Accessory) Install The Rock/Stone Stop Kit, if Applicable

For use only with these fireplaces with thick facing materials and a decorative facade. Maximum allowed depth of non-combustible material is 6".


#### INSTALLATION INSTRUCTIONS


1. Unbox items. Included items: 4 piece trim kit, 3 self-tapping screws and instructions.



#### Install The Rock/Stone Stop Kit (continued)

- 2. Place Top trim piece and hood that is included with façade on unit and install using three screws (see Figure 11B).
- 3. Remove four shoulder screws from fireplace.
- Install one side of trim kit on fireplace using 2 previously removed shoulder screws.
- **5.** Install other side of trim kit on fireplace using 2 previously removed shoulder screws.
- **6.** Install bottom trim if needed using 3 provided self-tapping screws (see **Figure 11C**).
- 7. Once trim kit is installed the facade can be installed on the fireplace. NOTE: The façade will not sit completely flush against trim kit (see Figure 11D).







#### **VENT SYSTEM PREPARATION**

#### 8. Select a Horizontal or Vertical Vent System

1. With the fireplace secured in the framing, determine the vent route and identify the exterior termination location. The following sections describe vertical (roof) and horizontal (exterior wall) vent applications. Use only approved vent components.

**NOTE:** This fireplace must be vented directly to the outside.



The vent system may not service multiple appliances, and must never be connected to a flue serving a separate solid fuel burning appliance.

NOTE: The vent pipe is tested to be run inside an enclosed wall. There is no requirement for inspection openings in the enclosing wall at any of the joints in the vent pipe.


#### 9. Install the Vent Restrictor (if necessary)

- 1. Use the vent run descriptions in *Figure 12* to determine if a vent restrictor is necessary.
- 2. If necessary, assemble the vent restrictor and wing as detailed in *Figure 13C*.
- 3. If necessary, install the appropriate vent restrictor (*Figure 13A or 13B*).

NOTE: If installing the vent restrictor in a rear vent application, ensure the factory-installed intake air baffle is in place (Figure 13B).

NOTE: The vent restrictor is shipped in the firebox.

NOTE: When venting Rear Horizontal with slip collar and termination only, install base vent restrictor with the breakaway portion raised.

#### **Vent Restrictor with Vertical Terminations**

When vertically terminating the vent system through the roof and using the vent restrictor, install the vent restrictor in the top vent of the fireplace outlet.

If installing more than 6 ft of vertical venting, install the restrictor (*Figure 13A*), from inside or outside the unit, in the inner fireplace collar. The vent restrictor is held in place by friction.

#### **Vent Restrictor with Horizontal Terminations**

When horizontally terminating a vent system with a vertical vent run up to 6 ft through an exterior wall, no vent restrictor is required.

If installing more than 6 ft of vertical venting, install the restrictor (*Figure 13B*), from inside or outside the unit, in the inner fireplace collar. The vent restrictor is held in place by friction.

Figure 13A - Vent Restrictor Installation, Top Vent




Figure 13B - Vent Vestrictor Installation, Rear Vent





Figure 13C - Vent Restrictor Assembly

#### 10. Connecting the Vent Pipe

Secure Vent® SV4.5 direct-vent system components are unitized concentric pipe components featuring positive twist lock connections (*Figures 14 - 15*). All of the fireplaces covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the fireplace/vent collar to create the positive twist lock connection.


- 1. Align the dimpled end over the collar, adjusting the radial alignment until the four (4) locking dimples are aligned with the inlet of the four (4) inclined channels on the collar (*Figures 14 15*).
- 2. Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels.


NOTE: The unitized design of the Secure Vent® components will engage and seal both the inner and outer vent pipe.


**3.** If desired, a #6 x 1/2" sheet metal screw can be used at the joint, but is not required as the pipe will securely lock when twisted (*Figure 15*).

Where required, a telescopic vent section (SV4.5LA) may be used to provide the installer with an option to install in tight and confined spaces, or where the vent run made up of fixed length pieces develops a joint in a undesirable location, or will not build up to the required length. The SV4.5LA Telescopic Vent Section has an effective length of from 1-1/2 to 7" (38 to 178 mm). The SV4.5LA is fitted with a locking inclined channel end (identical to a normal vent section component) and a plain end with three (3) pilot holes. Slip the plain end over the locking channel end of a standard SV4.5 vent component the required distance and secure with three (3) screws.

#### Vent elbows

Vent elbows are available in 90° and 45° configurations. Refer to *Figure 16* for the SV4.5E45 and SV4.5E90 elbow dimensions. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element.

1. Rotate the elbow in a clockwise direction (to avoid the possibility of unlocking any of the previously connected vent sections) for proper alignment (*Figure 16*). See **Connecting the vent pipe** for more information.

#### Clearance to combustibles

Maintain the minimum clearance to combustibles (e.g., framing, attic, ceiling insulation, etc.). For all vertical runs:

NOTE: Attic insulation shield (H3907, see *Page 56*) must be installed when blown or loose-fill insulation is used, and is required for all attic installations. For all horizontal/inclined runs:

- 1" (26 mm) from all sides
- 3" (77 mm) from the top
  1" (26 mm) from the sides
- 1" (26 mm) from the bottom

#### 11. Install the Vent System

#### Install the Vertical Termination Vent System

These instructions should be used as a guideline and do not supersede local codes in any way. Install venting with the most restrictive requirements as outlined in these instructions, local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 in Canada.

Ensure clearances are in accordance with local installation codes and the requirements of the gas supplier.

Vertical vent systems terminate through the roof. The minimum vent height above the roof and/or adjacent walls is specified in ANSI Z223.1 (In Canada, the current CAN/CGA-B149.1 installation code) by major building codes. Always consult your local codes for specific requirements. A general guide to follow is the gas vent rule (Table 6, Page 13).


The following figures and their associated vertical vent tables illustrate the various configurations that are possible for use with these fireplaces. Secure Vent® pipe is shown in these figures; Secure Flex® pipe may also be used. A table summarizes each configuration's minimum and maximum vertical and horizontal length parameters for a variety of applications.

1. Refer to Figure 22 and Tables 16 - 19 on Pages 29 - 30 to select the type of vertical installation desired. Elbows are available in 90° and 45° configurations. Refer to Figure 16 on Page 24 for the SV4.5E45 and SV4.5E90 elbow dimensional specifications.

#### Vertical (Straight) Installation

1. Determine the number of straight vent sections required. See Effective Vent Length (Pages 24 - 25) for more information. Plan the vent lengths so that a joint does not occur at the intersection of ceiling or roof joists.


Figure 17 - Vertical (Straight) Installation



#### **Vertical (Offset) Installation**

- Analyze the vent route and determine the number of vent sections and elbows required. See Effective Vent Length
  (Pages 24 25) for more information. Plan the venting so that a joint does not occur in the ceiling or roof joists.
  Allow for elbows (Figure 16, Page 24). Maintain clearances to combustibles equal to or greater than minimum specified in these instructions.
- 2. Frame the ceiling opening. Use a plumb line from the ceiling above the fireplace to locate the center of the vertical run. Cut and/or frame an opening, 10-1/2 x 10-1/2" (267 x 267 mm) inside dimensions, about this center mark (*Figure 18*).

Figure 18 - Framing the Ceiling Opening




- 3. Attach the vent components to the fireplace. See Connecting the vent pipe (Page 24).
- 4. Attach the vent components to each other. See Connecting the vent pipe (Page 24).
- **5.** Install firestop/spacer at ceiling. When using Secure Vent®, use SV4.5VF firestop/spacer at ceiling joists; when using Secure Flex®, use SF4.5VF firestop/spacer. If there is living space above the ceiling level, the firestop/spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist. Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner.
  - Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections. The gap between the vent pipe and a vertical firestop can be sealed with non-combustible caulking.

NOTE: Attic Insulation Shield (H3907) must be installed when blown or loose-fill insulation is used, and is required for all attic installations.

**6.** Support the vertical vent run sections. Support the vertical portion of the venting system every 8 ft (2.4 m) above the fireplace vent outlet. One method of support is by utilizing field provided support straps (conventional plumber's tape). Secure the plumber's tape to the framing members with nails or screws. Loop the tape around the vent, securing the ends of the tape to the framing. If desired, sheet metal screws #6 x 1/2" length may be used to secure the support straps to the vent pipe (*Figure 19*).


NOTE: Proper venting support is very important.

- 7. Change vent direction of horizontal/inclined run. Install the SV4.5E45 and SV4.5E90 elbows in the same manner as the straight vent sections. See **Vent elbows** (*Page 24*) for more information.
- **8.** Continue installation of horizontal/inclined sections. Continue with the installation of the straight vent sections in horizontal/inclined run. Install support straps every 5 ft (1.52 m) along horizontal/inclined vent runs using conventional plumber's tape in a direction away from the fireplace.
  - Rise per foot run ratios are acceptable all the way to level. For best results, maintain the horizontal/inclined run in a straight (no dips), slightly elevated plane of approximately 1/4" per 1 ft (20 mm per 1 m).
  - Maintain the required clearances to combustibles (*Page 26*).
- 9. Frame the roof opening. Identify the location for the vent at the roof. Cut and/or frame opening (Table 15).

- 10. Install the roof flashing. Extend the vent sections through the roof structure. Install the roof flashing over the vent section and position such that the vent column rises vertically (use carpenter's level). Nail along perimeter to secure flashing or adjust roofing to overlap the flashing edges at top and sides only and trim where necessary. Seal the top and both sides of the flashing with waterproof caulking. The flashing must overlap the roofing material along the bottom.
- 11. Install the storm collar. Install the storm collar, supplied with the flashing, over the vent/flashing joint (*Figure 20*). Loosen the storm collar screw. Slide collar down until it meets the top of the flashing. Tighten the adjusting screw. Apply non-combustible caulking or mastic around the circumference of the joint to provide a water tight seal.

Figure 20 - Installing the Storm Collar





Figure 21 - Installing the Vertical Termination



#### 12. Install the vertical termination

The final step involves installation of the SV4.5CGV-1 vertical termination. Extend the vent sections to the correct height (*Table 6, Page 13*). The SV4.5CGV-1 Vertical Termination (*Figure 21*) installs in the exact same fashion as any other Secure Vent® section. Align the termination over the end of the previously installed section, adjusting the radial alignment until the four (4) locking dimples of the termination are aligned with the inlets of the four (4) incline channels of the last vent section. Push the termination down until it fully engages, then twist the termination clockwise running the dimples down and along the incline channels until they seat at the end of the channels.

If the vent system extends more than 5 ft (1.5 m) above the roof flashing, stabilizers may be necessary. Additional screws may be used at section joints for added stability. Guide wires or roof support assemblies may be attached to the joint for additional support on multiple joint configurations.

#### **Vertical Vent Figures/Tables**

NOTE: Secure Vent® rigid vent pipe is shown in the figures; Secure Flex® flexible vent pipe may also be used.

NOTE: Rise per foot run ratios are acceptable all the way to level. For best results, maintain the horizontal/ inclined run in a straight (no dips), slightly elevated plane of approximately 1/4" per 1 ft (20 mm per 1 m).

NOTE: SV4.5VF (Secure Vent), SF4.5VF (Secure Flex) firestop/spacer must be used anytime vent pipe passes through a combustible floor or ceiling. SV4.5HF (Secure Vent), SF4.5HF (Secure Flex)firestop/spacer must be used anytime vent pipe passes through a combustible wall.

NOTE: Two (2) 45° elbows may be used in place of one (1) 90° elbow. The same rise to run ratios, as shown in the venting figures for 90° elbows, must be followed if 45° elbows are used.

Figure 22 - Top Vent—Straight




#### **Install the Horizontal Termination Vent System**

These instructions should be used as a guideline and do not supersede local codes in any way. Install venting with the most restrictive requirements as outlined in these instructions, local codes, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 in Canada.

Ensure clearances are in accordance with local installation codes and the requirements of the gas supplier.

Horizontal vent systems terminate through an outside wall. Building Codes limit or prohibit terminating in specific areas (*Table 7, Page 14*).

The following figures and their associated horizontal vent tables illustrate the various configurations that are possible for use with these fireplaces. Secure Vent® pipe is shown in these figures; Secure Flex® pipe may also be used. A table summarizes each configuration's minimum and maximum vertical and horizontal length parameters for a variety of applications. For more information on connecting the vent pipe, see *Page 24*.

Assure that adequate space between the bottom of the horizontal run and the attic is provided so that blown in insulation does not contact the vent.




Figure 23 - Typical Horizontal Vent Installation

- Analyze the vent route and determine the number of vent sections and elbows required. See Effective Vent
   Length (Pages 24 25) for more information. Plan the venting so that a joint does not occur in the ceiling or
   roof joists. Allow for elbows (Figure 16, Page 24). Maintain clearances to combustibles equal to or greater than
   minimum specified in these instructions (Page 26).
- 2. Frame the exterior wall opening. Locate the center of the vent outlet on the exterior wall (*Table 10, Page 18*). Cut and/or frame an opening, 10-1/2 x 12-1/8" (267 x 308 mm) inside dimensions, about this center.
- 3. Frame the ceiling opening. If the vertical route is to penetrate a ceiling, use plumb line to locate the center above the fireplace. Cut and/or frame an opening, 10-1/2 x 10-1/2" (267 x 267 mm) inside dimensions, about this center (*Figure 18, Page 27*).
- 4. Attach the vent components to the fireplace. See Connecting the vent pipe (Page 24).
- 5. Attach the vent components to each other. See Connecting the vent pipe (Page 24).

- **6.** Install the firestop/spacer at the ceiling. When using Secure Vent®, use SV4.5VF firestop/spacer at ceiling joists; when using Secure Flex®, use SF4.5VF firestop/spacer. If there is living space above the ceiling level, the firestop/ spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist. Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner.
  - Maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections.
- 7. Support the vertical run sections. On the vertical run, support the venting system every 8 ft (2.4 m) above the fireplace vent outlet with field provided support straps (Plumber's tape). Attach the straps to the vent pipe and secure to the framing members with nails or screws (*Figure 19, Page 27*). Change vent direction. At transition from or to a horizontal/inclined run, install SV4.5E45 or SV4.5E90 elbows in the same manner as the straight vent sections. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element. Twist elbow sections in a clockwise direction only so as to avoid the possibility of unlocking any of the previously connected vent sections (*Figure 16, Page 24*).
- 9. Continue installation of horizontal/inclined sections. Continue with the installation of the straight vent sections in horizontal/inclined run. Install support straps every 5 ft. (1.52 m) along horizontal/inclined vent runs using conventional plumber's tape (*Figure 23, Page 31*). Maintain the horizontal/inclined run in a straight (no dips), slightly elevated plane. The recommended incline is approximately 1/4" per 1 ft (20 mm per 1 m) horizontal, in a direction away from the fireplace. Smaller rise per foot run ratios are acceptable all the way to at or near level. Use a carpenter's level to measure from a constant surface and adjust the support straps as necessary. Maintain the required clearances to combustibles (*Page 26*).
- 10. Assemble the vent run to the exterior wall. If not previously measured, locate the center of the vent at the exterior wall. Prepare the opening. Assemble the vent system until the terminus of the last section is within 7" (178 mm) to 11-1/4" (286 mm) inboard of the exterior surface to which the SV4.5HT termination is to be attached (*Figure 24, Page 33*). If the terminus of the last section is not within this distance, use the telescopic vent section SV4.5LA, as the last vent section. *Table 20, Page 34* lists the additional venting components needed (in addition to the termination and adaptor) for a range of wall thicknesses.
- **11.** Attach the termination adaptor. Attach the adaptor (SV4.5RCH, provided with the termination) to the vent section or telescoping vent section, elbow or fireplace collar (*Figure 24, Page 33*).
- 12. Install the firestop/spacer at the exterior wall. When using the square termination, install SV4.5HF (Secure Vent®), SF4.5HF (Secure Flex®) Firestop/Spacer over the opening at the exterior side of the framing, long side up, with the 3" spacer clearance at the top (*Figure 24, Page 33*) and nail into place.
  - NOTE: The firestop/spacer may also be installed over the opening at the interior side of the framing.
- 13. Install the termination. From outside the exterior wall, slide the collars of the termination onto the adaptor until the termination seats against the exterior wall surface to which it will be attached. Orient the housing of the termination with the arrow pointed upwards. Secure the termination to the exterior wall. The horizontal termination must not be recessed into the exterior wall or siding by more than the 1-1/4" (32 mm) (Figure 25, Paue 33).

NOTE: If the venting exits the building below grade, or close to grade, see Installation Accessories on *Page* 56 for available snorkel terminations. The termination must be above grade and above the expected level of snow accumulation


NOTE: The vent termination is hot while in operation and for a period of time following the use of the fireplace. To prevent contact with hot surfaces, use a horizontal termination guard; available for purchase at your local dealer.

The horizontal terminations have been designed to perform in a wide range of weather conditions. Our terminations meet or exceed industry standards.

When selecting the locations of your horizontal terminations, do not place the termination where water from eaves and adjoining rooflines may create a heavy flow of cascading water onto the termination cap. If the cap must be placed where the possibility of cascading water exists, it is the responsibility of the builder to direct the water away from the termination cap by using gutters or other means.

Take care to carefully follow the installation instructions for the termination, including the use of silicone caulking where required.

NOTE: To help minimize water infiltration install the firestop/spacer (SV4.5HF) on the exterior side of the wall. The firestop may be caulked with mill base caulk (such as 10K81) or high-temperature silicone.

Figure 25 - Venting Connection and Exterior Wall Recessing of the Horizontal Termination






Table 22 - Top Vent—One 90° Elbow, Elbow Connection at Fireplace



#### **Vertical or Horizontal Venting Using Secure Flex® Kits and Components**


#### When Secure Flex® kits are used in a rear flue, horizontal termination installation, at least 1 ft of vertical rise is required.

Secure Flex venting kits and components may be used in any other vent installation where rigid Secure Vent® (SV4.5) direct-vent components can be used. All restrictions, clearances, and allowances pertaining to rigid vent also apply to flexible vent. Do NOT modify Secure Flex kits. Also, do NOT join separate sections of flex vent together. Secure Flex kits can be installed on the end of a Secure Vent (SV4.5) rigid vent run, provided that doing so does not violate any of the venting length, height, routing, horizontal to vertical ratio requirements, or clearance considerations detailed in this manual. When combined, a rigid vent should not be installed between two flexible vents.

Secure Flex kits come with an included adaptor that can be installed on the fireplace collar or the inclined channel end of the last Secure Vent (SV4.5) vent section in a rigid system in the exact same fashion as any other Secure Vent section. Align the dimpled end of the adaptor over the previously installed section or fireplace collar, adjusting the radial alignment until the four locking dimples of the adaptor are aligned with the inlets of the four incline channels of the last vent section or collar. Push on the adaptor until it is fully engaged, then twist the adaptor clockwise running the dimples down and along the incline channels until they seat at the end of the channels.

#### 1. Install the Inner Flex Pipe.

- A. Install the small gear clamp loosely around the inner flexible vent, then push it back out of the way.
- **B.** Apply a bead of Mill-Pac Black (700 °F) high temperature sealant (P/N 10K81) to the inner adaptor collar, approximately 1/2" from the end.
- **C.** Pull and extend the inner flexible vent.
- **D.** Slide the inner flex vent over the adaptor collar at least 1-3/4".

#### NOTE: Ensure the flex vent is free from damage or tears.

- E. Slide the gear clamp down and tighten it fully to secure the flexible vent to the adaptor inner collar approximately 3/4" from the end of the flex.
- **F.** Install three (3) sheet metal screws 120° apart through the flexible vent and into the adaptor collar just below the gear clamp to provide additional security to the connection.

#### 2. Install the outer Flex Pipe.

- **A.** Install the large gear clamp loosely around the outer flexible vent pipe, then push it back out of the way.
- **B.** Apply a bead of Mill-Pac Black (700 °F) high temperature sealant (P/N 10K81) to the outer adaptor collar. Cover to the grooves of the collar that extend approximately 1" from the end and to the flat surface, approximately 1 3/8" from the end.
- C. Pull and extend the outer flexible vent.
- **D.** Slide the outer flexible vent over the adaptor collar. Ensure the flexible vent completely engages the adaptor collar 1-3/4" from the end, and that it is free from damage or tears.
- **E.** Slide the gear clamp down and tighten it fully to secure the flexible vent to the adaptor outer collar approximately 3/4" from the end of the flexible vent.

- **F.** Install three (3) sheet metal screws 120° apart through the flexible vent and into the adaptor collar just below the gear clamp to provide additional security to the connection.
- 3. Route the flexible vent.

NOTE: Ensure that the flexible vent is properly routed to provide the required clearance. Do NOT allow the flexible vent to bend in a radius tighter than 5" (127 mm) (*Figure 27, Page 37*). Place the internal flexible vent spacers evenly and avoid kinking the inner vent. Support horizontal sections of flexible vent with metal straps at 2 ft (0.61 m) intervals.

- 4. Install firestop/spacers at ceiling and wall penetrations.
  - SF4.5VF firestop/spacer for ceilings
  - SF4.5HF firestop/spacer for walls

NOTE: See the appropriate sections and figures shown throughout the venting section for installation requirements.

5. Attach the flexible vent to the termination.

NOTE: Secure Flex® components can be purchased separately and attached to bulk lengths of Secure Flex flexible vent cut to size at the job site. Attach the flexible vent to the Secure Flex terminations as it was attached to the adaptor (Figure 26, Page 37).

NOTE: Attach Secure Flex vent to Secure Flex terminations only. Do NOT substitute Secure Vent® terminations or Secure Vent adaptor for Secure Flex components. Secure Flex termination and adaptor collars are a different circumference than Secure Vent collars. Secure Flex vent has an longer center tube to improve ease-of-installation.

#### 12. Complete the Field Wiring

## **A** CAUTION

The ground supply lead must be connected to the wire attached to the green ground screw located on the outlet box (see wiring diagrams). Failure to do so will result in a potential safety hazard. The appliance must be electrically grounded in accordance with local codes or, in the absence of local codes, the National Electrical Code, ANSI/NFPA 70—latest edition (in Canada, the current CSA C22.1 Canadian Electrical Code).

## **A** CAUTION

Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation.



- 1. Route a 3-wire, 120 Vac, 60 Hz, 1 ph power supply to the fireplace junction box.
- Remove the electrical inlet cover plate from the side of the unit by removing the plate's securing screws (Table 12, Page 18).
- **3.** If unit is not supplied with a strain relief, remove the cover plate knockout. Then, feed the power supply wire through the knockout opening and into the unit junction box.

## **A** WARNING

Electronic models of these appliances are equipped with a three-prong (grounding) plug utilized in connecting the electronic components to the junction box in the lower compartment. This grounding plug provides protection against shock hazard and should be plugged directly into a properly grounded three-prong receptacle. DO NOT cut or remove the grounding prong from the plug.

- 4. Connect the black power supply wire to the lower outlet's black and red pigtail lead (*Figures 28* and 29). Connect the white power supply wire to the outlet's common terminal.
- **5.** Connect the ground supply wire to the pigtail lead attached to the outlet's green ground screw. Restrain the inlet power lead per NEC or local codes.
- **6.** After the wiring is complete, replace the cover plate.


#### 13. Connect the Gas Line

All codes require a shutoff valve mounted in the supply line. *Figure 30* illustrates two methods for connecting the gas supply. The flex-line method is acceptable in the U.S., however, Canadian requirements vary depending on locality. Installation must be in compliance with local codes.

NOTE: A sediment trap is recommended in the gas piping within the home to prevent moisture and debris in the line from damaging the valve.

NOTE: Secure all joints tightly using appropriate tools and sealing compounds (ensure propane resistant compounds are used in propane applications). Seal around the gas line to prevent cold air leakage. Gas line holes and other openings can be caulked or stuffed with unfaced fiberglass insulation.

These fireplaces are equipped with a gas flex line for use (where permitted) in connecting the unit to the gas line. A gas flex line is provided to aid in attaching the direct-vent fireplace to the gas supply. The gas flex line can only be used where local codes permit. The flex line is rated for both natural and propane gas. A manual shut off valve is also provided with the flex line.

The gas control valve is located in the lower control compartment (*Figure 1B, Page 9*).

#### **Access the Control Compartment**

#### See Page 61 for instructions on Accessing the Control Compartment.

Secure all joints tightly using appropriate tools and sealing compounds (ensure propane resistant compounds are used in propane applications). Optionally, seal around the gas line to prevent cold air leakage. Gas line holes and other openings can be caulked or stuffed with unfaced fiberglass insulation.

All codes require a shutoff valve mounted in the supply line. The orientation of the shutoff valve should face the front. *Figure 30*, *Page 40* illustrates two methods for connecting the gas supply. A sediment trap is recommended to prevent moisture and debris in the gas line from damaging the valve.

#### **Test Factory and Field Connections for Gas Leaks**

## **A** WARNING

#### Never use an open flame to check for leaks.

Turn on gas supply and test for gas leaks, using a gas leak test solution—also known as bubble leak solution.

NOTE: Using a soapy water solution is an effective leak test solution but it is not recommended, because the soap residue that is left on the pipes/fittings can result in corrosion over time.

- 1. Light the fireplace (refer to the lighting instructions label in the control compartment or *Pages 68-69*).
- 2. Brush all joints and connections with the gas leak test solution to check for leaks. If bubbles are formed, or gas odor is detected, turn the gas control knob (OFF/PILOT/ON) to the OFF position (millivolt units), or turn the receiver or remote control to the OFF position (electronic units). Either tighten or refasten the leaking connection, and then retest as described above.
- 3. When the gas lines are tested and leak free, rinse off the leak testing solution

#### 14. Verify Proper Fireplace Operation


- 1. With the gas line installed, inspect the system before closing the front of the unit.
- 2. Follow the pilot lighting instructions:
- Electronic Systems (Pages 68-69)

NOTE: When lighting the fireplace for the first time, it will take a few minutes for the gas line to purge itself of air. When purged, the pilot and burner will light and operate as indicated. Subsequent lighting of the fireplace will not require purging. Inspect the pilot flame (carefully remove logs, if necessary).

#### **Electronic Fireplace Inspection**

To light the burner, turn ON the wall or remote control switch. Ensure the igniter lights the pilot. The pilot flame should engulf the thermocouple. Pilot should have two flames, one that engulfs the thermocouple and one that lights the burner (see **Figure 31**, **Page 42**).

#### 15. Initialize the Wireless Wall Switch for the First Time

1. Install the two (2) CR2032 batteries.

NOTE: Check the polarity (+/-) of the batteries and insert them into the battery bay as indicated below. NOTE: See Operation Instructions provided with the wireless wall switch.

2. Learning Transmitter To Module (Pairing the Remote to the Control Module)

To pair the remote transmitter to the control module, press the learn switch and release. There should be an audible beep indicating the module is ready to accept a transmitter code. Press any button on the transmitter within 60-seconds to send a signal. If the signal is received, the module should beep indicating the signal was received.

NOTE: The module will remain "open" and ready to accept a signal for 60-seconds after the learn button is pressed.

The control module will learn up to 3 different transmitter security codes (only one may be a thermostat style).

Security codes will be retained in memory indefinitely if power is removed.

Press and hold learn switch on for 6-seconds then the release to clear all transmitter security codes retained in memory. Repeat learn process as needed.

#### 16. Installing the Firebox Liners

- If accessory panels are desired, the metal front ramp must be changed prior to installation. See *Page 43*.
   If accessory logs are desired, the rear panel must be removed to uncover the log positioning tabs prior to installation of the panels. See *Page 45*.
- 2. After all changes have been made, please review how to install the hand bend brackets described on the next page.
- 3. Carefully position the rear panel, upper edge first, in the firebox against the rear wall.
- **4.** While holding the rear panel, carefully position the left side panel in the firebox.
- **5.** Carefully position the right side panel in the firebox.







- Hand Bend one of the brackets into a z-shape as shown in *Figure 35B*. The Long Leg of the bracket must be straight.

- Pre-bend a bracket and insert the top leg of the bracket between the lintel and top panel as shown in *Figure 35D*.
- Install the side panel by sliding it between the lintel and side panel inserting the bottom rear edge between the bracket and side panel.

- 7. Hand bend the front top bracket by gently pushing the tab over the panel edge as shown in *Figure 35E*.
- Install the second side panel by following instructions 3 to 8 bending the brackets to the mirror direction shown on Figures 35A to 35E.

- Do NOT install the logs until the appliance has been completely installed, the gas line connected and tested for leaks, and the initial burner operation has been confirmed.

- Logs get very hot and remain hot for up to one hour after the gas supply is turned OFF. Handle the logs only when cool.






- 1. If necessary, remove the glass door per instructions (Page 49)

4. Place log #1 on tab #1 (Figure 38).



5. Place log #2 using tabs #2 and #3 (Figure 39).

Installing the Rock Kit




#### **Installing the Glass Media**

1. Place glass media in area between rear panel and front ramp as seen in *Figure 43B* below. Do not mound glass media. No more than 3 lbs of glass media should be used in a 35" unit, 4 lbs of glass media in a 40" unit or 5 lbs of glass media in a 45" unit.

NOTE: It is suggested to use a sifter to keep small glass particles off burner.

IMPORTANT NOTE: Do not place media inside square pilot shield (Figure 43C).





#### 18. Installing and Removing the Glass Door

- Do not attempt to substitute the materials used on these doors, or replace cracked or broken glass.


#### **Installing the Glass Door**

- 1. Visually inspect the gasket on the backside of the glass door.
  - NOTE: The gasket surface must be clean, free of irregularities, and seated firmly. Ensure it is properly located. Make sure the bead is not rolled into the channel at the top of the door, but remains flat against the top of the glass.
- 2. Position the door in front of the firebox opening with the bottom of the door held away from the fireplace at a 45° angle (*Figure 44, Page 50*). Hook the top flange of the door frame over the top of the firebox frame.
- **3.** Ensure the glass door is centered with even spacing on each side.
- **4.** Let the bottom of the glass door swing gently in towards the fireplace ensuring that the gasket seats evenly as the door draws shut. Securely fasten the two (2) latches beneath the firebox floor to the door V-flange.
  - IMPORTANT NOTE: The door must close without force. When installed properly, the bottom of the door should not have interference with the fireplace in order to close. If it does, remove the door and inspect the door gasket to ensure it is even and not rolled up at the top. SEE WARNING (Figure 44, Page 50).
- **5.** Reinstall the facade that includes the required barrier.

#### Removing the Glass Door

- 1. If necessary, remove the door and place it in a safe location for later reinstallation.
- 2. Remove the facade. Place the facade in a safe location for later reinstallation.
- **3.** Detach the two (2) door latches beneath the firebox floor.
- **4.** Swing the bottom of the glass door away from the fireplace to a 45° angle (*Figure 44, Page 50*).
- **5.** Carefully grip the door at the top and bottom, and remove it from the fireplace. Place the door in a safe location for later reinstallation.

#### 19. Adjust the Air Shutter to Ensure Proper Flame Appearance

#### Flame Appearance and Sooting

The flame should be blue at the base, and yellow-orange in the body of the flame.

When the fireplace is first lit, the entire flame may be blue and will gradually turn yellow-orange during the first 15 minutes of operation. If the flame remains blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the logs, fireplace inside surfaces, and on exterior surfaces adjacent to the vent termination.

Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellow-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

#### Air Shutter Adjustment Guidelines

- If smoke or soot is present, first check the log set positioning to ensure that the flames are not impinging on any
  of the logs. If the log set is properly positioned and a sooting condition persists, then the air shutter should be
  opened more.
- The more offsets in the vent system, the wider the air shutter will need to be opened.
- A fireplace operated with the air shutter opened too far may have flames that appear blue and transparent. These
  weak, blue, and transparent flames are termed anemic.
- Propane models may exhibit flames that appear stringy. If this condition is present and persists, adjust the air shutter to a more open position, then operate the fireplace for a few more minutes to ensure that the flame normalizes and the flames do not appear sooty. The following chart is provided to help achieve the correct air shutter adjustment for your installation.



- 1. Move the adjustment rod down to increase air flow and up to decrease it. The rod is located in the lower control compartment. Position the air shutter to the factory setting (*Table 29*).
- 2. Light the fireplace. Follow the lighting procedure on the lighting label in the control compartment or **Pages 69-**
- 3. Allow the burner to operate for at least fifteen (15) minutes while observing the flame continuously to ensure that the proper flame appearance is achieved (*Figure 47, Page 52*). If the following conditions are present, adjust accordingly:
  - If flame appears sooty, adjust the air shutter, incrementally, to a more open position until the proper flame appearance is achieved.
  - If flame remains blue, adjust the air shutter, incrementally, to a more closed position until the proper flame appearance is achieved.
- **4**. When satisfied that the burner flame appearance is normal. Turn fireplace to the off position, and reinstall the facade, then proceed to finish the installation.

#### Figure 47 - Burner Flame Appearance





**NOTE:** Classic Frame facade will adjust out 1/2"; the Craftsman, Artisan, and Reflection facades will adjust out 1" to accommodate noncombustible finishing materials.


If the screen mesh barrier gets damaged it shall be replaced prior to operation of the fireplace.

- 1. Remove the current barrier by placing the facade on a flat surface face down and removing the four retainer screws and the modesty panel.
- Slide the barrier out and replace with the appropriate barrier and then secure the new barrier in place using the four screws and modesty panel. Be sure the screen is turned to be flush with the front of the facade as shown in Figure 48B.

If the screen mesh barrier gets damaged it shall be replaced prior to operation of the fireplace.

Instructions will vary slightly depending on facade and unit size.

Retain all fasteners removed during disassembly, they will be reused.

- 1. Lay the facade face down on a soft, level, non-abrasive surface.
- 2. Using a 1/4" nut driver, remove screws around the perimeter of the barrier (see Figure 48E).
  - a. Craftsman and Artisan: 6 screws, Reflection: 5 screws.
- 3. Craftsman and Reflection only: remove visual deflector attached by 3 screws (see Figure 48C).
- **4.** In one place on each side, bend retaining tab up to clear barrier (see **Figure 48D**).
- **5.** Using an 11/32" nut driver, remove lock nuts attaching visual deflector/barrier retainer (see **Figure 48E**). **a.** Craftsman: 7 nuts, Artisan: 4 nuts, 11 nuts.
- 6. Remove and discard damaged barrier assembly from the facade and replace with new barrier assembly.
- 7. Reassemble in reverse order of disassembly. Take care to not over-tighten nuts to prevent damage to the façade. NOTE: Barrier assembly does not come pre-drilled for screws (from step two) and does not need to be. The sharp point on the screws will penetrate the barrier frame with downward pressure while turning the screw into place.

Figure 48C - Facade Assembly




Figure 48D - Bend Retaining TAB UP





Figure 48E - Screws and Lock Nuts



- A. If unit is not installed: locate the access panel of left hand side of unit and remove (2 screws) or remove the barrier assembly and remove the front lower access panel (2 screws).
- B. If unit is installed with optional facade, remove facade and follow Step A. If unit is installed with finishing material that do not allow for front lower access panel to be removed, follow steps below after unit is completely cooled.
  - **1.** Remove barrier assembly and glass door.

  - **4.** Remove pan that is inset into floor being careful not to damage gasket.
  - 5. Blower access is now possible.
  - **6.** Once complete, reassemble unit using the reverse of the steps above.

Figure 48F - Blower Installation









#### **Burn-in Period**

The first few times this fireplace is operated, there will be an odor from the curing of paint and the burning off of the lubricants used in the manufacturing process. Depending on usage, the burn-in period may take a few hours or a few days.

NOTE: Ventilate the site during the burn-in period. The resulting odor and haze may set off a smoke detector. Do not operate the blower during the burn-in period.

A white film may develop on the glass front during the first few fires as part of the burn-in period. The glass should be kept clean during the burn-in period to prevent the film from baking on making it very difficult to remove. **See Cleaning the glass door** (*Page 64*).


#### **Accessing the Control Compartment and Removal of Facade**

Accessing the control compartment area and removal of the facade:





Figure 50B - Battery Holder (in Control Compartment)

- Place your thumbs on lower section of facade pressing against the facade and holding the upper portion in place. See Figure 50A (1).
- 2. Lift up slowly until the bottom pulls away from fireplace. The facade should freely swing out toward you allowing access to the control compartment. See *Figure 50A (2)*.

If you wish to remove the entire facade, swing the bottom of the facade out towards you and firmly grasp the sides of the facade and lift off the top shoulder screws. Place Facade in safe area until it is ready for re-installation. **THE FACADE AND BARRIER SHALL BE INSTALLED PRIOR TO OPERATION OF THE FIREPLACE**.

#### **Electronic Fireplaces**

Detailed lighting instructions are found on *Pages 69-70*. Also, electronic fireplace lighting instructions are found on the pull-out lighting instructions attached to the gas control valve.

If the electronic fireplace is equipped with a remote wall switch or remote control, the fireplace main burner can be turned ON/OFF with the wall switch or remote control.

#### To light the fireplace in a power outage:

- 1. Confirm that batteries are installed in the remote control battery bay and battery holder in the control compartment (see **Page 63**).
- 2. Set the unit-mounted switch, or remote control is set to the ON Position.
- 3. The unit should spark at the pilot and light.
  - **NOTE:** If there is no spark, replace the batteries.
- 4. Operate the fireplace normally.

#### **Installing the Backup Batteries**

With a battery backup, electronic fireplaces can automatically switch to battery power. In the event of a power outage, this allows ON/OFF operation (without blower functionality). Install new batteries before every burn season.

- 1. Remove the facade (see Figure 50A, Page 62), and locate the battery holder (See Figure 50B).
- 2. Install four (4) AA batteries in the battery holder.
- 3. Re-install the facade (see Figure 50A, Page 62).

#### **Continuous Pilot Ignition Switch**

Fireplaces with an electronic gas valve have a continuous pilot ignition (CPI) controlled by the remote. This switch allows the pilot to be switched from intermittent mode to continuous mode:

- Intermittent Mode—The pilot is extinguished when the fireplace is OFF.
- Continuous Mode—The pilot stays ON when the fireplace is OFF.

In periods of extreme cold, condensation may form on the glass door when the fireplace is OFF and the pilot is in intermittent mode. Also, with the pilot in intermittent mode, the fireplace may *cycle startup* (i.e., the pilot and burner ignite, but the burner extinguishes and reignites several times until the flue reaches the temperature for proper drafting).

- To save energy—switch to intermittent mode.
- For a standing pilot that will help prevent glass door condensation and cycle startup—switch to continuous mode.

NOTE: Continuous mode is indicated by a pilot that comes ON and remains lit when the fireplace is OFF.

#### **MAINTENANCE**

Refer to the Maintenance Schedule (*Page 66*) for maintenance tasks, procedures, frequency, and a listing of by whom the tasks should be performed. Always verify proper fireplace operation after servicing.

## **A** WARNING

Turn OFF gas and electrical power to the fireplace and allow it to cool before cleaning or servicing the appliance.

## A CAUTION

Wear gloves and safety glasses for protection while doing required maintenance.

#### Verify proper operation after servicing.

Always turn OFF gas before cleaning. Before relighting, refer to the lighting instructions in this manual. Instructions are also found on a pull-out panel located in the control compartment.

Always keep the appliance area clear and free from combustible materials, gasoline and other flammable liquids.

#### Inspecting the Venting System

**NOTE:** Prior to the first use of the fireplace and each burn season and periodically during the burn season, inspect the horizontal termination for debris such as bird nests, leaves, paper, or branches. Remove any items from the surfaces of the termination prior to use. Also be aware of shrubs and plantings that may encroach on the termination.

The fireplace and venting system should be thoroughly inspected before initial use and at least annually by a qualified service technician. Inspection should include ensuring that exhaust or intake passages are unobstructed and vent components are properly assembled and not damaged.

The homeowner must contact a qualified service technician at once if any abnormal condition is observed.

If the venting system is disassembled for any reason, a qualified service technician should follow vent installation instructions for proper reassembly and proper sealing of the venting system components. However, more frequent periodic inspections and cleanings should be performed by the homeowner.

#### **Inspecting the Burner Flame Appearance**

Periodically inspect the burner and pilot flame. Ensure that the burner flame appearance resembles the flame shown in *Figure 47* on *Page 52* and as described in Flame Appearance and Sooting (*Page 51*). Any necessary burner flame adjustments must be performed by qualified personnel only (*Pages 51-52*). Refer to *Page 41* for more information about the pilot flame appearance. Contact a qualified service technician at once if any abnormal condition is observed.

#### Cleaning the Glass Door

## **A** CAUTION

#### Do not use abrasive cleaners on glass. Never clean the glass when it is hot.

Clean the glass during the **Burn-in Period**, and then only when necessary and when the fireplace is cool. Wipe the surface with a clean, dampened, soft cloth. Follow with a dry, soft towel as desired. Take care not to scratch the glass surface. Periodically, remove any build-up caused by the following:

- During start-up, it is normal for condensation to form on the inside of the glass (this condensation and fog will
  usually disappear in a few minutes). The moisture can cause lint, dust, and other airborne particles to cling to
  the glass surface.
- Initial curing of the high temperature paint and burning off of lubricants used in the manufacturing process may
  result in a film on the glass.
- A white coating may form on the glass as a result of impurities and minerals in the fuel.

Clean the glass two or three times each heating season, depending on the circumstances present. The following cleaning solutions are approved for use:

- Non-ammonia based glass cleaner
- 50/50 mixture of white vinegar / water
- Gas fireplace/stove glass cleaner

#### **Inspecting the Glass Gasket**

Visually inspect the gasket on the backside of the glass door. The gasket surface must be clean, free of irregularities, and seated firmly.

#### **Cleaning the Control Compartment**

Keep the control compartment clean by vacuuming or brushing it out at least twice a year. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, etc. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean.

#### **Touching Up Paint in Small Areas**

Only use a factory-supplied paint kit for any touch-ups. Paint is available at your local IHP dealer. Never attempt to paint a hot fireplace. Do not attempt to repaint the fireplace until the finish is completely cured. See Burn-in Period (*Page 62*). If the surface becomes stained or marred, it may be lightly sanded and touched up.

#### Logs

#### Removing and cleaning the logs

## **A** CAUTION

#### The fiber logs become very fragile after curing.

Carefully remove the logs. Clean carbon from the logs using a vacuum cleaner, or a soft bristle brush (e.g., paint brush).

#### Reinstalling the logs

Carefully follow the placement instructions (*Pages 44 - 47*). All logs should fit onto the corresponding pins and/or log stoppers. This will ensure proper flame and safe combustion.

NOTE: Improper positioning of logs can create carbon build-up and will alter the performance of the fireplace.

#### Replacing the logs

If the logs become damaged and need replacement, use only the proper replacement logs from manufacturer (*Page 67*).

#### Cleaning the Burner

Carefully remove the logs/media. Vacuum out any foreign matter on the burner (e.g., lint, carbon, etc.). Ensure the burner ports are free of debris.

NOTE: Improper positioning of logs/media can create carbon build-up and will alter the performance of the fireplace.

#### Inspecting the Wiring

Refer to the wiring diagram (*Figure 28, Page 39*).

## **A** CAUTION

Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.

## ATTENTION

#### THE WARRANTY

Innovative Hearth Products ("IHP") Limited Lifetime Warranty warrants your Astria® brand gas fireplace ("Product") to be free from defects in materials and workmanship at the time of manufacture. The product body, firebox and barrier carry the Limited Lifetime Warranty. Ceramic glass carries the Limited Lifetime Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the Limited Lifetime Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this Limited Lifetime Warranty as described herein.

#### **COVERAGE COMMENCEMENT DATE**

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

#### **EXCLUSIONS AND LIMITATIONS**

This Limited Lifetime Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The product body, firebox and barrier carry the Limited Lifetime Warranty from the date of installation. Vent components, trim components and paint are excluded from this Limited Lifetime Warranty. The following do not carry the Limited Lifetime Warranty but are warranted as follows:

Burner - Repair or replacement for five years from the date of installation

Gas components & electrical components - Repair or replacement for one year from the date of installation

Gaskets - Repair or replacement for one year from the date of installation

Gold & nickel plating - Replacement for two years from date of installation. Excludes tarnishing

**Labor coverage** – Prevailing IHP labor rates apply for the warranty period of the component

Light bulbs & batteries - Replacement for 90 days from the date of installation

Logs - Replacement for five years from the date of installation against thermal breakage only

Optional blowers & remote controls - Repair or replacement for one year from the date of installation

Optional glass doors & optional glass accessories - Repair or replacement for 90 days from the date of installation

**Optional surrounds** – Stone/Natural Materials: Replacement for one year against cracking or breakage due to thermal stress. Other Materials: Replacement for one year. Excludes surface and hairline cracks and scratches or slight color changes that do not affect the operation or safety of the unit

Tempered Glass -Replacement for one year from the date of installation

#### Parts not otherwise listed carry a 90 day warranty from the date of installation.

Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

Additionally IHP assumes no responsibility for drafting conditions caused by venting configurations, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions that affect the operation of the unit.

This Limited Lifetime Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction, which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

#### LIMITATION ON LIABILITY

It is expressly agreed and understood that IHP's sole obligation and the purchaser's exclusive remedy under this warranty, under any other warranty, expressed or implied, or in contract, tort or otherwise, shall be limited to replacement, repair, or refund, as specified herein.

IHP makes no expressed warranties except as stated in this Limited Lifetime Warranty. The duration of any implied warranty is limited to the duration of this expressed warranty.

No one is authorized to change this Limited Lifetime Warranty or to create for IHP any other obligation or liability in connection with the Product. Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. The provisions of this Limited Lifetime Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

#### INVESTIGATION OF CLAIMS AGAINST WARRANTY

IHP reserves the right to investigate any and all claims against this Limited Lifetime Warranty and to decide, in its sole discretion, upon the method of settlement.

To receive the benefits and advantages described in this Limited Lifetime Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.

Contact IHP at the address provided herein to obtain a listing of approved dealers/distributors. IHP shall in no event be responsible for any warranty work done by a contractor that is not approved without first obtaining IHP's prior written consent.

#### **HOW TO REGISTER A CLAIM AGAINST WARRANTY**

In order for any claim under this warranty to be valid, you must contact the IHP dealer/distributor from which you purchased the product. If you cannot locate the dealer/distributor, then you must notify IHP in writing. IHP must be notified of the claimed defect in writing within 90 days of the date of failure.
